Invitation to bid for a Licence ('the Licence') to use the College's Post Incident Management (PIM) training to deliver training to Learners from UK police forces who are licensed under a College of Policing Firearms Training Licence and other approved partner agencies/organisations (Licence bid reference: COP004)

The College of Policing ('the College') is the professional body for the police in England and Wales. The College works to raise the professional status of police officers and police staff. It plays a vital role in setting standards and in the training and development of police officers and staff, ensuring that they have the skills they need in order to fight crime and protect the public.

This announcement and invitation to participate in a competition is for a 5-year licence to use the College's Post Incident Management (PIM) training courses to deliver training to Learners from UK police forces who are licensed under a College of Policing Firearms Training Licence and other approved partner agencies/organisations. It includes the College's:

- 5-day PIM Training courses
- 3-day PIM re-accreditations

The term post-incident describes the period following a death or serious injury (DSI), where the criteria for the implementation of a post-incident investigation has been met and an investigation into police action or inaction is to be conducted. A post incident manager's role is to facilitate, manage and ensure the integrity of the post-incident procedure.

# Submitting a bid

Bidders must complete the attached bid application form and submit their bid by email to copyright&licensing@college.police.uk by the date specified in the table above. Bidders must not submit any additional information with their application other than that specifically requested.

# **Bid evaluation**

The College is advertising and competing this opportunity in order to facilitate an increase in supply to meet the current demand and to obtain optimum value for money for policing. This does not mean accepting the lowest cost to Learners and an assessment will be made of the bidders experience, capacity and quality standards as well as their likelihood of making use of the Licence.

Bids will be evaluated in accordance with the marking scheme set out in the attached bid application (Part B).

Upon completion of the evaluation, the marks obtained by the bidder for each question will be converted into a "Question Score", this is a percentage of the Total Score Available as indicated in the marking scheme for the specific question. The Question Scores will be added together to determine an overall "Total Score" for each bidder. The Total Score Available for each question set out in the bid application is as follows:

# **Grant of Licence**

The bidder that achieves the highest score will be awarded the Licence. If two or more bidders obtain the highest total score, the bidder with the highest score for the 'Methodology' element will be deemed the winner and will be granted a Licence. If the College receives only one bid in relation to this opportunity, the bidder will be awarded the Licence provided they meet the minimum total score of 50.
