Forest East Park

Task	Frequency
The whole of the park to be mowed, including strimming around all obstacles as necessary. The area to be mowed must be litter-picked before mowing/strimming. The slim area between the perimeter paths and hedge must also be mown/strimmed. The grass must be kept short for sports played on the playing fields.	16 time a year, to be mostly completed through the summer months.
OUTSIDE OF BIRD NESTING SEASON the side and top of all hedges around the playing fields must be flailed, as must all other boundary hedges. This is also to include the hedges on the Somerfield Way car park.	Annually.

Wooded areas to be roughly cut once a year only, after the bulbs have flowered.	Annually.
To raise the crown height of trees. lvy/suckers to be removed also.	As necessary to ensure tree crown heights are kept at a safe height and to prevent trees having ivy etc growing on them.
Paths to be sliced if necessary.	Annually.
To use a pet and child safe weed killer to treat all weeds on the paths.	As necessary to ensure weeds are kept at bay.
Whole orchard area to be cut	Annually, after wild flowers have flowered
Whole orchard area – grass, wavy path to be mown on both sides of orchard area, through the trees Somerfield Way car park – to be kept free of weeds	16 time a year, to be mostly completed through the summer months.As required
