# Agreement with the Department for Business & Trade

# Walpole New York Luxury Trade Mission

### 1) BACKGROUND

The British luxury industry contributes £81 billion to the British economy, accounts for 3.7 UK GDP and is responsible for over 450,000 jobs across the UK. The sector is heavily exportorientated with 70%, or £56bn in value terms, destined for overseas markets. This contribution is built on established UK-based manufacturing with 75% of Walpole members manufacturing in Britain and by conservative estimates the high-end sector is forecasted to reach £125 in next five years. The wider contribution of the high-end sector through travel and tourism, employment, skills and manufacturing and soft power diplomacy is vast; British high-end brands are some of the greatest ambassadors for this country and enhance its reputation on a global scale through soft power diplomacy.

A Walpole report with McKinsey & Co identified key growth drivers for the high-end sector and highlights two important opportunities: 1) the majority of British high-end brands are SMEs and as such have significant white space for growth and 2) international development and exports is one of the key drivers of sector growth an essential for any high-end business to gain scale and reach its full potential.

The following markets are highlighted as priorities for the UK high-end sector over the next five years: US; Europe; Japan, South Korean, China , the UAE and Saudi with the US being rated by 75% of UK luxury brands as the priority growth market.

Following the success of Walpole's British luxury trade trips to New York over the last five years Walpole will be returning to the US in March 2025 to further build the opportunities in this key export market.

## Objectives for the Programme

In March 2025 Walpole will lead a five day delegation to New York from the 17<sup>th</sup> to 21<sup>st</sup> March. Building on the success of previous trips, the newly formatted programme will see Walpole host a series of events and meetings to promote both British luxury in the US and high-value American visitors to the UK.

- The Walpole US Delegation is designed to promote Anglo-American trade, develop business, media and diplomatic relationships and support Walpole members in promoting and developing their brands in the US.
- As well as supporting trade with one of our key export markets, the trip also promotes US inbound tourism to the UK encouraging high-value American visitors.
- Through the trip's promotional activities, Walpole flies the flag for the UK and British luxury in the largest luxury goods market.

### 2) DESCRIPTION OF GOODS AND SERVICES

Through the mission Walpole, with the support of a range of partners, will host a series of seven events and activities which support the objectives outlined above and include:

The official programme takes place from the Monday 17<sup>th</sup> – Friday 21<sup>st</sup> March 2025 and features a series of events, meetings and briefings including a US luxury market insight session, a **reception at the British Consul General's Residence, media events and an event to showcase** British luxury hospitality. Throughout the trip, members will also have the opportunity to book and schedule individual meetings around the main programme to arrange targeted commercial meetings.
