Extension for Helicopter leasing agreement in support of the continuing medical evacuation requirements of Operation GRITROCK, Sierra Leone.

Summary

Air Partner ("AP") has an agreement with the UK Department for International Development ("DFID") under which AP provides certain services which include humanitarian missions for crisis hit parts of the world. This Agreement between AP and GHS as hereinafter defined shall form part of AP's services to DFID

DFID wish Air Partner (AP), acting as an agent for DFID, to procure helicopter charter services from Global Helicopter Services GmbH (GHS) and medical services from the West African Rescue Association, a subsidiary of International SOS (WARA). Working together GHS and WARA are providing an airborne non-Ebola medical evacuation capability in Sierra Leone after the withdrawal of RFA Argus from the area. This service agreement came into force on 6^{th} of March 2015 and the service has been commenced with the contracted aircraft arriving inside the country of operation on 25^{th} of March.

The purpose of this contract extension is to cover an extension period to the original contract of three (3) month after 25th of June initial period of service and shall conclude another period of three (3) months starting on 26th of June. The initially indicated option to further extend after 25th of September remains valid. Notification of another extension of the contract by further three (3) month shall be submitted to GHS upon 30 days notice in writing signed by both AP and GHS.

The medical personnel, equipment and services are provided under separate contract between AP to WARA and this agreement solely speaks for the relation between GHS and AP.
