Section 4 – Specification and about this procurement

1. Introduction

The Biotechnology and Biological Sciences Research Council (BBSRC), EPSRC and Innovate UK supported a significant programme of investment in industrial biotechnology and bioenergy through the Industrial Biotechnology (IB) Catalyst as well as the Networks in Industrial Biotechnology and Bioenergy (NIBBs).

UKRI-BBSRC, on behalf of all other funding partners involved, would like to invite tenders for a co-ordinator/s who will play a key role in supporting the monitoring of the IB Catalyst Translation awards and the coordination of activities relating to the BBSRC NIBB into wider UK IB activities.

The IB Catalyst was established in 2014 to support the development of research outcomes into new industrial biotechnology processes and products. The IB Catalyst and BBSRC NIBB Coordinator will be actively involved in monitoring project progress through attending project meetings and is also responsible for reporting issues and significant outcomes to BBSRC. As part of the monitoring of the IB Catalyst Translation awards the coordinator(s) will enable better industrial engagement and sustainability beyond the lifetime of the grant towards more robust commercial impact from the research.

The second phase of the BBSRC NIBB will be tasked with building on the momentum and achievements so far whilst considering how to move the area of industrial biotechnology and bioenergy (IBBE) towards realisation of biotechnological solutions for UK-based manufacturing, by utilising the excellent UK science base.

The majority of research projects funded by the BBSRC NIBB Phase I are situated around Technology Readiness Level (TRL) 1-2. It is anticipated the next phase of the Networks should be looking to move activities more towards TRL 3-4 where possible.

The BBSRC NIBB Phase II activities should coordinate with other relevant research programmes such as the Supergen Bioenergy Hub, SPF Greenhouse Gas Demonstrator project, ISCF Decarbonising Industrial Clusters, ISCF Smart Sustainable Plastic Packaging and the Future Biomanufacturing Research Hub. The role of the Coordinator will be to support the BBSRC NIBB in linking in to these other research programmes to maximise the application of the expertise within the Networks to address these common challenges and that other programmes can make best use of the BBSRC NIBB activities and expertise.

2. Aims

We invite tenders for a co-ordinator(s) to undertake the following:

- Ensure the impact of the UKRI-BBSRC investments through the IB Catalyst and the BBSRC NIBB phase II are maximised through supporting the translation of research towards commercialisation and the relevant UK activities in IB are coordinated linking expertise.
- Gather evidence of impact and support the dissemination of outputs of these investments.

 Provide UKRI-BBSRC independent strategic advice in the context of UK biomanufacturing.

3. Objectives

Monitor the progress of UKRI - BBSRC investments through the IB Catalyst Translation and BBSRC NIBB II awards.

Disseminate the outputs of these investments.

Link together expertise by coordinating UKRI funded activities relevant to UK biomanufacturing and clean growth.

Support the progression of research up TRLs by encouraging and enabling industrial engagement and supporting the development of collaborative research projects.

Gather evidence to better understand how bioscience is being used in UK manufacturing and how UKRI-BBSRC funded research is contributing to innovation in the IBBE area and provide an understanding with respect to an international context.

OUTPUTS

UKRI-BBSRC receives up to date formal report every 6 months on the progress of UKRI-BBSRC investments and impact on UK biomanufacturing. The format and delivery method of reports will be agreed with the supplier in the initial implementation meeting

BBSRC NIBB II funded projects progress the research further along the TRLs.

Improved national coordination of activities and investments in this area

Better engagement between the research community with policy makers and regulators

Case studies to demonstrate the impact of funded work through the IB Catalyst and NIBB mechanisms

A progress report to provide input to future strategy and the design and implementation of future funding programmes.

Providing strategic advice to UKRI-BBSRC to support next steps for supporting research and innovation towards clean growth.

An event jointly delivered with UKRI-BBSRC to showcase the outputs of the IB Catalyst translation awards and other relevant investments.

4. Background to the Requirement

IB Catalyst

£76M was awarded through the Industrial Biotechnology Catalyst by funders (BBSRC, EPSRC, IUK) to 82 projects over four funding rounds between 2014 and 2016. Awards were made across 5 streams from Early Stage Translation to Late Stage Experimental and have been monitored either through Innovate UK monitoring processes or in the case of the 15 Translational awards through the IB Catalyst Coordinator. As a condition of awarded grants the project leaders are required to complete an annual report outlining progress against work packages and any significant outcomes. The Translation awards will all be completed by early 2022 and therefore a key objective of the IB Catalyst coordinator will be to ensure the successful dissemination of the outputs from the IB Catalyst projects.

BBSRC NIBB

The BBSRC NIBB foster collaborations between academia, industry, policy makers and National Government Organisations (NGOs) in order to find new approaches to tackle research challenges, translate research and deliver key benefits in IBBE.

In 2014, BBSRC invested £18M (including £1M from EPSRC) in the first phase of Networks in Industrial Biotechnology and Bioenergy (BBSRC NIBB). The 13 Networks worked across the boundaries of biology, chemistry and engineering with participation from other disciplines strongly encouraged. There are currently over 6000 members of which 996 come from industry. Overall there were 625 proof of concept and business interaction vouchers awarded involving 269 industrial partners.

In 2018, a further £11M (including £1.1M from EPSRC) was approved for a second phase of networking activity in IBBE which was committed to fund six Phase II networks. The Phase II Networks will be tasked with building on the success of Phase I activities whilst also moving their areas of research further towards translation and higher TRLs. Each phase II Network has a particular focus area, mainly within the UK, but with interest to build international links.

The BBSRC NIBB in phase II aim to achieve the following outcomes based on successful networking during 2019-2024:

- Key science areas generate a range of novel and exciting science and technology relevant to IBBE, maintaining momentum from Phase I.
- The majority of research projects funded by BBSRC NIBB Phase 1 were around Technology Readiness Level (TRL) 1-2. It is anticipated the next phase of the Networks should move some of these projects towards TRL 3-4 where possible.
- Further high quality collaboration with demonstrable follow-on funding across multiple sponsors
- Greater and fuller industrial engagement, especially with companies engaged with biotechnology for the first time, leading to biotechnological solutions to key manufacturing problems
- Growth in international profile of the UK and UK as international partner of choice for

collaboration.

- Companies make inward investment to the UK for the purposes of R&D, followed by manufacturing, leading to new jobs, further employment and UK economic growth
- UK becomes international locus for revolutionising chemicals industry, establishing the circular bioeconomy (for C emission reduction) and for efficient biopharmaceuticals manufacture (biologics, vaccines)
- Impact of the BBSRC NIBB and their leaders can be clearly defined, demonstrated and linked to the Networks

5. Scope

PERIOD OF THE AGREEMENT

The period of the agreement will commence on 22 November 2019 until 21st November 2022. The contract will be awarded for 3 years with the option to extend for a further 2 years on an annual basis from the commencement of the contract. The absolute final end date if all extension are utilised shall be 21st November 2024.

6. Requirement

Monitoring of IB Catalyst Translation awards (estimated 104 days)

- i. To monitor progress of funded projects against agreed processes and to include regularly visiting funded research groups as part of the annual report assessment activity.
- ii. To implement the IB Catalyst reporting framework which supports the tracking of project performance against competition objectives.
- iii. To report to the funders on the outcomes of completed projects and their planned next steps.
- iv. To identify and report on wider project outcomes including industry-academic interactions, knowledge exchange activities and in-kind contributions, the development of any IP, commercialisation of process/ technologies developed and additional funding secured by projects along the translation pipeline.

Dissemination of the outputs from the IB Catalyst projects (estimated 13 days)

- v. To ensure that the outputs and outcomes of Catalyst projects are identified, captured and communicated with BBSRC and partners.
- vi. Seek suitable project material for press releases and case studies that can be used to demonstrate the achievements of the IB Catalyst.
- vii. Jointly deliver an event with UKRI-BBSRC to showcase the outputs of the IB Catalyst Translation awards and other relevant investments.

Coordination of the BBSRC phase II Networks are as follows:

- viii. Attend BBSRC Network Management Board meetings (2 meetings annually per NIBB = 60 days)
- ix. Attend BBSRC NIBB led community meetings (2 meetings annually per NIBB = 60 days)
- x. Attend the BBSRC-led Directors' meetings (5 days).
- xi. Assisting in the development of network-funded projects, moving up the Technology Readiness Levels to TRLs 3&4. (as part of viii and ix)
- xii. Develop a thorough understanding of the funding opportunities (including Newton, GCRF, ISCF, SPF) available for taking forward projects in order to advise applicants in developing research proposals, encouraging collaboration and interdisciplinary consortia where appropriate, ensuring that the applications have the appropriate team and skills to deliver the projects objectives (20 days)
- xiii. Liaison between NIBB II, Supergen Bioenergy Hub and GGR demonstrators and DIC / Supporting interactions between the academic and business community and communication within the communities. Help facilitate links between the producers of biomass and the processors and potential applications through attendance at Network MB meetings (10 days)
- xiv. Additional time outside of Network management board meetings to help networks develop sustainability models to enable them to be self-sustaining beyond 2024 (5 days)

Reporting to BBSRC-UKRI (10 days):

- xv. Provide updates on progress and outputs of the IB Catalyst Translation awards and BBSRC NIBB II.
- xvi. Provide independent link between BBSRC and the NIBB Directors/management board providing an overall national picture of impact of UKRI funding.
- xvii. Provide independent advice to BBSRC on the implementation of its activities in industrial biotechnology and bioenergy.

Technical and Specialist Knowledge and Expertise

- The coordinator(s) must have an overall understanding of UKRI in particular how the
 organisation operates to ensure ability to professionally represent UKRI and funding
 schemes to support the development of the government Clean Growth strategy.
- The coordinator(s) should possess sound scientific knowledge across a range of disciplines, such as biosciences, chemistry, engineering, as well as an understanding of the economics and social sciences that are relevant to the industrial biotechnology sector.
- The coordinator(s) must have detailed high level technical knowledge relevant to the research challenges of industrial biotechnology, an understanding as to the needs of the UK industrial biotechnology and bioenergy-relevant industry sectors coupled with an in-depth knowledge of the relevant science research base within the UK.

Project and Strategic Management

- The coordinator(s) will be able to apply their skills and expertise to project management, specifically to managing industry/academic research collaborations.
- The coordinator(s) must also be able to think strategically and contribute to the future development of the bioscience led research community delivering clean growth for the UK.
- The coordinator(s) must have the ability to nurture an entrepreneurial environment where academics recognise and are assisted in taking forward opportunities for impact in industry from their science.
- The coordinator(s) must be able to manage confidential issues professionally, bearing in mind their representation of UKRI.

Personal Skills

 The coordinator(s) will have exceptional communication, networking and interpersonal skills, and be an effective facilitator in both commercial and academic arenas.

- In order to advise academics and industrialists on the development of their high
 quality innovative and industrially relevant research proposals the coordinator(s) must
 have capacity to gain the respect of both academics and industrialists and the
 capability to engage effectively across both communities. The coordinator(s) must be
 able to engender the collaborative ethos across the bioscience led research
 community delivering UK clean growth.
- The coordinator(s) should have the ability at reporting using a variety of different media in a professional and timely manner.

The coordinator(s) should be highly motivated and self-starting with excellent organisational skills and an ability to work creatively and flexibly, alone and as part of a team. They will be excited by the challenges of working at the interface of phenomenal growth in scientific knowledge, changing industrial need and evolving government policy and funding.

7. Timetable

Thirteen IB Catalyst will be due to finish between December 2019 and February 2022 as follows:

2022 - February

The 6 BBSRC NIBB funded through phase II will have 2 management board meetings per year per network and at least 2 community meetings per network per year. The dates will be confirmed by the networks as they progress.

The dissemination event to showcase the outputs of the IB Catalyst investments will be held towards the close of all projects (end of 2021, early 2022) but this will be done in collaboration with UKRI-BBSRC.

6 monthly meetings will be held with UKRI-BBSRC at a mutually convenient date.

Annual meetings will be held between UKRI-BBSRC and the NIBB II Directors which the coordinator(s) will be expected to attend.

- 5.4.4 Questions marked 'for information only' do not contribute to the scoring model.

Award Evaluation of criteria

Non-Price elements

Each question will be judged on a score from 0 to 100, which shall be subjected to a multiplier to reflect the percentage of the evaluation criteria allocated to that question.

Where an evaluation criterion is worth 20% then the 0-100 score achieved will be multiplied by 20%.

Example if a Bidder scores 60 from the available 100 points this will equate to 12% by using the following calculation:

Where the scoring criterion is worth 50% then the 0-100 score achieved will be multiplied by 50

In the example if a supplier scores 80 from the available 100 points this will equate to 40% by using the following calculation: Score/Total Points multiplied by 50 ($80/100 \times 50 = 40$)

The lowest score possible is 0 even if the price submitted is more than 100% greater than the lowest price.

 - 7.11.2.2 accepts any responsibility for the information contained in the RFP or for their fairness, accuracy or completeness of that information nor shall any of them be liable for any loss or damage (other than in respect of fraudulent misrepresentation) arising as a result of reliance on such information or any subsequent communication.

- 7.12.1.4 enters into any agreement or arrangement with any other party as to the amount of any Response submitted; or
- 7.12.1.5 offers or agrees to pay or give or does pay or give any sum or sums of money, inducement or valuable consideration directly or indirectly to

any party for doing or having done or causing or having caused to be done in relation to any other Response or proposed Response, any act or omission.

shall (without prejudice to any other civil remedies available to the Contracting Authority and without prejudice to any criminal liability which such conduct by a Bidder may attract) be disqualified.

7.13. No inducement or incentive

7.13.1 The RFP is issued on the basis that nothing contained in it shall constitute an inducement or incentive nor shall have in any other way persuaded a Bidder to submit a Response or enter into the Contract or any other contractual agreement.

7.14. Acceptance of the Contract

- 7.14.1 The Bidder in submitting the Response undertakes that in the event of the Response being accepted by the Contracting Authority and the Contracting Authority confirming in writing such acceptance to the Bidder, the Bidder will within 5 days of being called upon to do so by the Contracting Authority execute the Contract in the form set out in the Contract Terms or in such amended form as may subsequently be agreed.
- 7.14.2 The Contracting Authority shall be under no obligation to accept the lowest priced or any Response.

7.15. Queries relating to the Response

- 7.15.1 All requests for clarification about the requirements or the process of this procurement shall be made in through the e-sourcing tool unless where the e-sourcing tool is unavailable due to Emptoris or Crown Commercial Service system maintenance or failure, in this instance all clarifications shall be by email to the contact defined in Section 3.
- 7.15.2 The Contracting Authority will endeavour to answer all questions as quickly as possible but cannot guarantee a minimum response time.
- 7.15.3 In the event of a Bidder requiring assistance uploading a clarification to the esourcing portal they should use the contact details defined in <u>Section 3</u>.
- 7.15.4 No further requests for clarifications will be accepted after 7 days prior to the date for submission of Responses.
- 7.15.5 In order to ensure equality of treatment of Bidders, the Contracting Authority intends to publish the questions and clarifications raised by Bidders together with the Contracting Authority's responses (but not the source of the questions) to all participants on a regular basis.
- 7.15.6 Bidders should indicate if a query is of a commercially sensitive nature where disclosure of such query and the answer would or would be likely to prejudice its commercial interests. However, if the Contracting Authority at its sole discretion does not either; consider the query to be of a commercially confidential nature or one which all Bidders would potentially benefit from seeing both the query and the Contracting Authority's response, the Contracting Authority will:

- 7.15.6.1 invite the Bidder submitting the query to either declassify the query and allow the query along with the Contracting Authority's response to be circulated to all Bidders; or
- 7.15.6.2 request the Bidder, if it still considers the query to be of a commercially confidential nature, to withdraw the query prior to the end of the closing date and time for Bidder clarifications.
- 7.15.7 The Contracting Authority reserves the right not to respond to a request for clarification or to circulate such a request where it considers that the answer to that request would or would be likely to prejudice its commercial interests.

7.16. Amendments to Response Documents

7.16.1 At any time prior to the deadline for the receipt of Responses, the Contracting Authority may modify the RFP by amendment. Any such amendment will be numbered and dated and issued by the Contracting Authority to all prospective Bidders. In order to give prospective Bidders reasonable time in which to take the amendment into account in preparing their Responses, the Contracting Authority may, at its discretion, extend the time and/or date for receipt of Responses.

7.17. Modification and withdrawal

- 7.17.1 Bidders may modify their Response where allowable within the e-sourcing tool. No Response may be modified after the deadline for submission of Responses.
- 7.17.2 Bidders may withdraw their Response at any time prior the deadline for submission of Responses [or any other time prior to accepting the offer of a Contract]. The notice to withdraw the Response must be in writing and sent to the Contracting Authority by recorded delivery or equivalent service and delivered to the Head of Policy UK SBS at UK Shared Business Services Ltd, Procurement, Polaris House, North Star Avenue, Swindon, Wiltshire, SN2 1ET

7.18. Right to disqualify or reject

- 7.18.1 The Contracting Authority reserves the right to reject or disqualify a Bidder where
 - 7.18.1.1 the Bidder fails to comply fully with the requirements of this Request for Proposal or presents the response in a format contrary to the requirements of this document; and/or
 - 7.18.1.2 the Bidder is guilty of serious misrepresentation in relation to its Response; expression of interest; or the Response process; and/or
 - 7.18.1.3 there is a change in identity, control, financial standing or other factor impacting on the selection and/or evaluation process affecting the Bidder.

7.19. Right to cancel, clarify or vary the process

- 7.19.1 The Contracting Authority reserves the right to:
 - 7.19.1.1 cancel the evaluation process at any stage; and/or
 - 7.19.1.2 require the Bidder to clarify its Response in writing and/or provide additional information. (Failure to respond adequately may result in the Bidder not being selected),

7.20. Notification of award

- 7.20.1 The Contracting Authority will notify the successful Bidder of the Contract award in writing and will publish an Award Notice in the Official Journal of the European Union in accordance with the Regulations within 30 days of the award of the contract.
- 7.20.2 As required by the Regulations all successful and unsuccessful Bidders will be provided with an email advising the outcome of the submission of their RFP response.
