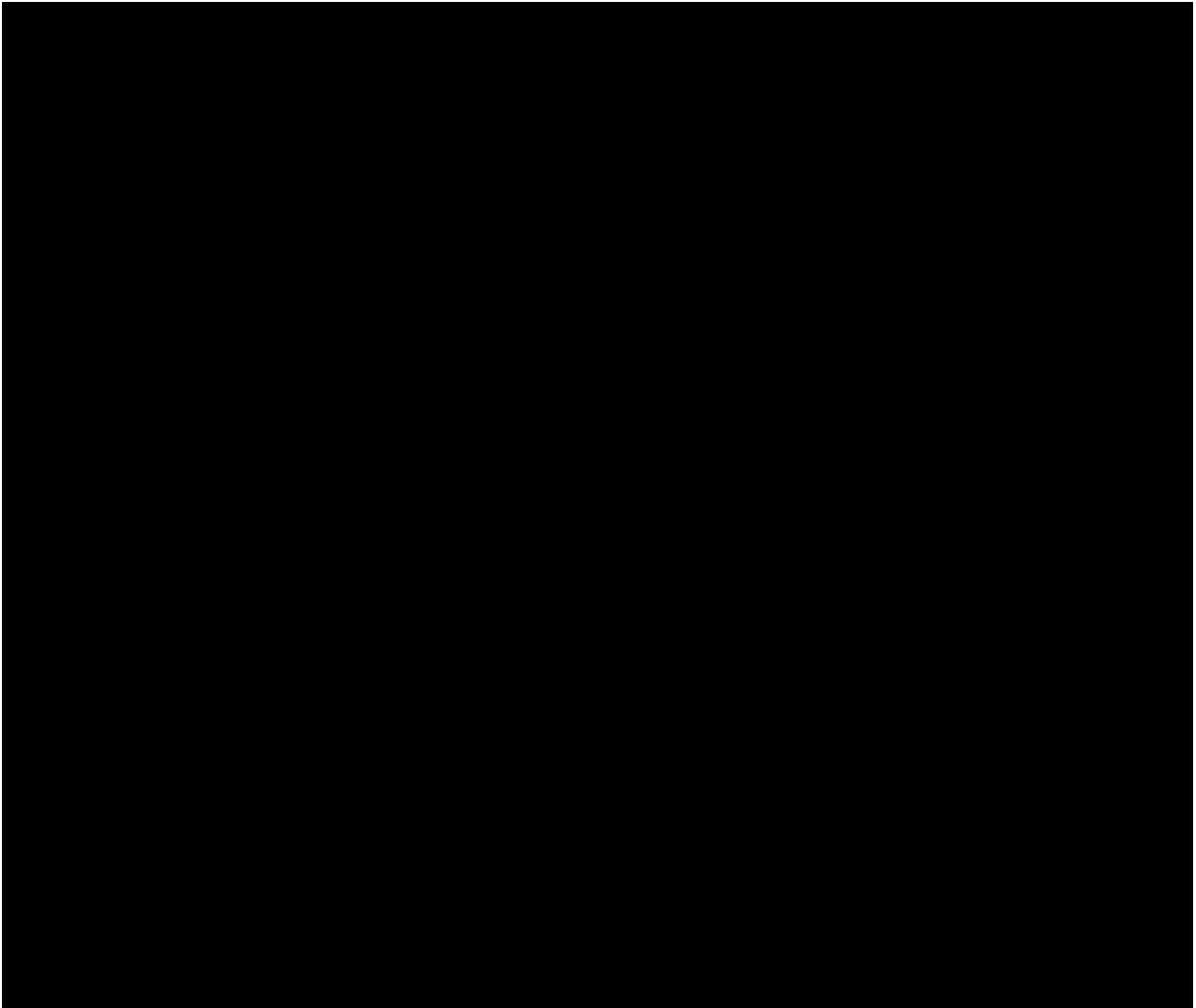

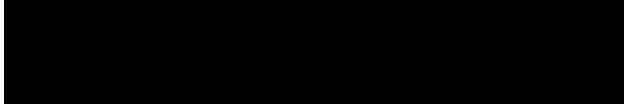

1. The insurance you need to have

1.1 The Supplier shall take out and maintain, or procure the taking out and maintenance of the insurances as set out in the Annex to this Schedule, any additional insurances required under an Order Contract (specified in the applicable Order Form) ("**Additional Insurances**") and any other insurances as may be required by applicable Law (together the "**Insurances**"). The Supplier shall ensure that each of the Insurances is effective no later than:

- 1.1.1 the DPS Start Date in respect of those Insurances set out in the Annex to this Schedule and those required by applicable Law; and
- 1.1.2 the Order Contract Effective Date in respect of the Additional Insurances.

1.2 The Insurances shall be:

- 1.2.1 maintained in accordance with Good Industry Practice;
- 1.2.2 (so far as is reasonably practicable) on terms no less favourable than those generally available to a prudent contractor in respect of risks insured in the international insurance market from time to time;
- 1.2.3 taken out and maintained with insurers of good financial standing and good repute in the international insurance market; and
- 1.2.4 maintained for at least six (6) years after the End Date.

- 7.2 Except where the Relevant Authority is the claimant party, the Supplier shall give the Relevant Authority notice within twenty (20) Working Days after any insurance claim in excess of 10% of the sum required to be insured pursuant to Paragraph 5.1 relating to or arising out of the provision of the Deliverables or this Contract on any of the Insurances or which, but for the application of the applicable policy excess, would be made on any of the Insurances and (if required by the Relevant Authority) full details of the incident giving rise to the claim.
- 7.3 Where any Insurance requires payment of a premium, the Supplier shall be liable for and shall promptly pay such premium.
- 7.4 Where any Insurance is subject to an excess or deductible below which the indemnity from insurers is excluded, the Supplier shall be liable for such excess or deductible. The Supplier shall not be entitled to recover from the Relevant Authority any sum paid by way of excess or deductible under the Insurances whether under the terms of this Contract or otherwise.

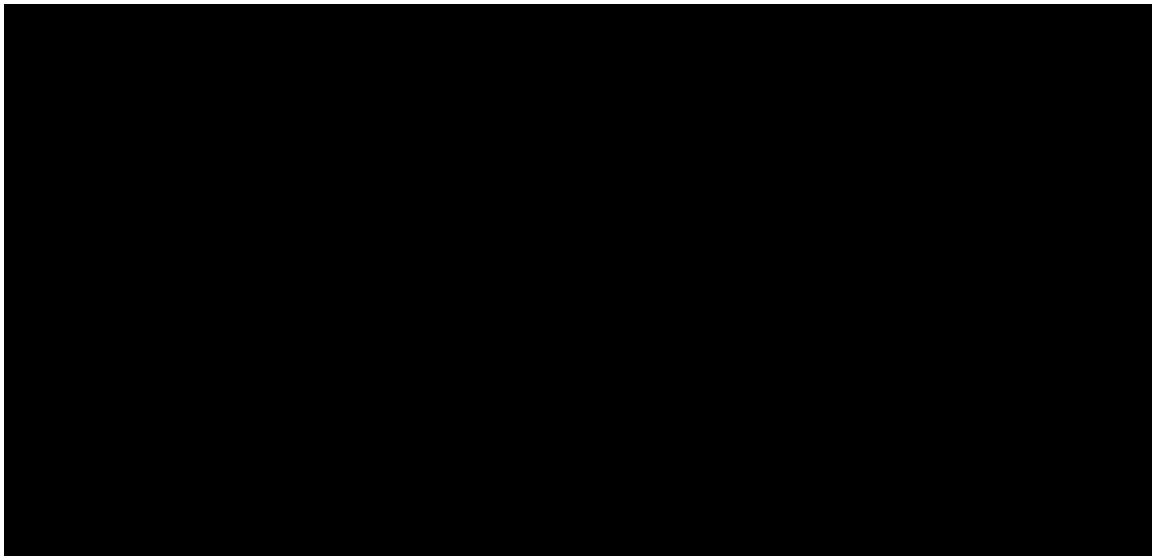

 - (c) the obligation not to embarrass CCS or the Buyer or otherwise bring CCS or the Buyer into disrepute;
 - (d) the keeping of records in respect of the goods and/or services being provided under the Key Sub-Contract, including the maintenance of Open Book Data; and
 - (e) the conduct of audits set out in Clause 6 (Record keeping and reporting);
 - 1.6.6 provisions enabling the Supplier to terminate the Key Sub-Contract on notice on terms no more onerous on the Supplier than those imposed on CCS and the Buyer under Clauses 10.4 (When CCS or the Buyer can end this contract) and 10.5 (What happens if the contract ends) of this Contract; and
 - 1.6.7 a provision restricting the ability of the Key Subcontractor to sub-contract all or any part of the provision of the Deliverables provided to the Supplier under the Key Sub-Contract without first seeking the written consent of CCS and the Buyer.

Joint Schedule 11 (Processing Data)**Definitions**

1. In this Schedule, the following words shall have the following meanings and they shall supplement Joint Schedule 1 (Definitions):

“Processor Personnel” all directors, officers, employees, agents, consultants and suppliers of the Processor and/or of any Subprocessor engaged in the performance of its obligations under a Contract;

Status of the Controller

2. The Parties acknowledge that for the purposes of the Data Protection Legislation, the nature of the activity carried out by each of them in relation to their respective obligations under a Contract dictates the status of each party under the DPA 2018. A Party may act as:

- (a) “Controller” in respect of the other Party who is “Processor”;
- (b) “Processor” in respect of the other Party who is “Controller”;
- (c) “Joint Controller” with the other Party;
- (d) “Independent Controller” of the Personal Data where the other Party is also “Controller”,

in respect of certain Personal Data under a Contract and shall specify in Annex 1 (*Processing Personal Data*) which scenario they think shall apply in each situation.

3. Where a Party is a Processor, the only Processing that it is authorised to do is listed in Annex 1 (*Processing Personal Data*) by the Controller.
4. The Processor shall notify the Controller immediately if it considers that any of the Controller’s instructions infringe the Data Protection Legislation.
5. The Processor shall provide all reasonable assistance to the Controller in the preparation of any Data Protection Impact Assessment prior to commencing any Processing. Such assistance may, at the discretion of the Controller, include:
 - (a) a systematic description of the envisaged Processing and the purpose of the Processing;
 - (b) an assessment of the necessity and proportionality of the Processing in relation to the Deliverables;

- (c) an assessment of the risks to the rights and freedoms of Data Subjects; and
 - (d) the measures envisaged to address the risks, including safeguards, security measures and mechanisms to ensure the protection of Personal Data.
6. The Processor shall, in relation to any Personal Data Processed in connection with its obligations under the Contract:
- (a) Process that Personal Data only in accordance with Annex 1 (*Processing Personal Data*), unless the Processor is required to do otherwise by Law. If it is so required the Processor shall notify the Controller before Processing the Personal Data unless prohibited by Law;
 - (b) ensure that it has in place Protective Measures, including in the case of the Supplier the measures set out in Clause 14.3 of the Core Terms, which the Controller may reasonably reject (but failure to reject shall not amount to approval by the Controller of the adequacy of the Protective Measures) having taken account of the:
 - (i) nature of the data to be protected;
 - (ii) harm that might result from a Personal Data Breach;
 - (iii) state of technological development; and
 - (iv) cost of implementing any measures;
 - (c) ensure that :
 - (i) the Processor Personnel do not Process Personal Data except in accordance with the Contract (and in particular Annex 1 (*Processing Personal Data*));
 - (ii) it takes all reasonable steps to ensure the reliability and integrity of any Processor Personnel who have access to the Personal Data and ensure that they:
 - (A) are aware of and comply with the Processor's duties under this Joint Schedule 11, Clauses 14 (*Data protection*), 15 (*What you must keep confidential*) and 16 (*When you can share information*);
 - (B) are subject to appropriate confidentiality undertakings with the Processor or any Subprocessor;
 - (C) are informed of the confidential nature of the Personal Data and do not publish, disclose or divulge any of the Personal Data to any third party unless directed in writing to do so by the Controller or as otherwise permitted by the Contract; and
 - (D) have undergone adequate training in the use, care, protection and handling of Personal Data;
 - (d) not transfer Personal Data outside of the UK or EU unless the prior written consent of the Controller has been obtained and the following conditions are fulfilled:

- (i) the Controller or the Processor has provided appropriate safeguards in relation to the transfer (whether in accordance with UK GDPR Article 46 or LED Article 37) as determined by the Controller;
 - (ii) the Data Subject has enforceable rights and effective legal remedies;
 - (iii) the Processor complies with its obligations under the Data Protection Legislation by providing an adequate level of protection to any Personal Data that is transferred (or, if it is not so bound, uses its best endeavours to assist the Controller in meeting its obligations); and
 - (iv) the Processor complies with any reasonable instructions notified to it in advance by the Controller with respect to the Processing of the Personal Data; and
 - (e) at the written direction of the Controller, delete or return Personal Data (and any copies of it) to the Controller on termination of the Contract unless the Processor is required by Law to retain the Personal Data.
7. Subject to paragraph 7 of this Joint Schedule 11, the Processor shall notify the Controller immediately if in relation to it Processing Personal Data under or in connection with the Contract it:
- (a) receives a Data Subject Access Request (or purported Data Subject Access Request);
 - (b) receives a request to rectify, block or erase any Personal Data;
 - (c) receives any other request, complaint or communication relating to either Party's obligations under the Data Protection Legislation;
 - (d) receives any communication from the Information Commissioner or any other regulatory authority in connection with Personal Data Processed under the Contract;
 - (e) receives a request from any third Party for disclosure of Personal Data where compliance with such request is required or purported to be required by Law; or
 - (f) becomes aware of a Personal Data Breach.
8. The Processor's obligation to notify under paragraph 6 of this Joint Schedule 11 shall include the provision of further information to the Controller, as details become available.
9. Taking into account the nature of the Processing, the Processor shall provide the Controller with assistance in relation to either Party's obligations under Data Protection Legislation and any complaint, communication or request made under paragraph 6 of this Joint Schedule 11 (and insofar as possible within the timescales reasonably required by the Controller) including by immediately providing:

- (a) the Controller with full details and copies of the complaint, communication or request;
 - (b) such assistance as is reasonably requested by the Controller to enable it to comply with a Data Subject Access Request within the relevant timescales set out in the Data Protection Legislation;
 - (c) the Controller, at its request, with any Personal Data it holds in relation to a Data Subject;
 - (d) assistance as requested by the Controller following any Personal Data Breach; and/or
 - (e) assistance as requested by the Controller with respect to any request from the Information Commissioner's Office, or any consultation by the Controller with the Information Commissioner's Office.
10. The Processor shall maintain complete and accurate records and information to demonstrate its compliance with this Joint Schedule 11. This requirement does not apply where the Processor employs fewer than 250 staff, unless:
- (a) the Controller determines that the Processing is not occasional;
 - (b) the Controller determines the Processing includes special categories of data as referred to in Article 9(1) of the UK GDPR or Personal Data relating to criminal convictions and offences referred to in Article 10 of the UK GDPR; or
 - (c) the Controller determines that the Processing is likely to result in a risk to the rights and freedoms of Data Subjects.
11. The Processor shall allow for audits of its Data Processing activity by the Controller or the Controller's designated auditor.
12. The Parties shall designate a Data Protection Officer if required by the Data Protection Legislation.
13. Before allowing any Subprocessor to Process any Personal Data related to the Contract, the Processor must:
- (a) notify the Controller in writing of the intended Subprocessor and Processing;
 - (b) obtain the written consent of the Controller;
 - (c) enter into a written agreement with the Subprocessor which give effect to the terms set out in this Joint Schedule 11 such that they apply to the Subprocessor; and
 - (d) provide the Controller with such information regarding the Subprocessor as the Controller may reasonably require.
14. The Processor shall remain fully liable for all acts or omissions of any of its Subprocessors.
15. The Relevant Authority may, at any time on not less than thirty (30) Working Days' notice, revise this Joint Schedule 11 by replacing it with any applicable controller to processor standard clauses or similar terms forming part of an

Independent Controllers of Personal Data

18.  - (ii) provide any information and/or assistance as reasonably requested by the other Party to help it respond to the request or correspondence in the timeframes specified by Data Protection Legislation.
26. Each Party shall promptly notify the other Party upon it becoming aware of any Personal Data Breach relating to Personal Data provided by the other Party pursuant to the Contract and shall:
 - (a) do all such things as reasonably necessary to assist the other Party in mitigating the effects of the Personal Data Breach;
 - (b) implement any measures necessary to restore the security of any compromised Personal Data;
 - (c) work with the other Party to make any required notifications to the Information Commissioner's Office and affected Data Subjects in accordance with the Data Protection Legislation (including the timeframes set out therein); and
 - (d) not do anything which may damage the reputation of the other Party or that Party's relationship with the relevant Data Subjects, save as required by Law.

- 2.3 Subject to Paragraph 2.2 above, a person who is not a Party to this Order Contract has no right under the CRTPA to enforce any term of this Order Contract but this does not affect any right or remedy of any person which exists or is available otherwise than pursuant to that Act.
- 2.4 No Third Party Beneficiary may enforce, or take any step to enforce, any Third Party Provision without the prior written consent of the Buyer, which may, if given, be given on and subject to such terms as the Buyer may determine.

- 2.13.6 any proceeding, claim or demand by HMRC or other statutory authority in respect of any financial obligation including, but not limited to, PAYE and primary and secondary national insurance contributions:

1. Buyer's Rights

- 1.1 The Buyer and the Supplier recognise that, where specified in DPS Schedule 4 (DPS Management), the Buyer may give CCS the right to enforce the Buyer's rights under this Schedule.

2. Supplier's Obligations

- 2.1 The Supplier must, throughout the Contract Period, identify new or potential improvements to the provision of the Deliverables with a view to reducing the Buyer's costs (including the Charges) and/or improving the quality and efficiency of the Deliverables and their supply to the Buyer.
- 2.2 The Supplier must adopt a policy of continuous improvement in relation to the Deliverables, which must include regular reviews with the Buyer of the Deliverables and the way it provides them, with a view to reducing the Buyer's costs (including the Charges) and/or improving the quality and efficiency of the Deliverables. The Supplier and the Buyer must provide each other with any information relevant to meeting this objective.
- 2.3 In addition to Paragraph 2.1, the Supplier shall produce at the start of each Contract Year a plan for improving the provision of Deliverables and/or reducing the Charges (without adversely affecting the performance of this Contract) during that Contract Year ("**Continuous Improvement Plan**") for the Buyer's Approval. The Continuous Improvement Plan must include, as a minimum, proposals:
 - 2.3.1 identifying the emergence of relevant new and evolving technologies;
 - 2.3.2 changes in business processes of the Supplier or the Buyer and ways of working that would provide cost savings and/or enhanced benefits to the Buyer (such as methods of interaction, supply chain efficiencies, reduction in energy consumption and methods of sale);
 - 2.3.3 new or potential improvements to the provision of the Deliverables including the quality, responsiveness, procedures, benchmarking methods, likely performance mechanisms and customer support services in relation to the Deliverables; and
 - 2.3.4 measuring and reducing the sustainability impacts of the Supplier's operations and supply-chains relating to the Deliverables, and identifying opportunities to assist the Buyer in meeting their sustainability objectives.
- 2.4 The initial Continuous Improvement Plan for the first (1st) Contract Year shall be submitted by the Supplier to the Buyer for Approval within one hundred (100) Working Days of the first Order or six (6) Months following the Start Date, whichever is earlier.

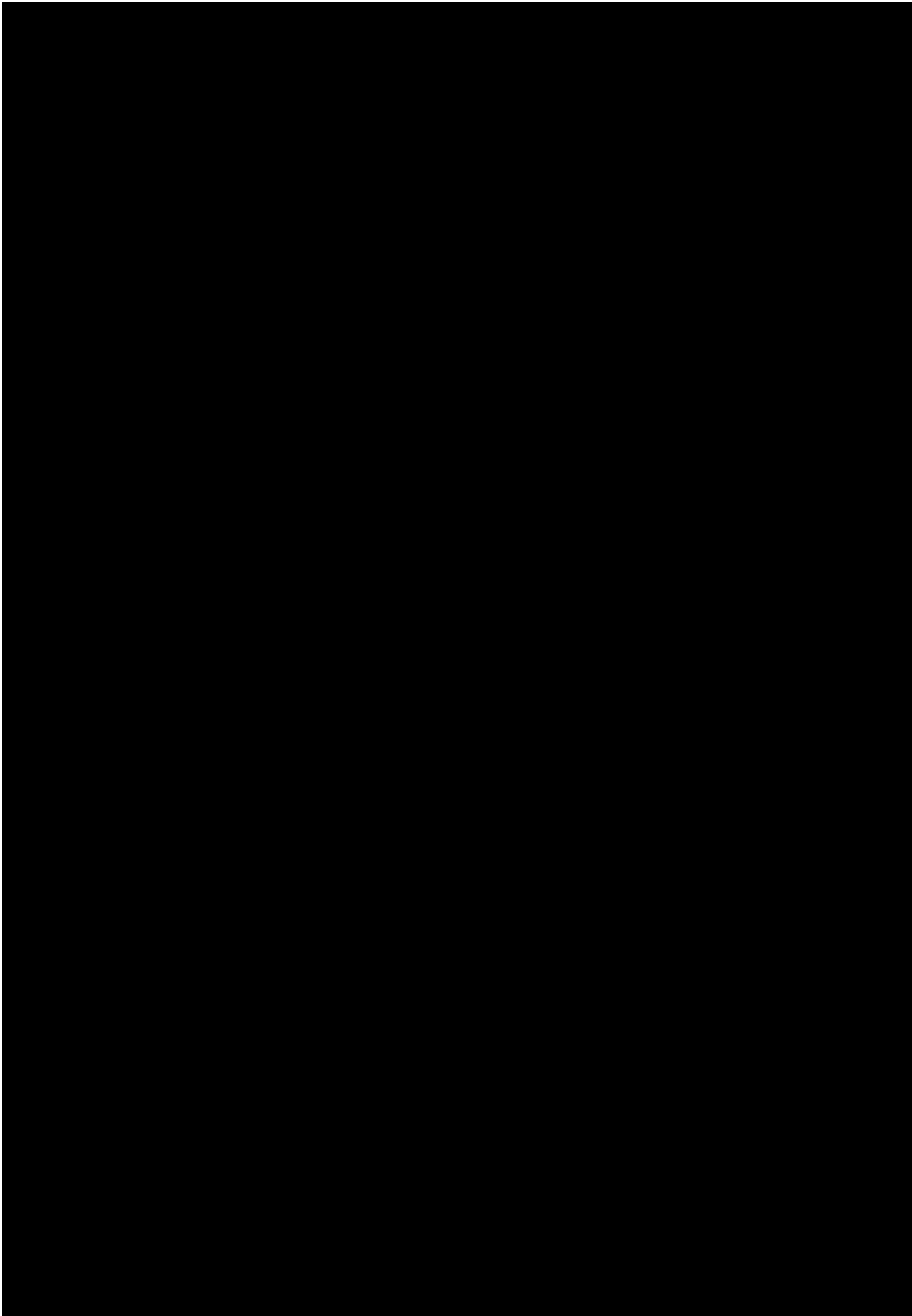
- 2.5 The Buyer shall notify the Supplier of its Approval or rejection of the proposed Continuous Improvement Plan or any updates to it within twenty (20) Working Days of receipt. If it is rejected then the Supplier shall, within ten (10) Working Days of receipt of notice of rejection, submit a revised Continuous Improvement Plan reflecting the changes required. Once Approved, it becomes the Continuous Improvement Plan for the purposes of this Contract.
- 2.6 The Supplier must provide sufficient information with each suggested improvement to enable a decision on whether to implement it. The Supplier shall provide any further information as requested.
- 2.7 If the Buyer wishes to incorporate any improvement into this Contract, it must request a Variation in accordance with the Variation Procedure and the Supplier must implement such Variation at no additional cost to the Buyer or CCS.
- 2.8 Once the first Continuous Improvement Plan has been Approved in accordance with Paragraph 2.5:
- 2.8.1 the Supplier shall use all reasonable endeavours to implement any agreed deliverables in accordance with the Continuous Improvement Plan; and
- 2.8.2 the Parties agree to meet as soon as reasonably possible following the start of each quarter (or as otherwise agreed between the Parties) to review the Supplier's progress against the Continuous Improvement Plan.
- 2.9 The Supplier shall update the Continuous Improvement Plan as and when required but at least once every Contract Year (after the first (1st) Contract Year) in accordance with the procedure and timescales set out in Paragraph 2.3.
- 2.10 All costs relating to the compilation or updating of the Continuous Improvement Plan and the costs arising from any improvement made pursuant to it and the costs of implementing any improvement, shall have no effect on and are included in the Charges.
- 2.11 Should the Supplier's costs in providing the Deliverables to the Buyer be reduced as a result of any changes implemented, all of the cost savings shall be passed on to the Buyer by way of a consequential and immediate reduction in the Charges for the Deliverables.
- 2.12 At any time during the Contract Period of the Order Contract, the Supplier may make a proposal for gainshare. If the Buyer deems gainshare to be applicable then the Supplier shall update the Continuous Improvement Plan so as to include details of the way in which the proposal shall be implemented in accordance with an agreed gainshare ratio.

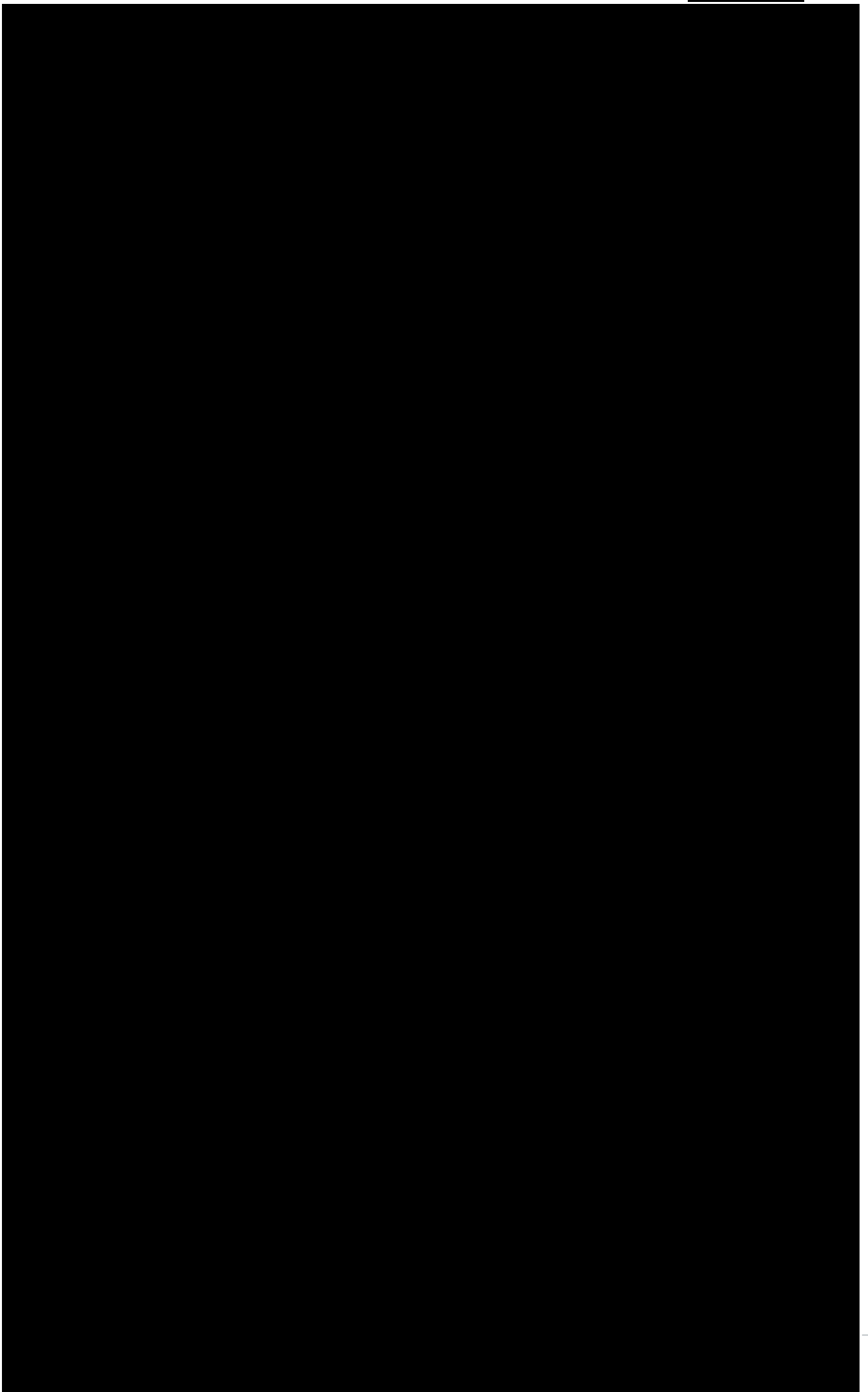

- 1.1 The Annex 1 to this Schedule lists the key roles (“**Key Roles**”) and names of the persons who the Supplier shall appoint to fill those Key Roles at the Start Date.
- 1.2 The Supplier shall ensure that the Key Staff fulfil the Key Roles at all times during the Contract Period.
- 1.3 The Buyer may identify any further roles as being Key Roles and, following agreement to the same by the Supplier, the relevant person selected to fill those Key Roles shall be included on the list of Key Staff.
- 1.4 The Supplier shall not and shall procure that any Subcontractor shall not remove or replace any Key Staff unless:
 - 1.4.1 requested to do so by the Buyer or the Buyer Approves such removal or replacement (not to be unreasonably withheld or delayed);
 - 1.4.2 the person concerned resigns, retires or dies or is on maternity or long-term sick leave; or
 - 1.4.3 the person’s employment or contractual arrangement with the Supplier or Subcontractor is terminated for material breach of contract by the employee.
- 1.5 The Supplier shall:
 - 1.5.1 notify the Buyer promptly of the absence of any Key Staff (other than for short-term sickness or holidays of two (2) weeks or less, in which case the Supplier shall ensure appropriate temporary cover for that Key Role);
 - 1.5.2 ensure that any Key Role is not vacant for any longer than ten (10) Working Days;
 - 1.5.3 give as much notice as is reasonably practicable of its intention to remove or replace any member of Key Staff and, except in the cases of death, unexpected ill health or a material breach of the Key Staff’s employment contract, this will mean at least three (3) Months’ notice;
 - 1.5.4 ensure that all arrangements for planned changes in Key Staff provide adequate periods during which incoming and outgoing staff work together to transfer responsibilities and ensure that such change does not have an adverse impact on the provision of the Deliverables; and

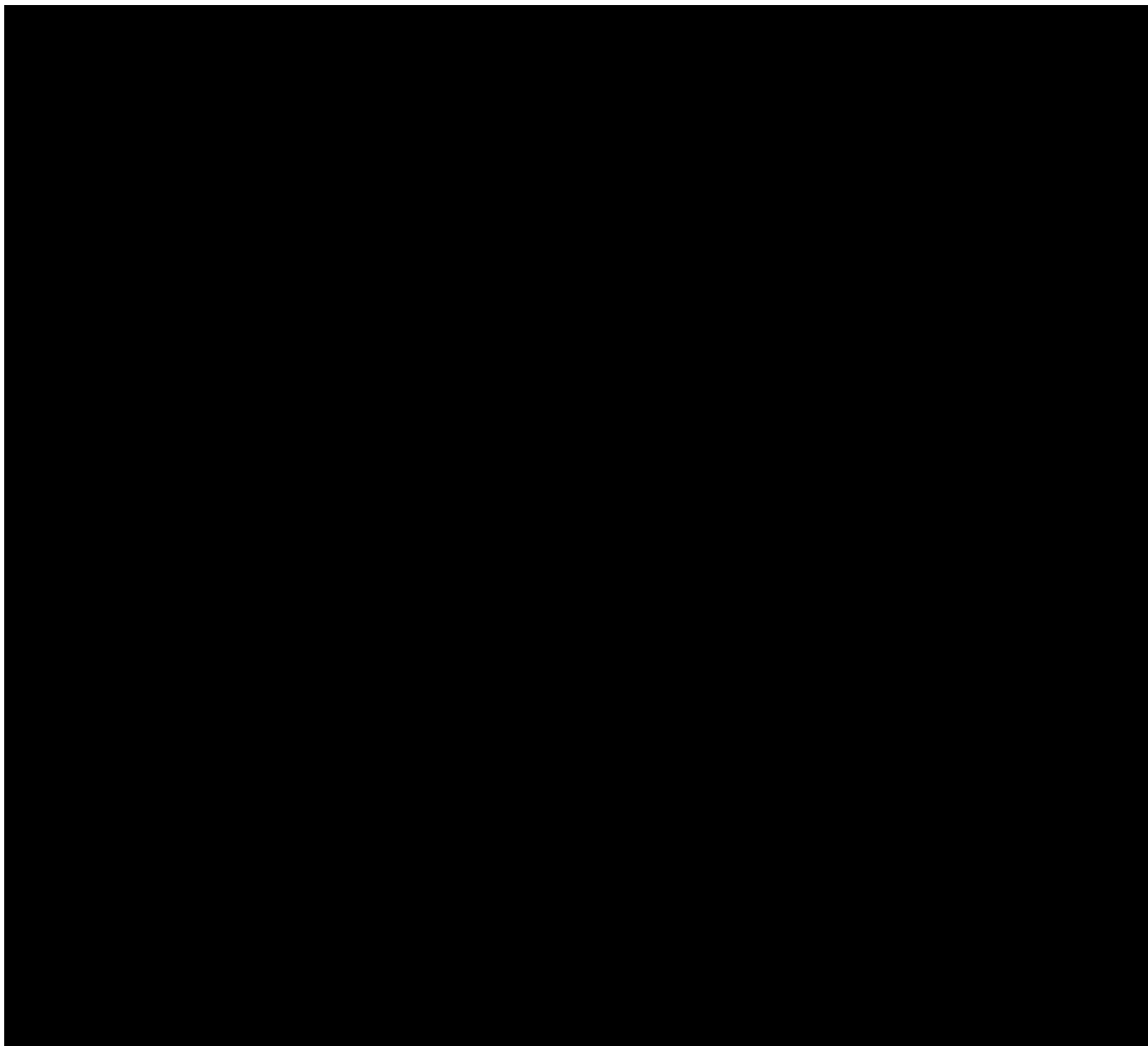

1. Background

The purpose of this research is to improve the evidence on the potential for energy and carbon savings from energy efficiency (EE) measures and technologies for industrial processes. This will provide stronger evidence to support analysis of industrial decarbonisation for carbon budget setting and better inform policy development. The Department for Energy Security and Net Zero (DESNZ) plan to share this evidence with the Climate Change Committee (CCC) to influence their Carbon Budget 7 (CB7) modelling and subsequent advice for placing restrictions on UK greenhouse gas emission over CB7 (2038-2042)¹. This research needs final analytical outputs by the end of June 2024 in order for DESNZ to meet the CCC's CB7 analysis timelines. The final report and handover of material is required by the end of August 2024.

The analysis supporting this modelling work for the CCC is also fundamental to the design of the Government's associated policy and strategy towards Net Zero. This includes:

- Informing how industrial EE can help achieve the 15% energy demand reduction target² and support the UK's energy security³,
- Improving the design and delivery of existing Department for Energy Security and Net Zero policies such as the Industrial Energy Transformation Fund (IETF), pilot Energy Advice Service (EAS), Energy Savings Opportunity Scheme (ESOS) and Climate Change Agreements (CCA), and;
- Informing the development of new policy concerning industrial EE.

The fast-paced development of industrial EE policies is integral to meet milestones set out in the Net Zero Strategy, which suggests UK industry⁴ emissions need to reduce by 87-96% from 2019 levels⁵. The Committee on Climate Change (CCC) reports that there remains at least 3MtCO₂e potential savings from industrial EE by 2035⁶.

This research aims to update and improve our current industrial EE evidence base which is largely based on the "Industrial Decarbonisation and Energy Efficiency Roadmaps to 2050" published in 2015 which sets out potential decarbonisation pathways for the eight

most carbon-intensive industrial sectors⁷. Since this publication, the UK has legislated Net Zero emissions by 2050 and the context for energy policy has changed significantly with increases in fuel prices and energy bills. DESNZ require a refresh of our industrial EE evidence in order to address evidence gaps and support the development of evidence-based policies. Key objectives of this research are to:

1. Update and improve the list of industrial energy efficiency measures and technologies for the 8 'priority' sectors, mapping the technologies and measures to the relevant industrial processes for each sector, estimating their associated costs and fuel savings.
2. Update the current adoption rate⁸ as well as the maximum technical potential and business-as-usual deployment rate profiles⁹ across the list of industrial energy efficiency measures and technologies.
3. Augment evidence on the barriers impacting the uptake of specific industrial energy efficiency measures and technologies as well as barriers impacting particular sectors.
4. Use empirical evidence to assess the industrial EE potential for 'Other manufacturing'.

Outcomes from this research will help identify where energy and carbon saving measures can be delivered at lowest cost, since efficiencies delivered in the short-term can reduce the long-term costs of decarbonisation through more expensive technologies such as through carbon capture and fuel switching. Energy efficiency for industrial processes will include technologies such as waste heat recovery, refrigeration, and mechanical processes as well as improved process designs, such as via metering and energy control systems.

2. Aims and Objectives of the Project

This research will address gaps from this evidence base and gather data to improve Departmental modelling to support the development of industrial EE policies to deliver environmental, economic and climate benefits.

The research will cover **8 'priority' sectors**: chemicals, paper & pulp, food & drink, iron & steel, refineries, cement, ceramics, and glass; **as well as 'Other manufacturing'** (i.e., 8 sectors plus 'other manufacturing').

The specific objectives of the research project are to:

- 1) Update and improve the list of industrial energy efficiency measures and technologies and their associated cost and fuel savings for the 8 'priority'**

sectors¹⁰. Add relevant new technologies and measures to the list, mapping them to industrial processes and collating fuel saving and cost parameters for use in Departmental modelling. This will require the successful bidder to:

- Update and improve the list of EE technologies and measures identified from the 2015 Roadmaps study for the 8 'priority' sectors, assessing whether there are relevant additions and amendments that should be made.
- Identify which EE technologies and measures are relevant to 'Other manufacturing'.
- Develop clear technology definitions with associated fuel savings, capex, opex, and installation costs, asset lifetime and year in which technology is commercially available. The 2015 Roadmaps study identified a range of EE technologies across 8 carbon-intensive sectors, however some technologies have generic classifications and lack detailed definitions.
- Identify how the implementation of multiple EE technologies and measures interact and impact the fuel savings from a particular technology. This is because the installation of numerous EE technologies for a process may reduce the fuel savings associated with an individual technology.
- Identify where the deployment of EE technologies and measures might interact with decarbonisation options, such as through fuel switching, carbon capture and industrial resource efficiency measures, such as where EE technologies become less relevant, compliment or act as a substitute to other decarbonisation options.
- Map EE technologies and measures onto sector-specific processes that align with Departmental modelling, and where appropriate group technologies and measures.

This research project should answer the following questions to achieve this objective:

- a) *What industrial EE technologies and measures exist or are anticipated for each of the 8 'priority' sectors and which sector specific application do they apply to? What are their definitions and purpose within sector processes?*
- b) *What are the key EE technologies and measures that are applicable within 'Other manufacturing'? What are the processes these EE technologies and measures are used for within key subsectors of 'Other manufacturing'? (e.g., use of efficient motors, compressors or other mechanical processes in the manufacturing of vehicles, textiles, electrical engineering etc.)*
- c) *What are up-to-date and representative capex, opex, installation costs and fuel savings associated with the EE technologies and measures listed?*
- d) *What are the fuel savings interactions between EE technologies and measures?*
- e) *What would the fuel and carbon savings from the deployment of EE technologies and measures equate to at a sector and industry level?*
- f) *What are the potential interactions with EE technologies and potential industrial resource efficiency measures and deep decarbonisation technologies?*
- g) *Which sector processes used in DESNZ modelling do the EE technologies and measures apply to? What are the key fuel saving EE technologies and*

measures? How might smaller EE technologies and measures be grouped within these sector processes?

2) Update the current adoption rate as well as the maximum technical potential and business-as-usual deployment rate profiles across the list of industrial energy efficiency technologies and measures.

This research project should develop the following scenarios for the deployment of EE measures and technologies:

- a) **Scenario A:** *What is the current adoption rate of EE technologies and measures across the 8 carbon-intensive sectors? How does this compare to the 2015 Industrial Decarbonisation and Energy Efficiency Roadmaps? What is the applicability rate for the technologies within the sector?*¹¹
- b) **Scenario B:** *What would be the deployment rate of EE technologies and measures under a business-as-usual scenario out to 2050 that would be expected with the current policy mix and private sector incentives?*
- c) **Scenario C:** *What would be the maximum technology deployment out to 2050 that could be reasonably achieved for each EE measure and technology?*

Deployment rate profiles should include a scenario that accounts for interactions between EE technologies and measures in scenarios B and C since fuel savings may be lower if multiple technologies are deployed as part of the same process.

These findings should then feed into a spreadsheet model to estimate the fuel and carbon savings industrial EE could achieve. The spreadsheet model should have the ability to undertake scenarios such as applying a proportion of maximum technical potential fuels savings or include additional intermediate deployment scenarios.

3) Augment evidence on the barriers impacting the uptake of specific industrial energy efficiency technologies and measures or whether there are specific barriers to sectors. There are well-established high-level barriers to EE, but it would be useful to identify the barriers facing particularly important technologies or measures as well as by sectors. Such challenges may be technical (e.g. dependency on other technologies, installation risks), behavioural (e.g. sub-optimal utilisation, lack of skills) or commercial (e.g. relatively low paybacks).

This research project should answer the following questions to achieve this objective:

- a) *What current or anticipated drivers and barriers are affecting the deployment of EE technologies? Are there possible solutions to these barriers?*
- b) *To what extent do the barriers identified influence the transition between business-as-usual and maximum deployment rate profiles? How might addressing key barriers increase the deployment of key technologies in relation to the maximum technology deployment rate profiles?*

- 4) Use empirical evidence to assess the industrial EE potential for ‘Other manufacturing’ to understand the scope for fuel and carbon savings across industry beyond the 8 carbon-intensive industrial sectors from the 2015 study being updated for this research.** Currently, broad assumptions are used to estimate the energy efficiency potential from sectors outside of the 2015 study. ‘Other manufacturing’ captures a diverse range of activities, accounting for around one-third of energy use within industry. DESNZ therefore require an assessment to inform the scope for energy efficiency gains in this sector. There are multiple ways in which ‘Other manufacturing’ could be broken down. Given the range of activities under ‘Other manufacturing’ a top-down analytical approach such as identifying EE trends or metrics for EE benchmarking might be appropriate for this sector. Similar top-down workings across the 8 ‘priority’ sectors will also be helpful to sense check bottom-up the fuel savings calculated from using the technology list.

This research project should answer the following questions to achieve this objective:

- a) *What would be the potential fuel savings from ‘Other manufacturing’ for a maximum technology deployment scenario out to 2050?*
- b) *What are the potential fuel savings from ‘Other manufacturing’ under a business-as-usual scenario out to 2050 that would be expected with the current policy mix and private sector incentives?*
- c) *What EE trends are taking place across industrial sectors in the UK, including the 8 ‘priority’ sectors? What are the EE metrics of highly efficient industrial sites in these sectors and what could be a theoretical minimum energy intensity/ level of energy use?*

3. Suggested Methodology

DESNZ expects evidence on the research questions outlined in section 2 ‘Aims and Objectives of the Project’, will be gathered via the literature review and desk-based research for the 8 ‘priority sectors’ as well as for ‘Other manufacturing’. It is expected that interviews will be used to test findings from the literature review for the 8 ‘priority sectors’ to augment findings and establish an approach for the workshop. Answers developed following the literature review and interviews will then be tested at the workshops for further input and reach to a consensus view.

For ‘Other manufacturing’ it is envisaged that a different approach will be taken following the literature review, such as using a top-down approach to develop profiles for EE potential within this sector. This is due to the heterogenous nature of the activities within ‘Other manufacturing’, but DESNZ welcome innovative suggestions on how the research questions on ‘Other manufacturing’ can be answered.

‘Priority sectors’ and bottom-up deep-dive for deployment rate profiles

It is envisaged that these will cover the original 8 roadmaps sectors from the 2015 industrial decarbonisation Roadmaps; iron & steel, cement, ceramics, refining, pulp & paper, chemicals, glass and food & drink.

A similar research approach was undertaken in DESNZ's 2015 Industrial Decarbonisation and Energy Efficiency Roadmaps¹² which were used by the Climate Change Committee (CCC) in their Carbon Budget 6 modelling¹³. To establish well-informed deployment rate profiles across the technologies multiple research methods are required to ensure the deployment findings consider a range of stakeholder input. Production processes and EE potential will vary notably between sectors. This should be taken into account to inform a proportionate research approach for each sector. Bidders should set out how the differing levels of process complexity and number of key EE technology options between sectors will be taken into account to promote a proportionate research approach and pragmatic use of resources.

For each sector, DESNZ envisage a process of:

- a) Literature reviews of different technologies and measures relevant to their current adoption rates and potential deployment rate profiles in the UK's industrial sectors.
- b) Stakeholder consultation via interviews on relevant EE technologies and measures, technology deployment and scope for technological potential for EE. This should cover a balance of relevant stakeholders from industry, trade associations and academia.
- c) A facilitated workshop that looks to build consensus on each of the deployment scenarios and will need to include a diverse list of relevant stakeholders from industry, trade associations and academia.
- d) Sense checking the consistency of deployment scenarios with relevant EE benchmarks.

DESNZ expects this research is set into two phases to sequence engagement with stakeholders who might also be involved in similar Departmental research currently underway, for example on Industrial Resource Efficiency (IRE). Phase 1 of the IRE research, which concluded in July, included steel and cement sectors. The phase 2 of the IRE work, which will be interviewing and holding workshops with stakeholders in September/October 2023, includes chemicals, pulp & paper, food & drink and glass. This suggests that for this research project, it may be best to lead engagement with iron & steel, cement, refineries and ceramics for a Phase 1 sector group, with remaining sectors covered in a Phase 2. For clarification the two phases for industrial EE sectors suggested are:

Phase 1: Iron & steel, cement, refineries and ceramics

Phase 2: Chemicals, pulp & paper, food & drink and glass; as well as findings for 'Other manufacturing'

Top-down analysis for 'Other manufacturing' sector

For 'Other manufacturing' DESNZ envisage a process of:

- a) A literature review detailing widely applicable technologies and measures relevant to 'Other manufacturing' and key subsectors. IT is expected that this assessment will draw on information from the literature reviews on the 'priority sectors' to help identify key applicable technologies and measures for research question 1b.
- b) To understand the scope for energy and carbon savings across industry beyond the 8 carbon-intensive industrial sectors assessed in the 2015 Roadmaps study, DESNZ require an assessment of EE potential for 'Other manufacturing' which captures a diverse range of activities. There are multiple ways in which this could be approached such as breaking down 'Other manufacturing' down into key sectors, materials or processes, however due to the range of activities, a top-down analysis for sectoral energy efficiency trends or benchmarking exercises might be most appropriate for this sector.

DESNZ welcomes suggestions on how the EE potential for 'Other manufacturing' can be approached to provide well-informed yet proportionate findings. Bidders should outline a proposed methodology for how the EE potential scenarios for 'Other manufacturing' would be evidenced.

Definition of industrial energy efficiency

For this research, the definition of industry covers activities under SIC codes 5, 7-9, 10-33 and 41 to 43 covering mining, construction and all manufacturing activities. Mining and construction activities are not 'priority sectors' and should be accounted for as part of 'Other manufacturing', taking a proportionate approach.

EE technologies and measures concern machinery and equipment involved in industrial processes, including primary and final energy consumption, as well as energy management and control systems. EE buildings measures such as around building fabric, space heating and lighting are not in scope (see annex A for current EE technology list).

The Department will provide to the successful bidder some internal information to support this research. This will include data from the 2015 Roadmaps EE technology list, deployment rates and percentage fuel savings by sector and the format of the modelling inputs which the technology parameters from this research need to align. The Department will also provide information on baseline sector fuel use, key industrial resource efficiency measures and deep decarbonisation technologies to help assess potential interactions with EE from industrial processes. Bidders should not assume additional data is provided beyond those mentioned.

Literature reviews

The literature reviews are needed to bring together existing research from the 2015 Roadmaps study and wider research that has been done relevant to the research questions detailed in section 2 above 'Aims and Objectives of the Project'. It is envisaged the literature reviews for each phase will be structured by sector, sector process and then relevant technologies and measures. The literature review should attempt all research questions outlined in section 2 to ensure that the stakeholder interviews and workshops are informed by a comprehensive understanding of the current evidence base as the findings will form the basis of discussions.

The literature reviews should aim to synthesise available evidence on the EE technologies. DESNZ would like there to be a systematic approach to searching the literature to ensure the search is comprehensive and to reduce selection bias. The search of the literature should aim to capture published literature and grey literature from the UK and internationally, published since the time of the 2015 Industrial Decarbonisation and Energy Efficiency Roadmap. Justification should be provided as to why sources were selected for the literature review. Where sources are found but not used for evidence, reasoning should be provided.

The list of EE technologies and measures from this research is likely to differ to some extent compared to the 2015 Roadmaps, with updated and more refined EE options and due to the aims of this research. For reference see annex A for current technology list.

Methodology assessment criteria list 1: Bids outlining the proposed review methodology should include:

- a) How a proportionate approach and pragmatic use of resources will be employed across the different sectors.
- b) Search criteria and approach taken to identify relevant sources, including search words or parameters.
- c) Sources and databases used to identify literature.
- d) Inclusion and exclusion criteria as to why sources will be referenced or not.
- e) Methods for quality assessment, including any scoring of sources.
- f) How a searchable, user-friendly dataset including all literature analysed and sorted into industrial sectors will be formatted.

Interviews with relevant stakeholders

Interviews are expected to last no more than one hour and can be held virtually. The interviews will be used to test findings from the literature set out in the objectives such as on the technology list and deployment rate profiles, seek details and build understanding around the literature review findings. Interviews should cover a diverse range of stakeholders which would help point out any evidence gaps or risks, and gain opinions on areas of uncertainty. Our work on the IRE project has suggested that it would be more appropriate to do this via interviews of key individuals via structured interviews rather than a workshop.

DESNZ envisage sampling to identify relevant academics and trade associations as well as shortlisting key industrial sites/companies with large energy use or output, while also ensuring all key industrial processes within the respective sectors are covered.

DESNZ does not require bidders to have pre-existing connections with stakeholders for the interviews or workshops and will support in the identification of stakeholders to engage.

Methodology assessment criteria list 2: Bidders should propose and provide rationale for:

- a) Sampling approach to identify key stakeholders and approach to obtain contact details for interview and the workshops.
- b) Number of interviews proposed in total and by sector.
- c) Length and mode (e.g., in-person, videocall, telephone) of interviews.
- d) Engagement plan to promote attendance and ensure interviewees review pre-interview material.
- e) Approach for using the literature reviews and evidence gathering to produce interview materials and structure the interviews.
- f) Development of interview guides and plans to support interviewer preparations.
- g) How answers will be logged and used for data collection.

Facilitated workshops

DESNZ believe a facilitated workshop is needed to verify and test the findings of the literature review and interviews, and to fill remaining evidence gaps for each of the priority sectors. These will bring together a diverse range of expert stakeholders who are able to advise on the relevant industrial energy efficiency technologies and measures and systematically build a consensus on the issues set out in the research objectives. This is crucial to ensuring the credibility of the final results and will ensure research outputs are representative of stakeholder views. It is envisaged that workshops would take no longer than a working day. **Bidders should set out the number of interviews proposed in total and per sector.** A diverse range of key stakeholders will be required for interviews.

Purposive sampling should be used to ensure an appropriate range of expert stakeholder views are represented. The size of each workshop will vary depending on industry sector complexity, but don't envision more than around 20 people at any one workshop. For each sector there should be stakeholders from a range of backgrounds (academics, industry representatives, and third-party organisations). Bids should include 8 facilitated workshops – including a mixture of industry, trade representatives and academics.

For each sector DESNZ envisage holding one workshop, with some flexibility for follow up engagement if required. The outputs from the literature review and interviews should be provided to participants ahead of the workshop alongside a list of the questions to address. Workshop participants will be asked to review these outputs and consider the questions ahead of the workshops. It is envisaged that the workshops will be utilised to present draft deployment rate profiles across the relevant technologies for attendees to give views.

DESNZ suggests this discussion should be carried out within the COM-B framework (**C**apability, **O**ppportunity, **M**otivation) – that is, considering not just for the factors preventing industry from being able to carry out energy efficiency actions (capability), but also what factors provide the incentives (motivation) and circumstances (opportunity) to act.

Methodology assessment criteria list 3: Bidders should propose and provide rationale for:

- a) Engagement plan to promote attendance and ensure interviewees review pre-interview material.
- b) Method proposed for the workshops, including length, structure and whether virtual, in-person and/or hybrid.
- c) Approach for using findings to produce workshop material and how will this build on findings taken from the literature review and interviews.
- d) How the workshop will be coordinated to ensure effective input from the range of stakeholders in attendance.
- e) Approach to ensure adequate discussion is had on the required research questions.
- f) Approach to mediate opposing views, build consensus from a diverse range of stakeholders as well as how research will represent a divergence of views if consensus cannot be reached.
- g) Approach to synthesize findings from the literature review, interviews, and workshops for final analytical outputs and reporting.
- h) Approach to identify relevant evidence provided from workshop stakeholder input and promote findings that are representative of the sector.
- i) How limitations and uncertainties from the chosen approach should be accounted for in the analysis.

Fuel saving from deployment scenarios

To enable estimates on the percentage fuel saving potential from industrial EE by sector, the adoption and applicability rate for each EE technology/measure needs to be established, along with a deployment rate profile for ‘business-as-usual’ and ‘maximum technology deployment’ scenarios. The scope to which an EE technology/measure can be deployed in future, accounting for the difference between adoption and applicability rate, is then applied to the potential percentage fuel savings from the technology/measure at the sector level. From this percentage change in fuel savings from the EE technology/measure, the reduction in fuel use is then calculated by multiplying the percentage change in fuel use by sector’s baseline fuel use¹⁴.

Key challenges

¹⁴ Calculation steps for fuel savings, at sector level, from deploying an EE technology in a given year compared to a base year:

$$1) \text{ \% Technology fuel savings} = (\% \text{ Change in deployment} \times (\% \text{ Applicability} - \% \text{ Adoption})) \times \% \text{ Technology fuel saving potential}$$

$$2) \text{ Technology fuel saving (GWh)} = \% \text{ Technology fuel savings} \times \text{Baseline sector energy use (GWh)}$$

A key challenge for this research is likely to be around establishing stakeholder consensus on a robust maximum technical deployment rate profile across the key technologies and measures for the sector. This will require coordinating workshops effectively to enable input from a range of stakeholders and that sufficient explanations are made regarding how technologies would be deployed, ensuring key technologies are given adequate time for discussion.

4. Deliverables

Findings will ultimately need to be set out in one 30-page summary report (not including annexes) along with a report for each of the 9 sectors (i.e. the 8 'priority' sectors plus 'Other manufacturing'.

Draft literature reviews for each of the 9 sectors should be provided following evidence gathering and prior to sending to interviewees for DESNZ to review. Also, two interim reports should be provided for each phase for DESNZ to review detailing research findings following evidence gathered from the literature reviews and interviews ahead of sending out to workshop stakeholders.

Literature review outputs:

Literature reviews should cover each of the 8 'priority sectors' as well as for 'Other manufacturing' containing summarised findings from the literature for the research objectives outlined in section 2 above and an indication of the strength of the literature supporting these findings. From the research DESNZ would like to receive a searchable, user-friendly dataset including all literature analysed and sorted into industrial sectors.

Outputs from stakeholder interviews:

Materials for the interviews should summarise the evidence from the literature and outline the questions that will be asked in the interviews. This should set out the sources used, and evidence gathered pertaining to the objectives in section 2 above. These will be sent to interviewees in advance of the interview. Answers from the interviews should be written up and anonymised.

Workshop outputs:

Materials for the workshops should summarise the evidence from the literature and interviews, outlining findings on the objectives and setting out questions that will be asked in the workshops. These will be sent to attendees in advance of the workshops including a list of recommended and actual stakeholder attendees for each workshop, a note outlining the methodology used in the workshops and how consensus was agreed upon, and anonymised transcripts of all the workshops. It is envisaged that the workshops will focus on establishing a consensus on the deployment rate profiles across the relevant technologies and measures following input from attendees.

Reporting outputs:

1. Draft literature reviews

9 draft literature reviews for each of the 8 'priority' sectors plus 'Other manufacturing' containing draft findings. For the 8 'priority' sectors this work will form the material

proposed to share with interviewees pertaining to the research questions in section 2 above such as on the list of EE technologies and measures, their definitions and parameters, sector process mapping, fuel saving interactions, deployment rates and barriers.

The 9 draft literature reviews are expected to be structured by sector, sector process, then technology and measure across the 8 'priority' sectors as well as a section on 'Other manufacturing' which will likely require a slightly different and higher-level structure such as by sub-sector or broad process. Draft outputs related to the technology list and other research questions in section 2 above should also be provided.

It is expected that all literature reviews will take place at the same time to support efficiencies for evidence gathering across the sector technologies as similar sources might be used and have some technology read across. DESNZ propose that the draft literature reviews for Phase 1 sectors are provided by December 2023 (pre-Christmas) and draft literature reviews for Phase 2 sectors, including 'Other manufacturing' are provided by January 2023. Timelines should account for time for DESNZ to review the draft literature reviews and provide comments, with scope for a second iteration for DESNZ to review, ahead of interviews for the respective sector Phases.

2. Interim reports

Two interim reports are required once information from the literature reviews and interviews have been collated for each phase of the research. We expect the first interim report on iron & steel, cement, refineries and ceramics to be completed in February 2023, and the second interim report on chemicals, paper & pulp, food & drink and glass completed in May 2024.

The interim reports should contain updated findings regarding the research questions outlined in section 2 above and set out material that will be tested with stakeholders at the workshops. Importantly, this will include the technology deployment profiles.

The interim reports should also set out the literature referenced and methodology, including where any expert judgment was applied and the extent to which uncertainties are present. The interim reports should be clear and provide details of how the outputs in response to the research questions were formed. Again, timelines should account for time for DESNZ to review and provide comments, with scope for a second iteration for DESNZ to review should it be required.

The first interim report should provide greater detail on the methodology and assessment on the robustness of initial findings to support lessons learned to help inform the approach for Phase 2 of the research. The two interim reports are expected to be structured in a similar way to the draft literature reviews from the evidence gathering.

3. Final reports

The final report will need to be set out in one 30-page cross-cutting report (not including annexes) summarising the research as a whole across the 9 sectors. Alongside this summary report, DESNZ require a report for each of the 9 sectors (i.e. the 8 'priority' sectors plus 'Other manufacturing'). Much of the reports will be based on the work done during the literature reviews and interim reports which seek to build on one another.

These final reports will need to be suitable for publication and a technical report(s)

covering each sector suitable for publication accessible to a public audience. DESNZ expect at least two substantive drafts of the final reports to be shared with DESNZ for comment with drafts shared across July 2024 with a final report by the end of August 2024.

The final report will be based on finding from the literature reviews interviews and facilitated workshops and should include a record of the evidence which produced these answers (e.g. what evidence was used, where there was disagreement between sources, measure of disagreement etc.). The final report should provide consensus views on the current, maximum technical and business-as-usual technology deployment rates as outlined in the objectives from section 2 above.

4. Spreadsheet model with deployment scenarios and impact on fuels/ EE over time

This will set out deployment rate profiles of different EE measures and technologies out to 2050 and calculate what their combined impact will be on the sector level and industry wide consumption of different fuels and allow for EE scenarios for each sector to be created. The spreadsheet will contain the information consistent with the research questions and aforementioned reporting requirements, placing the data into an organised spreadsheet model format. Key components are the list of EE technologies and measures, their deployment rate scenarios, and cost and fuel saving parameters consistent with DESNZ modelling.

This spreadsheet model will be used for internal purposes to allow DESNZ and the CCC to incorporate the findings in analysis to derive decarbonisation pathways for industry. The exact specification and format will be agreed with DESNZ at the outset of the project – as this will also help format responses to research question 1.

High-level sector analysis on EE trends for 'Other manufacturing' and the 8 'priority' sectors should also be provided with full workings.

These analytical outputs will need to be finalised and shared with DESNZ by June 2024 following findings from Phase 2 sector workshops and prior to the drafting of final reports, to ensure DESNZ can meet the CCC's timings for modelling sector decarbonisation pathways.

Quality assurance

The spreadsheet models must be quality assured and documented. Bidders should include a Quality Assurance (QA) plan that they will apply to all the research tasks and modelling. It should include the delivery of a DESNZ QA Log.

This [link¹⁵](#) contains an externally accessible version of the DESNZ Modelling QA guidance, and the QA log. The QA log should be filled during the project and submitted at project completion as a deliverable to demonstrate the QA undertaken.

When models are submitted to DESNZ, during the project or at completion, they should be accompanied by confirmation by a senior (partner or equivalent) of the supplier organisation, that the assurance has taken place in accordance with approaches outlined

in the QA plan agreed with DESNZ. Evidence of testing through development provided in support of the QA Log ratings greatly improves the level of confidence in it.

For all projects suppliers must provide quality assurance evidence for any existing models they wish to submit to DESNZ. This must be to a standard that is at least the equivalent of DESNZ's internal standard and accepted as suitable by DESNZ.

5. Other outputs

Other outputs including presentation of results to a cross-government audience and slide decks for use in cross-government and external presentations.

Timings

For this research the contract is set to end August 2024. There is a firm deadline for finalised analytical outputs to be provided to DESNZ by June 2024. Bids should include proposed work plans and how research will be managed to ensure all deliverables are provided by this date, including potential contingency plans if work is struggling to meet the schedule. The phases are suggested to sequence stakeholder interviews and workshops with the IRE research. However, this sequencing does not constrain when the 'priority sector' literature reviews and 'Other manufacturing' literature review and research can commence. Higher payments for Phase 2 reflect greater process complexities assumed from these sectors.

It is expected that there will be some parallel working such as across the sector literature reviews as well as between Phase 1 sector workshops and Phase 2 sector interviews. Bids should outline a proposed work plan to manage this parallel working across the sectors and Phase 1 and 2 interviews, workshops and reporting.

The £350,000 budget from DESNZ is allocated between financial year with £200,000 for 2023/24 and £150,000 for 2024/25.

Project management and quality assurance

The successful bidder will be expected to identify one named point of contact through whom all enquires can be filtered. As this research is broadly split into two phases but require parallel work across them, bidders will be expected to appoint a project management structure that ensures the literature reviews are managed in parallel, whilst synergies and opportunities for efficiencies are identified.

A DESNZ project manager will be assigned to the project and will be the central point of contact.

Where a consortium or sub-contractors are in place, DESNZ expects that they are included in relevant meetings, workshops and review points to ensure their full engagement in the project. All contractors and sub-contractors are responsible for the delivery of timely, quality outputs. It is expected that the lead contractor takes an active role in oversight of all workstreams and bears the overall responsibility for the delivery of the evaluation activities and outputs.

Regular project management updates

The frequency of project updates is likely to vary throughout the course of the contract in line with the nature of the activities at the time. It should be expected that at a minimum fortnightly Microsoft Teams calls will be required between the supplier and DESNZ project manager. The successful bidder will be required to provide regular written updates on progress for each stage of research and outstanding actions. The regularity of these updates should be decided during the inception phase of the project.

It is expected that the successful bidder will keep project trackers and risk logs up to date in advance of each project management meeting, including an invoice schedule and overview of the budget for each phase of research. DESNZ expects this to be made accessible for the department to monitor progress.

On occasion, DESNZ may ask the successful bidder to attend a DESNZ office for a face-to-face meeting. This is not expected to be regular occurrence and online meetings will be the default. Attendance will be at the successful bidder's own expense

Core Terms - DPS

1. Definitions used in the contract

Interpret this Contract using Joint Schedule 1 (Definitions).

2. How the contract works

- 2.1 The Supplier is eligible for the award of Order Contracts during the DPS Contract Period.
- 2.2 CCS does not guarantee the Supplier any exclusivity, quantity or value of work under the DPS Contract.
- 2.3 CCS has paid one penny to the Supplier legally to form the DPS Contract. The Supplier acknowledges this payment.
- 2.4 If the Buyer decides to buy Deliverables under the DPS Contract it must use DPS Schedule 7 (Order Procedure) and must state its requirements using DPS Schedule 6 (Order Form Template and Order Schedules). If allowed by the Regulations, the Buyer can:
- (a) make changes to DPS Schedule 6 (Order Form Template and Order Schedules);
 - (b) create new Order Schedules;
 - (c) exclude optional template Order Schedules; and/or
 - (d) use Special Terms in the Order Form to add or change terms.
- 2.5 Each Order Contract:
- (a) is a separate Contract from the DPS Contract;
 - (b) is between a Supplier and a Buyer;
 - (c) includes Core Terms, Schedules and any other changes or items in the completed Order Form; and
 - (d) survives the termination of the DPS Contract.
- 2.6 Where the Supplier is approached by any Other Contracting Authority requesting Deliverables or substantially similar goods or services, the Supplier must tell them about this DPS Contract before accepting their order.
- 2.7 The Supplier acknowledges it has all the information required to perform its obligations under each Contract before entering into a Contract. When information is provided by a Relevant Authority no warranty of its accuracy is given to the Supplier.
- 2.8 The Supplier will not be excused from any obligation, or be entitled to additional Costs or Charges because it failed to either:

Core Terms - DPS

(a) verify the accuracy of the Due Diligence Information; or (b) properly perform its own adequate checks.

2.9 CCS and the Buyer will not be liable for errors, omissions or misrepresentation of any information.

2.10 The Supplier warrants and represents that all statements made and documents submitted as part of the procurement of Deliverables are and remain true and accurate.

2.11 An Order Contract can only be created using the electronic procedures described in the FTS Notice as required by the Regulations.

2.12 A Supplier can only receive Orders under the DPS Contract while it meets the basic access requirements for the DPS stated in the FTS Notice. CCS can audit whether a Supplier meets the basic access requirements at any point during the DPS Contract Period.

3. What needs to be delivered

3.1 All deliverables

3.1.1 The Supplier must provide Deliverables:

- (a) that comply with the Specification, the DPS Application and, in relation to an Order Contract, the Order Tender (if there is one);
- (b) to a professional standard;
- (c) using reasonable skill and care; (d) using Good Industry Practice;
- (e) using its own policies, processes and internal quality control measures as long as they do not conflict with the Contract; (f) on the dates agreed; and (g) that comply with Law.

3.1.2 The Supplier must provide Deliverables with a warranty of at least 90 days from Delivery against all obvious defects.

3.2 Goods clauses

3.2.1 All Goods delivered must be new, or as new if recycled, unused and of recent origin.

3.2.2 All manufacturer warranties covering the Goods must be assignable to the Buyer on request and for free.

3.2.3 The Supplier transfers ownership of the Goods on Delivery or payment for those Goods, whichever is earlier.

3.2.4 Risk in the Goods transfers to the Buyer on Delivery of the Goods, but remains with the Supplier if the Buyer notices damage following Delivery and lets the Supplier know within 3 Working Days of Delivery.

Core Terms - DPS

- 3.2.5 The Supplier warrants that it has full and unrestricted ownership of the Goods at the time of transfer of ownership.
- 3.2.6 The Supplier must deliver the Goods on the date and to the specified location during the Buyer's working hours.
- 3.2.7 The Supplier must provide sufficient packaging for the Goods to reach the point of Delivery safely and undamaged.
- 3.2.8 All deliveries must have a delivery note attached that specifies the order number, type and quantity of Goods.
- 3.2.9 The Supplier must provide all tools, information and instructions the Buyer needs to make use of the Goods.
- 3.2.10 The Supplier must indemnify the Buyer against the costs of any Recall of the Goods and give notice of actual or anticipated action about the Recall of the Goods.
- 3.2.11 The Buyer can cancel any order or part order of Goods which has not been Delivered. If the Buyer gives less than 14 days notice then it will pay the Supplier's reasonable and proven costs already incurred on the cancelled order as long as the Supplier takes all reasonable steps to minimise these costs.
- 3.2.12 The Supplier must at its own cost repair, replace, refund or substitute (at the Buyer's option and request) any Goods that the Buyer rejects because they do not conform with Clause 3. If the Supplier does not do this it will pay the Buyer's costs including repair or re-supply by a third party.

3.3 Services clauses

- 3.3.1 Late Delivery of the Services will be a Default of an Order Contract.
- 3.3.2 The Supplier must co-operate with the Buyer and third party suppliers on all aspects connected with the Delivery of the Services and ensure that Supplier Staff comply with any reasonable instructions.
- 3.3.3 The Supplier must at its own risk and expense provide all Supplier Equipment required to Deliver the Services.
- 3.3.4 The Supplier must allocate sufficient resources and appropriate expertise to each Contract.
- 3.3.5 The Supplier must take all reasonable care to ensure performance does not disrupt the Buyer's operations, employees or other contractors.
- 3.3.6 The Supplier must ensure all Services, and anything used to Deliver the Services, are of good quality and free from defects.

3.3.7 The Buyer is entitled to withhold payment for partially or undelivered Services, but doing so does not stop it from using its other rights under the Contract.

4. Pricing and payments

4.1 In exchange for the Deliverables, the Supplier must invoice the Buyer for the Charges in the Order Form.

4.2 CCS must invoice the Supplier for the Management Levy and the Supplier must pay it using the process in DPS Schedule 5 (Management Levy and Information).

4.3 All Charges and the Management Levy:

(a) exclude VAT, which is payable on provision of a valid VAT invoice; and (b) include all costs connected with the Supply of Deliverables.

4.4 The Buyer must pay the Supplier the Charges within 30 days of receipt by the Buyer of a valid, undisputed invoice, in cleared funds using the payment method and details stated in the Order Form.

4.5 A Supplier invoice is only valid if it:

- (a) includes all appropriate references including the Contract reference number and other details reasonably requested by the Buyer;
- (b) includes a detailed breakdown of Delivered Deliverables and Milestone(s) (if any); and
- (c) does not include any Management Levy (the Supplier must not charge the Buyer in any way for the Management Levy).

4.6 The Buyer must accept and process for payment an undisputed Electronic Invoice received from the Supplier.

4.7 The Buyer may retain or set-off payment of any amount owed to it by the Supplier if notice and reasons are provided.

4.8 The Supplier must ensure that all Subcontractors are paid, in full, within 30 days of receipt of a valid, undisputed invoice. If this does not happen, CCS or the Buyer can publish the details of the late payment or non-payment.

4.9 If CCS or the Buyer can get more favourable commercial terms for the supply at cost of any materials, goods or services used by the Supplier to provide the Deliverables, then CCS or the Buyer may require the Supplier to replace its existing commercial terms with the more favourable terms offered for the relevant items.

4.10 If CCS or the Buyer uses Clause 4.9 then the DPS Pricing (and where applicable, the Charges) must be reduced by an agreed amount by using the Variation Procedure.

4.11 The Supplier has no right of set-off, counterclaim, discount or abatement unless they are ordered to do so by a court.

5. The buyer's obligations to the supplier

5.1 If Supplier Non-Performance arises from an Authority Cause:

- (a) neither CCS or the Buyer can terminate a Contract under Clause 10.4.1;
- (b) the Supplier is entitled to reasonable and proven additional expenses and to relief from liability and Deduction under this Contract;
- (c) the Supplier is entitled to additional time needed to make the Delivery; and (d) the Supplier cannot suspend the ongoing supply of Deliverables.

5.2 Clause 5.1 only applies if the Supplier:

- (a) gives notice to the Party responsible for the Authority Cause within 10 Working Days of becoming aware;
- (b) demonstrates that the Supplier Non-Performance would not have occurred but for the Authority Cause; and
- (c) mitigated the impact of the Authority Cause.

6. Record keeping and reporting

6.1 The Supplier must attend Progress Meetings with the Buyer and provide Progress Reports when specified in the Order Form.

6.2 The Supplier must keep and maintain full and accurate records and accounts on everything to do with the Contract:

- (a) during the Contract Period;
- (b) for 7 years after the End Date; and (c) in accordance with UK GDPR, including but not limited to the records and accounts stated in the definition of Audit in Joint Schedule 1.

6.3 The Relevant Authority or an Auditor can Audit the Supplier.

6.4 During an Audit, the Supplier must:

Core Terms - DPS

- (a) allow the Relevant Authority or any Auditor access to their premises to verify all contract accounts and records of everything to do with the Contract and provide copies for an Audit; and
 - (b) provide information to the Relevant Authority or to the Auditor and reasonable co-operation at their request.
- 6.5 Where the Audit of the Supplier is carried out by an Auditor, the Auditor shall be entitled to share any information obtained during the Audit with the Relevant Authority.
- 6.6 If the Supplier is not providing any of the Deliverables, or is unable to provide them, it must immediately:
 - (a) tell the Relevant Authority and give reasons;
 - (b) propose corrective action; and
 - (c) provide a deadline for completing the corrective action.
- 6.7 The Supplier must provide CCS with a Self Audit Certificate supported by an audit report at the end of each Contract Year. The report must contain:
 - (a) the methodology of the review;
 - (b) the sampling techniques applied; (c) details of any issues; and (d) any remedial action taken.
- 6.8 The Self Audit Certificate must be completed and signed by an auditor or senior member of the Supplier's management team that is qualified in either a relevant audit or financial discipline.

7. Supplier staff

- 7.1 The Supplier Staff involved in the performance of each Contract must:
 - (a) be appropriately trained and qualified;
 - (b) be vetted using Good Industry Practice and the Security Policy; and
 - (c) comply with all conduct requirements when on the Buyer's Premises.
- 7.2 Where a Buyer decides one of the Supplier's Staff is not suitable to work on a contract, the Supplier must replace them with a suitably qualified alternative.
- 7.3 If requested, the Supplier must replace any person whose acts or omissions have caused the Supplier to breach Clause 27.
- 7.4 The Supplier must provide a list of Supplier Staff needing to access the Buyer's Premises and say why access is required.

- 7.5 The Supplier indemnifies CCS and the Buyer against all claims brought by any person employed by the Supplier caused by an act or omission of the Supplier or any Supplier Staff.

8. Rights and protection

- 8.1 The Supplier warrants and represents that:

- (a) it has full capacity and authority to enter into and to perform each Contract;
- (b) each Contract is executed by its authorised representative;
- (c) it is a legally valid and existing organisation incorporated in the place it was formed;
- (d) there are no known legal or regulatory actions or investigations before any court, administrative body or arbitration tribunal pending or threatened against it or its Affiliates that might affect its ability to perform each Contract;
- (e) it maintains all necessary rights, authorisations, licences and consents to perform its obligations under each Contract;
- (f) it does not have any contractual obligations which are likely to have a material adverse effect on its ability to perform each Contract;
- (g) it is not impacted by an Insolvency Event; and (h) it will comply with each Order Contract.

- 8.2 The warranties and representations in Clauses 2.10 and 8.1 are repeated each time the Supplier provides Deliverables under the Contract.

- 8.3 The Supplier indemnifies both CCS and every Buyer against each of the following:

- (a) wilful misconduct of the Supplier, Subcontractor and Supplier Staff that impacts the Contract; and (b) non-payment by the Supplier of any Tax or National Insurance.

- 8.4 All claims indemnified under this Contract must use Clause 26.

- 8.5 The description of any provision of this Contract as a warranty does not prevent CCS or a Buyer from exercising any termination right that it may have for breach of that clause by the Supplier.

- 8.6 If the Supplier becomes aware of a representation or warranty that becomes untrue or misleading, it must immediately notify CCS and every Buyer.

- 8.7 All third party warranties and indemnities covering the Deliverables must be assigned for the Buyer's benefit by the Supplier.

9. Intellectual Property Rights (IPRs)

- 9.1 Each Party keeps ownership of its own Existing IPRs. The Supplier gives the Buyer a non-exclusive, perpetual, royalty-free, irrevocable, transferable worldwide licence to use, change and sub-license the Supplier's Existing IPR to enable it to both:
- (a) receive and use the Deliverables; and
 - (b) make use of the deliverables provided by a Replacement Supplier.
- 9.2 Any New IPR created under a Contract is owned by the Buyer. The Buyer gives the Supplier a licence to use any Existing IPRs and New IPRs for the purpose of fulfilling its obligations during the Contract Period.
- 9.3 Where a Party acquires ownership of IPRs incorrectly under this Contract it must do everything reasonably necessary to complete a transfer assigning them in writing to the other Party on request and at its own cost.
- 9.4 Neither Party has the right to use the other Party's IPRs, including any use of the other Party's names, logos or trademarks, except as provided in Clause 9 or otherwise agreed in writing.
- 9.5 If there is an IPR Claim, the Supplier indemnifies CCS and each Buyer against all losses, damages, costs or expenses (including professional fees and fines) incurred as a result.
- 9.6 If an IPR Claim is made or anticipated the Supplier must at its own expense and the Buyer's sole option, either:
- (a) obtain for CCS and the Buyer the rights in Clause 9.1 and 9.2 without infringing any third party IPR; or
 - (b) replace or modify the relevant item with substitutes that do not infringe IPR without adversely affecting the functionality or performance of the Deliverables.
- 9.7 In spite of any other provisions of a Contract and for the avoidance of doubt, award of a Contract by the Buyer and placement of any contract task under it does not constitute an authorisation by the Crown under Sections 55 and 56 of the Patents Act 1977 or Section 12 of the Registered Designs Act 1949. The Supplier acknowledges that any authorisation by the Buyer under its statutory powers must be expressly provided in writing, with reference to the acts authorised and the specific IPR involved.

10. Ending the contract or any subcontract

10.1 Contract Period

- 10.1.1 The Contract takes effect on the Start Date and ends on the End Date or earlier if required by Law.

10.1.2 The Relevant Authority can extend the Contract for the Extension Period by giving the Supplier no less than 3 Months' written notice before the Contract expires.

10.2 Ending the contract without a reason

10.2.1 CCS has the right to terminate the DPS Contract at any time without reason by giving the Supplier at least 30 days' notice.

10.2.2 Each Buyer has the right to terminate their Order Contract at any time without reason by giving the Supplier not less than 90 days' written notice.

10.3 Rectification plan process

10.3.1 If there is a Default, the Relevant Authority may, without limiting its other rights, request that the Supplier provide a Rectification Plan.

10.3.2 When the Relevant Authority receives a requested Rectification Plan it can either:

- (a) reject the Rectification Plan or revised Rectification Plan, giving reasons; or
- (b) accept the Rectification Plan or revised Rectification Plan (without limiting its rights) and the Supplier must immediately start work on the actions in the Rectification Plan at its own cost, unless agreed otherwise by the Parties.

10.3.3 Where the Rectification Plan or revised Rectification Plan is rejected, the Relevant Authority:

- (a) must give reasonable grounds for its decision; and
- (b) may request that the Supplier provides a revised Rectification Plan within 5 Working Days.

10.3.4 If the Relevant Authority rejects any Rectification Plan, including any revised Rectification Plan, the Relevant Authority does not have to request a revised Rectification Plan before exercising its right to terminate its Contract under Clause 10.4.3(a).

10.4 When CCS or the buyer can end a contract

10.4.1 If any of the following events happen, the Relevant Authority has the right to immediately terminate its Contract by issuing a Termination Notice to the Supplier:

- (a) there is a Supplier Insolvency Event;
- (b) there is a Default that is not corrected in line with an accepted Rectification Plan;
- (c) the Supplier does not provide a Rectification Plan within 10 days of the request;
- (d) there is any material Default of the Contract;
- (e) there is any material Default of any Joint Controller Agreement relating to any Contract;

Core Terms - DPS

- (f) there is a Default of Clauses 2.10, 9, 14, 15, 27, 32 or DPS Schedule 9 (Cyber Essentials) (where applicable) relating to any Contract;
- (g) there is a consistent repeated failure to meet the Performance Indicators in DPS Schedule 4 (DPS Management);
- (h) there is a Change of Control of the Supplier which is not pre-approved by the Relevant Authority in writing;
- (i) if the Relevant Authority discovers that the Supplier was in one of the situations in 57 (1) or 57(2) of the Regulations at the time the Contract was awarded; or
- (j) the Supplier or its Affiliates embarrass or bring CCS or the Buyer into disrepute or diminish the public trust in them.

10.4.2 CCS may terminate the DPS Contract if a Buyer terminates an Order Contract for any of the reasons listed in Clause 10.4.1.

10.4.3 If any of the following non-fault based events happen, the Relevant Authority has the right to immediately terminate its Contract by issuing a Termination Notice to the Supplier:

- (a) the Relevant Authority rejects a Rectification Plan;
- (b) there is a Variation which cannot be agreed using Clause 24 (Changing the contract) or resolved using Clause 34 (Resolving disputes);
- (c) if there is a declaration of ineffectiveness in respect of any Variation; or (d) any of the events in 73 (1) (a) or (c) of the Regulations happen.

10.5 When the supplier can end the contract

The Supplier can issue a Reminder Notice if the Buyer does not pay an undisputed invoice on time. The Supplier can terminate an Order Contract if the Buyer fails to pay an undisputed invoiced sum due and worth over 10% of the annual Contract Value within 30 days of the date of the Reminder Notice.

10.6 What happens if the contract ends

10.6.1 Where a Party terminates a Contract under any of Clauses 10.2.1, 10.2.2, 10.4.1, 10.4.2, 10.4.3, 10.5 or 20.2 or a Contract expires all of the following apply:

- (a) The Buyer's payment obligations under the terminated Contract stop immediately.
- (b) Accumulated rights of the Parties are not affected.
- (c) The Supplier must promptly repay to the Buyer any and all Charges the Buyer has paid in advance in respect of Deliverables not provided by the Supplier as at the End Date.
- (d) The Supplier must promptly delete or return the Government Data except where required to retain copies by Law.
- (e) The Supplier must promptly return any of CCS or the Buyer's property provided under the terminated Contract.

Core Terms - DPS

- (f) The Supplier must, at no cost to CCS or the Buyer, co-operate fully in the handover and reprocurement (including to a Replacement Supplier).

10.6.2 In addition to the consequences of termination listed in Clause 10.6.1, where the Relevant Authority terminates a Contract under Clause 10.4.1 the Supplier is also responsible for the Relevant Authority's reasonable costs of procuring Replacement Deliverables for the rest of the Contract Period.

10.6.3 In addition to the consequences of termination listed in Clause 10.6.1, if either the Relevant Authority terminates a Contract under Clause 10.2.1 or 10.2.2 or a Supplier terminates an Order Contract under Clause 10.5:

- (a) the Buyer must promptly pay all outstanding Charges incurred to the Supplier; and
- (b) the Buyer must pay the Supplier reasonable committed and unavoidable Losses as long as the Supplier provides a fully itemised and costed schedule with evidence - the maximum value of this payment is limited to the total sum payable to the Supplier if the Contract had not been terminated.

10.6.4 In addition to the consequences of termination listed in Clause 10.6.1, where a Party terminates under Clause 20.2 each Party must cover its own Losses.

10.6.5 The following Clauses survive the termination or expiry of each Contract: 3.2.10, 4.2, 6, 7.5, 9, 11, 12.2, 14, 15, 16, 17, 18, 31.3, 34, 35 and any Clauses and Schedules which are expressly or by implication intended to continue.

10.7 Partially ending and suspending the contract

10.7.1 Where CCS has the right to terminate the DPS Contract it can suspend the Supplier's ability to accept Orders (for any period) and the Supplier cannot enter into any new Order Contracts during this period. If this happens, the Supplier must still meet its obligations under any existing Order Contracts that have already been signed.

10.7.2 Where CCS has the right to terminate a DPS Contract it is entitled to terminate all or part of it.

10.7.3 Where the Buyer has the right to terminate an Order Contract it can terminate or suspend (for any period), all or part of it. If the Buyer suspends a Contract it can provide the Deliverables itself or buy them from a third party.

10.7.4 The Relevant Authority can only partially terminate or suspend a Contract if the remaining parts of that Contract can still be used to effectively deliver the intended purpose.

10.7.5 The Parties must agree any necessary Variation required by Clause 10.7 using the Variation Procedure, but the Supplier may not either:

Core Terms - DPS

- (a) reject the Variation; or
- (b) increase the Charges, except where the right to partial termination is under Clause 10.2.

10.7.6 The Buyer can still use other rights available, or subsequently available to it if it acts on its rights under Clause 10.7.

10.8 When subcontracts can be ended

At the Buyer's request, the Supplier must terminate any Subcontracts in any of the following events:

- (a) there is a Change of Control of a Subcontractor which is not pre-approved by the Relevant Authority in writing;
- (b) the acts or omissions of the Subcontractor have caused or materially contributed to a right of termination under Clause 10.4; or
- (c) a Subcontractor or its Affiliates embarrasses or brings into disrepute or diminishes the public trust in the Relevant Authority.

11. How much you can be held responsible for

11.1 Each Party's total aggregate liability in each Contract Year under this DPS Contract (whether in tort, contract or otherwise) is no more than £1,000,000.

11.2 Each Party's total aggregate liability in each Contract Year under each Order Contract (whether in tort, contract or otherwise) is no more than one hundred and twenty five percent (125%) of the Estimated Yearly Charges unless specified in the Order Form.

11.3 No Party is liable to the other for:

- (a) any indirect Losses; or
- (b) Loss of profits, turnover, savings, business opportunities or damage to goodwill (in each case whether direct or indirect).

11.4 In spite of Clause 11.1 and 11.2, neither Party limits or excludes any of the following:

- (a) its liability for death or personal injury caused by its negligence, or that of its employees, agents or Subcontractors;
- (b) its liability for bribery or fraud or fraudulent misrepresentation by it or its employees;
- (c) any liability that cannot be excluded or limited by Law;
- (d) its obligation to pay the required Management Levy or Default Management Levy.

11.5 In spite of Clauses 11.1 and 11.2, the Supplier does not limit or exclude its liability for any indemnity given under Clauses 7.5, 8.3(b), 9.5, 31.3 or Order Schedule 2 (Staff Transfer) of a Contract.

Core Terms - DPS

- 11.6 In spite of Clauses 11.1, 11.2 but subject to Clauses 11.3 and 11.4, the Supplier's aggregate liability in each and any Contract Year under each Contract under Clause 14.8 shall in no event exceed the Data Protection Liability Cap.
- 11.7 Each Party must use all reasonable endeavours to mitigate any Loss or damage which it suffers under or in connection with each Contract, including any indemnities.
- 11.8 When calculating the Supplier's liability under Clause 11.1 or 11.2 the following items will not be taken into consideration:
- (a) Deductions; and
 - (b) any items specified in Clauses 11.5 or 11.6.
- 11.9 If more than one Supplier is party to a Contract, each Supplier Party is jointly and severally liable for their obligations under that Contract.

12. Obeying the law

- 12.1 The Supplier must use reasonable endeavours to comply with the provisions of Joint Schedule 5 (Corporate Social Responsibility).
- 12.2 To the extent that it arises as a result of a Default by the Supplier, the Supplier indemnifies the Relevant Authority against any fine or penalty incurred by the Relevant Authority pursuant to Law and any costs incurred by the Relevant Authority in defending any proceedings which result in such fine or penalty.
- 12.3 The Supplier must appoint a Compliance Officer who must be responsible for ensuring that the Supplier complies with Law, Clause 12.1 and Clauses 27 to 32.

13. Insurance

The Supplier must, at its own cost, obtain and maintain the Required Insurances in Joint Schedule 3 (Insurance Requirements) and any Additional Insurances in the Order Form.

14. Data protection

- 14.1 The Supplier must process Personal Data and ensure that Supplier Staff process Personal Data only in accordance with Joint Schedule 11 (Processing Data).
- 14.2 The Supplier must not remove any ownership or security notices in or relating to the Government Data.
- 14.3 The Supplier must make accessible back-ups of all Government Data, stored in an agreed off-site location and send the Buyer copies every 6 Months.

Core Terms - DPS

14.4 The Supplier must ensure that any Supplier system holding any Government Data, including back-up data, is a secure system that complies with the Security Policy and any applicable Security Management Plan.

14.5 If at any time the Supplier suspects or has reason to believe that the Government Data provided under a Contract is corrupted, lost or sufficiently degraded, then the Supplier must notify the Relevant Authority and immediately suggest remedial action.

14.6 If the Government Data is corrupted, lost or sufficiently degraded so as to be unusable the Relevant Authority may either or both:

- (a) tell the Supplier to restore or get restored Government Data as soon as practical but no later than 5 Working Days from the date that the Relevant Authority receives notice, or the Supplier finds out about the issue, whichever is earlier; and/or
- (b) restore the Government Data itself or using a third party.

14.7 The Supplier must pay each Party's reasonable costs of complying with Clause 14.6 unless CCS or the Buyer is at fault.

14.8 The Supplier:

- (a) must provide the Relevant Authority with all Government Data in an agreed open format within 10 Working Days of a written request;
- (b) must have documented processes to guarantee prompt availability of Government Data if the Supplier stops trading;
- (c) must securely destroy all Storage Media that has held Government Data at the end of life of that media using Good Industry Practice;
- (d) securely erase all Government Data and any copies it holds when asked to do so by CCS or the Buyer unless required by Law to retain it; and
- (e) indemnifies CCS and each Buyer against any and all Losses incurred if the Supplier breaches Clause 14 and any Data Protection Legislation.

15. What you must keep confidential

15.1 Each Party must:

- (a) keep all Confidential Information it receives confidential and secure;
- (b) except as expressly set out in the Contract at Clauses 15.2 to 15.4 or elsewhere in the Contract, not disclose, use or exploit the Disclosing Party's Confidential Information without the Disclosing Party's prior written consent; and

Core Terms - DPS

- (c) immediately notify the Disclosing Party if it suspects unauthorised access, copying, use or disclosure of the Confidential Information.

15.2 In spite of Clause 15.1, a Party may disclose Confidential Information which it receives from the Disclosing Party in any of the following instances:

- (a) where disclosure is required by applicable Law or by a court with the relevant jurisdiction if, to the extent not prohibited by Law, the Recipient Party notifies the Disclosing Party of the full circumstances, the affected Confidential Information and extent of the disclosure;
- (b) if the Recipient Party already had the information without obligation of confidentiality before it was disclosed by the Disclosing Party;
- (c) if the information was given to it by a third party without obligation of confidentiality;
- (d) if the information was in the public domain at the time of the disclosure;
- (e) if the information was independently developed without access to the Disclosing Party's Confidential Information;
- (f) on a confidential basis, to its auditors;
- (g) on a confidential basis, to its professional advisers on a need-to-know basis; or
- (h) to the Serious Fraud Office where the Recipient Party has reasonable grounds to believe that the Disclosing Party is involved in activity that may be a criminal offence under the Bribery Act 2010.

15.3 In spite of Clause 15.1, the Supplier may disclose Confidential Information on a confidential basis to Supplier Staff on a need-to-know basis to allow the Supplier to meet its obligations under the Contract. The Supplier Staff must enter into a direct confidentiality agreement with the Relevant Authority at its request.

15.4 In spite of Clause 15.1, CCS or the Buyer may disclose Confidential Information in any of the following cases:

- (a) on a confidential basis to the employees, agents, consultants and contractors of CCS or the Buyer;
- (b) on a confidential basis to any other Central Government Body, any successor body to a Central Government Body or any company that CCS or the Buyer transfers or proposes to transfer all or any part of its business to;
- (c) if CCS or the Buyer (acting reasonably) considers disclosure necessary or appropriate to carry out its public functions;
- (d) where requested by Parliament; or (e) under Clauses 4.7 and 16.

15.5 For the purposes of Clauses 15.2 to 15.4 references to disclosure on a confidential basis means disclosure under a confidentiality agreement or arrangement including terms as strict as those required in Clause 15.

15.6 Transparency Information is not Confidential Information.

15.7 The Supplier must not make any press announcement or publicise the Contracts or any part of them in any way, without the prior written consent of the Relevant Authority and must take all reasonable steps to ensure that Supplier Staff do not either.

16. When you can share information

16.1 The Supplier must tell the Relevant Authority within 48 hours if it receives a Request For Information.

16.2 Within five (5) Working Days of the Buyer's request the Supplier must give CCS and each Buyer full cooperation and information needed so the Buyer can:

- (a) publish the Transparency Information;
- (b) comply with any Freedom of Information Act (FOIA) request; and/or (c) comply with any Environmental Information Regulations (EIR) request.

16.3 The Relevant Authority may talk to the Supplier to help it decide whether to publish information under Clause 16. However, the extent, content and format of the disclosure is the Relevant Authority's decision in its absolute discretion.

17. Invalid parts of the contract

If any part of a Contract is prohibited by Law or judged by a court to be unlawful, void or unenforceable, it must be read as if it was removed from that Contract as much as required and rendered ineffective as far as possible without affecting the rest of the Contract, whether it is valid or enforceable.

18. No other terms apply

The provisions incorporated into each Contract are the entire agreement between the Parties. The Contract replaces all previous statements, agreements and any course of dealings made between the Parties, whether written or oral, in relation to its subject matter. No other provisions apply.

19. Other people's rights in a contract

No third parties may use the Contracts (Rights of Third Parties) Act 1999 (CRTPA) to enforce any term of the Contract unless stated (referring to CRTPA) in the Contract. This does not affect third party rights and remedies that exist independently from CRTPA.

20. Circumstances beyond your control

20.1 Any Party affected by a Force Majeure Event is excused from performing its obligations under a Contract while the inability to perform continues, if it both:

- (a) provides a Force Majeure Notice to the other Party; and
- (b) uses all reasonable measures practical to reduce the impact of the Force Majeure Event.

20.2 Either Party can partially or fully terminate the affected Contract if the provision of the Deliverables is materially affected by a Force Majeure Event which lasts for 90 days continuously.

21. Relationships created by the contract

No Contract creates a partnership, joint venture or employment relationship. The Supplier must represent themselves accordingly and ensure others do so.

22. Giving up contract rights

A partial or full waiver or relaxation of the terms of a Contract is only valid if it is stated to be a waiver in writing to the other Party.

23. Transferring responsibilities

- 23.1 The Supplier cannot assign, novate or transfer a Contract or any part of a Contract without the Relevant Authority's written consent.
- 23.2 The Relevant Authority can assign, novate or transfer its Contract or any part of it to any Central Government Body, public or private sector body which performs the functions of the Relevant Authority.
- 23.3 When CCS or the Buyer uses its rights under Clause 23.2 the Supplier must enter into a novation agreement in the form that CCS or the Buyer specifies.
- 23.4 The Supplier can terminate a Contract novated under Clause 23.2 to a private sector body that is experiencing an Insolvency Event.
- 23.5 The Supplier remains responsible for all acts and omissions of the Supplier Staff as if they were its own.
- 23.6 If CCS or the Buyer asks the Supplier for details about Subcontractors, the Supplier must provide details of Subcontractors at all levels of the supply chain including:
- (a) their name;
 - (b) the scope of their appointment; and
 - (c) the duration of their appointment.

24. Changing the contract

24.1 Either Party can request a Variation which is only effective if agreed in writing and signed by both Parties.

24.2 The Supplier must provide an Impact Assessment either:

- (a) with the Variation Form, where the Supplier requests the Variation; or
- (b) within the time limits included in a Variation Form requested by CCS or the Buyer.

24.3 If the Variation cannot be agreed or resolved by the Parties, CCS or the Buyer can either:

- (a) agree that the Contract continues without the Variation; or
- (b) terminate the affected Contract, unless in the case of an Order Contract, the Supplier has already provided part or all of the provision of the Deliverables, or where the Supplier can show evidence of substantial work being carried out to provide them; or
- (c) refer the Dispute to be resolved using Clause 34 (Resolving Disputes).

24.4 CCS and the Buyer are not required to accept a Variation request made by the Supplier.

24.5 If there is a General Change in Law, the Supplier must bear the risk of the change and is not entitled to ask for an increase to the DPS Pricing or the Charges.

24.6 If there is a Specific Change in Law or one is likely to happen during the Contract Period the Supplier must give CCS and the Buyer notice of the likely effects of the changes as soon as reasonably practical. They must also say if they think any Variation is needed either to the Deliverables, DPS Pricing or a Contract and provide evidence:

- (a) that the Supplier has kept costs as low as possible, including in Subcontractor costs; and
- (b) of how it has affected the Supplier's costs.

24.7 Any change in the DPS Pricing or relief from the Supplier's obligations because of a Specific Change in Law must be implemented using Clauses 24.1 to 24.4.

24.8 For 101(5) of the Regulations, if the Court declares any Variation ineffective, the Parties agree that their mutual rights and obligations will be regulated by the terms of the Contract as they existed immediately prior to that Variation and as if the Parties had never entered into that Variation.

25. How to communicate about the contract

25.1 All notices under the Contract must be in writing and are considered effective on the Working Day of delivery as long as they are delivered before 5:00pm on a Working Day. Otherwise the notice is effective

on the next Working Day. An email is effective at 9:00am on the first Working Day after sending unless an error message is received.

25.2 Notices to CCS must be sent to the CCS Authorised Representative's address or email address indicated on the Platform.

25.3 Notices to the Buyer must be sent to the Buyer Authorised Representative's address or email address in the Order Form.

25.4 This Clause does not apply to the service of legal proceedings or any documents in any legal action, arbitration or dispute resolution.

26. Dealing with claims

26.1 If a Beneficiary is notified of a Claim then it must notify the Indemnifier as soon as reasonably practical and no later than 10 Working Days.

26.2 At the Indemnifier's cost the Beneficiary must both:

- (a) allow the Indemnifier to conduct all negotiations and proceedings to do with a Claim; and
- (b) give the Indemnifier reasonable assistance with the claim if requested.

26.3 The Beneficiary must not make admissions about the Claim without the prior written consent of the Indemnifier which can not be unreasonably withheld or delayed.

26.4 The Indemnifier must consider and defend the Claim diligently using competent legal advisors and in a way that does not damage the Beneficiary's reputation.

26.5 The Indemnifier must not settle or compromise any Claim without the Beneficiary's prior written consent which it must not unreasonably withhold or delay.

26.6 Each Beneficiary must take all reasonable steps to minimise and mitigate any losses that it suffers because of the Claim.

26.7 If the Indemnifier pays the Beneficiary money under an indemnity and the Beneficiary later recovers money which is directly related to the Claim, the Beneficiary must immediately repay the Indemnifier the lesser of either:

- (a) the sum recovered minus any legitimate amount spent by the Beneficiary when recovering this money; or
- (b) the amount the Indemnifier paid the Beneficiary for the Claim.

27. Preventing fraud, bribery and corruption

27.1 The Supplier must not during any Contract Period:

- (a) commit a Prohibited Act or any other criminal offence in the Regulations 57(1) and 57(2); or
- (b) do or allow anything which would cause CCS or the Buyer, including any of their employees, consultants, contractors, Subcontractors or agents to breach any of the Relevant Requirements or incur any liability under them.

27.2 The Supplier must during the Contract Period:

- (a) create, maintain and enforce adequate policies and procedures to ensure it complies with the Relevant Requirements to prevent a Prohibited Act and require its Subcontractors to do the same;
- (b) keep full records to show it has complied with its obligations under Clause 27 and give copies to CCS or the Buyer on request; and
- (c) if required by the Relevant Authority, within 20 Working Days of the Start Date of the relevant Contract, and then annually, certify in writing to the Relevant Authority, that they have complied with Clause 27, including compliance of Supplier Staff, and provide reasonable supporting evidence of this on request, including its policies and procedures.

27.3 The Supplier must immediately notify CCS and the Buyer if it becomes aware of any breach of Clauses 27.1 or 27.2 or has any reason to think that it, or any of the Supplier Staff, has either:

- (a) been investigated or prosecuted for an alleged Prohibited Act;
- (b) been debarred, suspended, proposed for suspension or debarment, or is otherwise ineligible to take part in procurement programmes or contracts because of a Prohibited Act by any government department or agency;
- (c) received a request or demand for any undue financial or other advantage of any kind related to a Contract; or
- (d) suspected that any person or Party directly or indirectly related to a Contract has committed or attempted to commit a Prohibited Act.

27.4 If the Supplier notifies CCS or the Buyer as required by Clause 27.3, the Supplier must respond promptly to their further enquiries, co-operate with any investigation and allow the Audit of any books, records and relevant documentation.

27.5 In any notice the Supplier gives under Clause 27.3 it must specify the:

- (a) Prohibited Act;
- (b) identity of the Party who it thinks has committed the Prohibited Act; and
- (c) action it has decided to take.

28. Equality, diversity and human rights

28.1 The Supplier must follow all applicable equality Law when they perform their obligations under the Contract, including:

- (a) protections against discrimination on the grounds of race, sex, gender reassignment, religion or belief, disability, sexual orientation, pregnancy, maternity, age or otherwise; and
- (b) any other requirements and instructions which CCS or the Buyer reasonably imposes related to equality Law.

28.2 The Supplier must take all necessary steps, and inform CCS or the Buyer of the steps taken, to prevent anything that is considered to be unlawful discrimination by any court or tribunal, or the Equality and Human Rights Commission (or any successor organisation) when working on a Contract.

29. Health and safety

29.1 The Supplier must perform its obligations meeting the requirements of:

- (a) all applicable Law regarding health and safety; and
- (b) the Buyer's current health and safety policy while at the Buyer's Premises, as provided to the Supplier.

29.2 The Supplier and the Buyer must as soon as possible notify the other of any health and safety incidents or material hazards they are aware of at the Buyer Premises that relate to the performance of a Contract.

30. Environment

30.1 When working on Site the Supplier must perform its obligations under the Buyer's current Environmental Policy, which the Buyer must provide.

30.2 The Supplier must ensure that Supplier Staff are aware of the Buyer's Environmental Policy.

31. Tax

31.1 The Supplier must not breach any Tax or social security obligations and must enter into a binding agreement to pay any late contributions due, including where applicable, any interest or any fines. CCS and the Buyer cannot terminate a Contract where the Supplier has not paid a minor Tax or social security contribution.

31.2 Where the Charges payable under a Contract with the Buyer are or are likely to exceed £5 million at any point during the relevant Contract Period, and an Occasion of Tax Non-Compliance occurs, the Supplier must notify CCS and the Buyer of it within 5 Working Days including:

Core Terms - DPS

- (a) the steps that the Supplier is taking to address the Occasion of Tax Non-Compliance and any mitigating factors that it considers relevant; and
- (b) other information relating to the Occasion of Tax Non-Compliance that CCS and the Buyer may reasonably need.

31.3 Where the Supplier or any Supplier Staff are liable to be taxed or to pay National Insurance contributions in the UK relating to payment received under an Order Contract, the Supplier must both:

- (a) comply with the Income Tax (Earnings and Pensions) Act 2003 and all other statutes and regulations relating to income tax, the Social Security Contributions and Benefits Act 1992 (including IR35) and National Insurance contributions; and
- (b) indemnify the Buyer against any Income Tax, National Insurance and social security contributions and any other liability, deduction, contribution, assessment or claim arising from or made during or after the Contract Period in connection with the provision of the Deliverables by the Supplier or any of the Supplier Staff.

31.4 If any of the Supplier Staff are Workers who receive payment relating to the Deliverables, then the Supplier must ensure that its contract with the Worker contains the following requirements:

- (a) the Buyer may, at any time during the Contract Period, request that the Worker provides information which demonstrates they comply with Clause 31.3, or why those requirements do not apply, the Buyer can specify the information the Worker must provide and the deadline for responding;
- (b) the Worker's contract may be terminated at the Buyer's request if the Worker fails to provide the information requested by the Buyer within the time specified by the Buyer;
- (c) the Worker's contract may be terminated at the Buyer's request if the Worker provides information which the Buyer considers is not good enough to demonstrate how it complies with Clause 31.3 or confirms that the Worker is not complying with those requirements; and
- (d) the Buyer may supply any information they receive from the Worker to HMRC for revenue collection and management.

32. Conflict of interest

32.1 The Supplier must take action to ensure that neither the Supplier nor the Supplier Staff are placed in the position of an actual or potential Conflict of Interest.

32.2 The Supplier must promptly notify and provide details to CCS and each Buyer if a Conflict of Interest happens or is expected to happen.

32.3 CCS and each Buyer can terminate its Contract immediately by giving notice in writing to the Supplier or take any steps it thinks are necessary where there is or may be an actual or potential Conflict of Interest.

33. Reporting a breach of the contract

33.1 As soon as it is aware of it the Supplier and Supplier Staff must report to CCS or the Buyer any actual or suspected breach of:

- (a) Law;
- (b) Clause 12.1; or
- (c) Clauses 27 to 32.

33.2 The Supplier must not retaliate against any of the Supplier Staff who in good faith reports a breach listed in Clause 33.1 to the Buyer or a Prescribed Person.

34. Resolving disputes

34.1 If there is a Dispute, the senior representatives of the Parties who have authority to settle the Dispute will, within 28 days of a written request from the other Party, meet in good faith to resolve the Dispute.

34.2 If the Dispute is not resolved at that meeting, the Parties can attempt to settle it by mediation using the Centre for Effective Dispute Resolution (CEDR) Model Mediation Procedure current at the time of the Dispute. If the Parties cannot agree on a mediator, the mediator will be nominated by CEDR. If either Party does not wish to use, or continue to use mediation, or mediation does not resolve the Dispute, the Dispute must be resolved using Clauses 34.3 to 34.5.

34.3 Unless the Relevant Authority refers the Dispute to arbitration using Clause 34.4, the Parties irrevocably agree that the courts of England and Wales have the exclusive jurisdiction to:

- (a) determine the Dispute;
- (b) grant interim remedies; and/or
- (c) grant any other provisional or protective relief.

34.4 The Supplier agrees that the Relevant Authority has the exclusive right to refer any Dispute to be finally resolved by arbitration under the London Court of International Arbitration Rules current at the time of the Dispute. There will be only one arbitrator. The seat or legal place of the arbitration will be London and the proceedings will be in English.

34.5 The Relevant Authority has the right to refer a Dispute to arbitration even if the Supplier has started or has attempted to start court proceedings under Clause 34.3, unless the Relevant Authority has agreed to the court proceedings or participated in them. Even if court proceedings have started, the Parties must do everything necessary to ensure that the court proceedings are stayed in favour of any arbitration proceedings if they are started under Clause 34.4.

34.6 The Supplier cannot suspend the performance of a Contract during any Dispute.

35. Which law applies

This Contract and any Disputes arising out of, or connected to it, are governed by English law.
