



CONTRACT FOR THE PROVISION OF BIOMASS FEEDSTOCKS INNOVATION PROGRAMME PHASE 2 TO THE DEPARTMENT FOR BUSINESS, ENERGY & INDUSTRIAL STRATEGY

This Contract is dated **25 May 2022** and is made between:-

1. **The Secretary of State for Business, Energy & Industrial Strategy (“the Authority”)** of 1 Victoria Street, London SW1H 0ET, acting as part of the Crown;

and
2. **Terravesta Farms Limited** (the “Contractor”) whose registered office is at **12 Tentercroft Street, Lincoln, LN5 7DB**

INTRODUCTION

- (A) On 20 December 2021 the Authority issued an invitation to tender for the provision of **Phase 2 of the Biomass Feedstocks Innovation Programme** including in this the specification, a copy of which is set out in Schedule 1 (the “Authority’s Specification”).
- (B) In response the Contractor submitted a proposal dated 14 February 2022 and entitled **“Optimising Miscanthus Establishment through improved mechanisation and data capture to meet Net Zero targets (OMENZ)”** explaining how it would provide the services a copy of which is set out in Schedule 2 (the “Proposal”).

The parties agree as follows:

1. SUPPLY OF SERVICES AND PRICE

In consideration of payment by the Authority to the Contractor of the sum of **£3,349,996.59 (three million, three hundred and forty-nine thousand, nine hundred and ninety-six pounds and fifty-nine pence)** exclusive of Value Added Tax (the “Contract Price”) and in accordance with (a) **Schedule 1** – the Authority’s Specification; (b) **Schedule 2** – the Proposal; (c) **Schedule 3** – the Project Plan and Finance table; (d) **Schedule 4** – the Authority’s Standard Terms and Conditions of Contract for Supplies/Services, including amendments for Phase 2 (the “Standard Terms (as amended)” - a copy of which were issued by the Authority with the Invitation to Tender) and; (e) **Schedule 5** – the Correspondence, the Contractor shall provide the Services described in the Specification and the Proposal to the Authority.

2. COMMENCEMENT AND CONTINUATION



This contract shall commence on **25 May 2022** and subject to any provisions for earlier termination contained in the Standard Terms (as amended) end on **31 March 2025**.

3. TERMS AND CONDITIONS

- 3.1 The Standard Terms (as amended) for Phase 2 shall form part of this Contract.
- 3.2 The Contractor's Standard Terms and Conditions of business shall not apply to this Contract.
- 3.3 This Contract is formed of these clauses and the Schedules hereto. Any other attachments are provided for information purposes only and are not intended to be legally binding. In the event of any conflict or inconsistency, the documents prevail in the following order:
 - a) these clauses
 - b) the Standard Terms (as amended)
 - c) the Authority's Specification
 - d) the Project Plan and Finance Table
 - e) the Proposal

4. CONTRACTOR'S OBLIGATIONS

- 4.1 Where the Contractor is supplying goods to the Authority these shall be delivered to the Authority in full compliance with the Specification and shall be of satisfactory quality and fit for purpose. Where the Contractor is performing services for the Authority it shall do so in accordance with the Specification and exercise reasonable skill and care.

5. MANAGEMENT AND COMMUNICATIONS

- 5.1 The Contractor shall perform the Services under the direction of the Authority.
- 5.2 Any direction by the Authority may be given by **[REDACTED]** (the "Contract Manager") who is an officer in the Authority's Science and Innovation for Climate and Energy, 1 Victoria Street London SW1H 0ET, Email: bioenergy@beis.gov.uk or such other person as is notified by the Authority to the Contractor in writing.
- 5.3 The Contractor appoints **[REDACTED]** to be the Contractor's first point of contact for this Contract. All queries to the Contractor from the Authority's Contract Manager shall initially be addressed to the Contractor's first point of contact.



- 5.4 The Contractor's first point of contact and the Contract Manager shall meet as often as either the Contractor or the Authority may require to review the Contractor's performance of the Contract.

6. INVOICES AND PAYMENT

- 6.1 Subject to the Contractor providing the Services to the Authority in accordance with this Contract and submitting invoice/s to the Contract Manager in the manner reasonably required by the Contract Manager payment will be made by the Authority to the Contractor in accordance with (as referred to in Condition 11 of the Standard Terms (as amended))
- 6.2 As per the Biomass Feedstocks Innovation Programme Phase 2 outcome letter to the Contractor, dated 28 March 2022 (Schedule 5), the Authority will pay reasonable and eligible costs incurred for seasonal dependent project activities, subject to a cap equivalent of 5% of the contract value, completed before the full execution of this contract.

7. TRANSPARENCY

- 7.1 The Authority is required to publish information about this contract through the Governments Transparency website, Contracts Finder.

The Authority's decision not to publish full details of the contract does not however preclude it publishing such information in the future (subject to applicable redactions) and the Authority may be required to disclose such information under the Freedom of Information Act 2000, the Environmental Information Regulations 2004 (EIR) or other legal requirement. In such cases, the Authority would need to consider disclosure in the context of the particular circumstances of the request or requirement concerned.
