

# **Brockwell Park Winter Season Commercial Events Concession Contract – Expression of Interest (EOI)**

For nearly 300 years Lambeth has had a long history of hosting events, across its parks and open spaces. From decadent public concerts at Vauxhall Pleasure Gardens in the 18<sup>th</sup> century to the annual Lambeth Country Show in Brockwell Park taking place since 1974.

The London Borough of Lambeth is now inviting expressions of interest from Potential Providers who are keen to submit a tender proposal to create and operate a series of festive winter lights themed night events combined with the option to hold an environmentally friendly and sustainable fireworks event on Brockwell Park, London SE24 9BJ.

The period of the contract is for 32 months from 31 May 2021 to 31 January 2024, with the possibility of a further 24 months extension to 31 January 2026 (three years plus one plus one).

London Borough of Lambeth is looking for a suitably qualified Provider or suitable consortia to plan, promote and produce Winter Festive and Christmas themed events annually with an option to hold a sustainable Fireworks, in return for paying Lambeth Council a contract venue fee.

#### The Potential Provider will be expected to:

- Create a diverse and creative events proposal
- Source and manage talent, attractions and food and beverage traders
- Promote the event, pricing and ticketing arrangements, marketing, securing sponsorship, press relations
- Procure and supervise all attractions, traders, suppliers, sub-contractors
- Organise all logistical and operational matters to do with the events, including the management of health & safety in line with government guidance and local public health and environmental protection on site
- Attend all multi-agency safety and operational group meetings relevant to the event planning
- Manage all aspects of staffing and securing the events
- Secure all necessary permissions and carry out all stakeholder consultations, with the reasonable assistance of Lambeth Council
- Provide budget management, accounting, cash security, payment of suppliers, and receipt of all incomes.

The Potential Provider must be able to demonstrate that they have suitable knowledge and experience of delivering major outdoor commercial events, with a consistent track record in Service Delivery. Additionally, they must demonstrate that they have the capacity, financial ability and knowledge within the market to sustain a commercially

viable events programme over the entire period of the contract. All events should be a high-quality experience, with high standards of health & safety, sustainability, and customer service.

### **Suggested Operational Days**

The number of operational event days will be limited to 50 event days per annum allowing for the follow proposed dates:

- Optional Fireworks Night event: Friday 5<sup>th</sup> November 2021
- Christmas Lights events: Saturday 6<sup>th</sup> November Sunday 2<sup>nd</sup> January 2022
- Corporate and Private Hire options for each event day and New Year's Night Friday 31<sup>st</sup> December 2021

#### **Proposed Capacities**

- Optional Fireworks Night: up to 40,000
- Christmas Lights: up to 1,500 7500 per day depending on the site layout and the footprint of the Christmas lights walking route across the park.
- Corporate and Private Hire: 114 based on the private hire options such as igloo structures which can be increased year on year to reflect demand.

### **Proposed Operating Times**

4pm to 10pm (with exception of NYE)

An option for Corporate & Private Hire structures for Lunch and Dinner packages

### **Proposed Build and Break**

Load in Date: 11th October 2021

Load Out Date: 16<sup>th</sup> January 2022

Working hours: 8am – 8pm

Due to the operational and logistical requirements between each event day, and to allow the ground to recover, it will need two closed days each week.

London Borough of Lambeth will seek to keep the Park open during the daytime to minimise disruption to park users. (With the exception on any closed or sectioned off areas for back of house event operations and corporate private hire dining).

- 4. How much you could potentially pay Lambeth Council in fees each year to put on the events.
- 5. Lambeth would apply for premises licence and planning permission, however your input into this planning would be needed.
