- 1 PAYMENTS
- 1.1 Following receipt of a valid invoice from the Supplier, the Buyer shall pay the Supplier the Charges, together with any VAT or other applicable taxes, in full in cleared funds, without set off, counterclaim, variation, or deduction of any kind, irrespective of the performance or loss or availability of the Deliverables. Provided the valid invoice is received no later than the relevant Invoice Date set out in the table of Charges below, the Buyer shall pay by the respective Due Dates set out in in the table of Charges below, or otherwise within 30 days of receipt of invoice.
- 1.2 Time is of the essence in relation to all payments due.

1.3 Following receipt of a valid invoice no later than the relevant Invoice Date as set out in the table of Charges below, if any Charges or other sum due under this Call-off Contract is not paid on or before the Due Date, interest shall be payable on the overdue sum from the Due Date until the date of payment at the rate of 3% per annum over Barclays Bank Base Rate.

#### 2. DEFAULT

- 2.1 Each of the following shall constitute an event of default by the Buyer ("Event of Default"):
  - a) subject to 1.1, any payment due to the Supplier under this Payment Agreement remains unpaid for 14 days after its due date;
  - b) the Customer is in breach of any obligation under this Payment Agreement other than its payment obligations and such breach continues for 14 days or more following Supplier's written notification;
  - c) the Customer is deemed for the purposes of any applicable law to be unable to pay its debts as they fall due.
  - d) the Customer becomes or is declared insolvent, has a liquidator, receiver or administrative receiver appointed or passes a resolution for winding up (otherwise than for the purpose of a scheme of solvent amalgamation or reconstruction) or if a court having proper authority makes an order to that effect;
  - e) the Customer enters into administration, is the subject of an administration order or proposes to or enters into any voluntary arrangement with its creditors.
  - f) a material change of the ownership or control of the Customer (to that existing at the date hereof) without the prior written consent of the Supplier and Assignee.
  - g) the Customer is (or is likely to be) dissolved, deconstituted, reconstituted, abolished or replaced by any statutory or other successor
  - h) an occurrence of any of the events specified in paragraphs a) to g) above in relation to any guarantor or parent company of the Customer.
  - i) The Customer has offices, investments, or activities in countries or regions which are the subject of sanctions or embargoes imposed by any of the US OFAC, the EU, the UK government or any other relevant sanctions authority.
