The Department of Health (acting on behalf of the Business Services Authority) ("the Authority") is pleased to invite your organisation to tender for the Supply Chain Future Operating Model (FOM) – Logistics Services.

Background

The NHS spends approximately £5.7bn on goods annually. Rather than centrally purchased, this spend is distributed across many autonomous organisations that buy from a variety of suppliers in a variety of ways.

To promote efficient purchasing and delivery of goods, the NHS entered into a national supply chain arrangement with DHL in 2006. This arrangement consolidated NHS Logistics and much of NHS Procurement and Supply Agency into one organisation, the NHS Supply Chain. While there was no mandation of individual trusts to use the service, it sought to achieve aggregation of demand through compelling prices and service delivery.

The Contract was extended in 2015 and is due to expire in September 2018. As part of the extension agreement, the Authority has the contractual right to transfer certain pre-defined areas of the Contract from DHL and switch delivery to a new service provider. It also provided the Authority with greater transparency around the operation of the service and commitments to achieve £300 million of savings by September 2018.

The Future Operating Model envisages disaggregating the service into the below five areas:

The Requirement

The procurement exercise is for the delivery of Logistics Services, which will be a component of the Future Operating Model being procured to replace the current service.

The procurement is specifically to provide the following logistics services:

- 1. Management of existing logistics services including transport, inventory management and site facilities at the named sites in II2.3 as the principal leaseholder.
- 2. Provision of an in-bound logistics and inter-depot trunking service at a site to be determined by the successful bidder in consultation with the Authority.
- 3. Support for expansion of logistics services to meet projected demand increases (details regarding current volumes and projections will be available within the data room)
- 4. Provision for home and community delivery services for continence products and potentially other products on behalf of the Authority; to residential homes, care homes, domestic premises and any NHS-funded providers of community health care services.
