





- Ridge and Partners LLP will deliver site inspections, surveys, and risk assessments (referred to below as 'certificates or 'certification') across indoor LTS sites, thus providing the mandatory legal protection required to operate physical testing sites. A further breakdown is provided below in Section 2.

The Ridge will provide professional services required to co-ordinate and appoint subcontractors to undertake statutory inspections of the existing indoor test sites as per the tracker schedule which is correct on 4<sup>th</sup> March 2022.

Reports will be reviewed by a competent person from within Ridge and Partners LLP and uploaded to the Kahootz database.

#### 5 Constraints on how the Consultant Provides the Service

#### Inspections:

We have allowed for the works to be carried out during normal working hours (Monday to Friday, 7.00am - 5.30pm).

- We assume onsite parking will be available for our operatives to use free of charge where available.
- 2. We assume we will always have unrestricted access to all required areas.
- 3. We assume that the inspections are to be for the COVID test areas only. No allowance has been made to test any associated circuitry not related to the COVID test areas.
- 4. We assume Ridge will create a programme with our input and arrange access to all sites.
- 5. We have made no allowance to fix any wiring items of any kind.
- 6. We have made no allowance for any decoration works after our works are completed.
- 7. We have made no allowance for any works of any kind other than specifically noted in this quotation.
- 8. Any non-conformities will be reported after works have completed and will be subject to further quotation.
- 9. We have made no allowance for any builder's work, in particular:
  - a. Formation of chases within the building fabric
  - b. Fire Stopping
  - c. Holes above 50mm
  - d. Making good

#### **Asbestos Inspections:**

- We have allowed a contingency sum for 6no bulk samples per building; again, these are difficult to estimate without knowledge of the individual buildings. Actual number of samples taken shall be charged.
- 2. We have not allowed for specialist access equipment based on the assumption that these will not be required.
- 3. Please provide floor plans showing areas to be surveyed.

It is agreed that all intellectual property and knowledge in respect of the Covid 19 testing programme as operated by UKHSA and as used to deliver this contract, remains the property of UKHSA and cannot be shared with any third party or subsidiary of Ridge and Partners LLP without the prior and explicit written permission from the UKHSA commercial team as responsible for this contract.
