## Materials and Substances with Health and/or Safety Hazards

Highways

#### Covid-19 pandemic

The Contractor is to ensure they are protecting their workforce and minimising the risk of spread of infection. The health and safety requirements of any construction activity must not be compromised. If an activity cannot be undertaken in line with social distancing being implemented, or by exception, safely, without risk and mitigating measures then it shall not take place.

#### **Asbestos**

If Asbestos Containing Materials are found during construction, all works shall stop immediately and the area is to be isolated from the workforce. The Contractor must inform the Principal Contractor, who will then implement the necessary emergency response procedures in line with the Company policy.

Under no circumstances will the Contractor attempt to remove any Asbestos Containing Materials without prior consent from the overseeing organisation.

#### Lead

Scope of Works are unlikely to encounter lead. Consider existing paint coatings to bridge beams.

#### Tar based pavement/surfacing

Risk of Tar in lower pavement layers. Has testing been carried out. PAK Tests are indicative only and need confirming by laboratory testing. Has Tar been confirmed? Is further testing required? Tar is unlikely to be encountered in surface course. If Tar has been identified locations should be clearly marked on the schemes drawings.

Leptospirosis/Weil's disease / Psittacosis Contact with highway drainage during resurfacing works potential risk of Weil's disease. The Contractor is to ensure sufficient welfare facilities are in place at all times. All appropriate PPE must be worn at all times.

Any instances of illness / sickness on site should be reported to the Site Manager/Principal Contractor Representative immediately and the persons affected should seek medical advice.
