   Broxap warrants that it will perform the services quoted for with reasonable skill and care.

  1.8 Decorative coatings will default to our standard polyester powder coating with a dry film thickness (dft) of 60µm to c.120 µm. A duplex coating, to potentially extend the lifeexpectancy (especially in areas of high salinity or pollution), is available if required for a supplemental fee.

### 3. Design and Loadings

- 3.1 Broxap has intellectual property for any concepts/design proposals submitted as a part of this or any subsequent proposal. Such sketches, visuals or drawings illustrating our proposed intent are commercially sensitive, confidential information, issued purely for the purposes of illustrating our offer. These should not be released to any third party or used for any other purpose.
- 3.2 The Customer acknowledges and agrees that designs shall remain the exclusive property of the Broxap and that these are protected by the applicable UK Design Registration Laws. Branded maintenance plates/labels are included on all products installed.

- 3.3 Preliminary designs from this proposal, may not consider exposed areas (e.g. coastal or hillside) or locations of high altitude (150 metres above sea level).
- 3.4 Approval drawings will be issued electronically in 'pdf' format for approval and comment(s) and suitably redrafted up to first revision (minor changes).
- 3.5 Drawings issued by Broxap for approval by the customer or its agent, shall be returned prior to Broxap's commencement of fabrication/workshop drawings and/or production of materials. "Approval" means that drawings will have been examined and approved by the Customer, with regard to dimensions/details, technical specification/content and areas relating to the interfaces to the work of others.
- 3.6 Where design remains the contractual responsibility of others and/or where our offer makes use of standard products and/or manufacturing techniques, the Customer will be responsible for understanding our offer and for ensuring that any non-compliances receive the necessary consent from the approving body. Any requirements to bring non-compliances up to specification may demand a revised price or contract variation.

It is the responsibility of others to ensure the loadings are acceptable for the existing wall. We recommend the services of a local/council Structural Engineer are sought. Broxap can undertake structural checks if required (Epoa).
- 3.10 In the event whereby information necessary to the contract is required, formal Requests for Information (RFI's) shall be issued. Responses to RFI's should be made within five working days to avoid impact programme dates.
- 3.11 We assume that access for end user cleaning and maintenance, as may be required, will have been risked assessed and considered by the Customer.
- 3.12 Whilst our designs may be subject to an independent structural engineering review, requirements for fully written structural calculations, building warrant applications (for S.E.R.) and/or other specialist building works processes (e.g. planning permission local authority fees, building regulation fees) are excluded.

### 4. Electrical Interfaces and Assumptions

- 4.1 Structural hollow sections utilised within any structures quoted may provide 'passive provision' containment for services by others, it is assumed that any third party trade will provide their own structure mounted containment.
- 4.2 No allowance is made for draw wires or access hatches.
- 4.3 For any electrical services offered or quoted for by Broxap, our electrician will employ the use of black or white plastic conduit, which will be mounted externally to the structural members.
- 4.4 Any stated inclusions for electrical hardware installation that is included within our offer, shall be installed to BS 7671, with all wiring connections terminated.
- 4.5 It is assumed that suitable enabling works, to bring an adequate quantity of incoming feeds into the envelope of the structure, is carried out by others.

- 4.6 Mains connection and certifying shall be by others.
- 4.7 We assume that any requirements for lighting control shall be a "switched supply" from existing services. No consideration for timers, dusk to dawn sensors or emergency lighting is made (unless stated as inclusions).

### . Ground Conditions, Foundations and Drainage

- 5.1 Unless clearly itemised within our offer, foundations are to be designed and constructed by others;
- 5.2 Pad foundations are assumed to be typically ~200mm (no more than 300mm) from FFL to top of foundation. The top of any foundation is to be exposed prior to installation.

- 5.8 Making good the finished ground level/floor surface(s) after installation is the responsibility of others.
- 5.9 Engineer's check of existing or new sub-structure(s), that are not a part of Broxap's work scope, is to be by others.
- 5.10 If commissioned to design and/or construct foundations, these shall be clearly stated within our quotation. It is assumed that a minimum ground bearing pressure of 100kN/m<sup>2</sup> can be achieved in the existing substrata and that excavations shall be free from services, contaminated and/or hazardous materials, and shall be a "soft dig".

- 6.1 The Customer is to provide safe consolidated access to the area of works, it is assumed that free parking is available for Broxap's operatives' vehicles.

- 6.3 The ground should be flat and level and capable of remaining so after bad weather.

- 6.5 For cost effectiveness, Broxap's default transport charges exclude mechanical offloading (unless stated as an inclusion). It is assumed that the Customer will provide assistance with mechanical offloading where this is required. Where Broxap's installation services have been included and where reasonable to do so, goods shall be unloaded by the site team via manual handling techniques.
- 6.6 No allowances are made for a fall arrest system on Broxap's delivery vehicles where fall protection lorry bags are a site/customer requirement, we assume that these will be arranged by others prior to each of our deliveries.
- 6.7 No consideration has been made within any delivery charges for providing FORS accredited transportation.

with the local authority including any road closures and permits; including barriers at interfaces with pedestrians.

- 6.11 It is assumed that installation shall be achieved via the use of manual handling techniques, via access towers, where it is deemed to be safe to do so, in line with Broxap's RAMS. Should a mechanical lift be mandatory or alternative installation arrangements be required, the Customer is to outline its preferences for cost consideration and inclusion.
- 6.12 Access for any plant, craneage and any other access or equipment is required to areas of Broxap's work.
- 6.13 It is assumed that any cranes/plant can be sited within 20m of the structure and that any necessary ground preparation to accommodate/protect the plant will be by others.
- 6.14 Any allowances for cranes are defined within our offer. If stated as a "Contract Lift" price, this shall include crane, the driver, the lift plan and a supervisor (i.e. a suitably experienced Appointed Person "AP"). Cranes may also be provided on a "Crane & Driver (only)" rate, with the Customer accepting responsibility for the "AP".

### 7. Attendances, Site Works & Installation Operatives

- 7.1 Our offer to carry out the works assumes that the following facilities will be provided by The Customer without charge:
   a) Barriers and fencing to protect labour and plant from deep excavations
  - b) Edge protection/debris netting to all stairs, landings and floor edges/perimeters
  - c) Adequate storage and lay-down areas (floor or surface protection, if needed, by others)
  - d) Statutory safety, health and welfare facilities
  - e) 110 volt single-phase power supply
  - f) Attendance for weekend and overtime working
  - g) Safe means of access to working space
  - h) Use of rubbish skips
  - i) Permission to case study the installation
  - j) A 'hot desk' with power supply for Broxap Project Manager site attendances
- 7.2 All Broxap site staff will have the appropriate certification and proof of training in their relevant trades and plant handling, including CSCS cards etc.
- 7.3 SSSTS trained staff can be supplied to supervise Broxap's operatives on site as part of this offer. No consideration is given to SMSTS trained staff within this proposal. Prices for SMSTS trained staff are available on request.
- 7.4 Broxap will provide Method Statements and Risk Assessments relevant to the installation.
- 7.5 Unless noted otherwise, all steelwork will be erected to the tolerances stated within the "National Structural Steelwork Specification for Building Construction (5<sup>th</sup> Edition)".
- 7.6 The finished installation will be wiped to remove excess, visible surface dirt/grease prior to our handover. A return visit for a specialist clean can be procured supplemental to this offer (£poa).
- 7.7 Upon completion of our works and on hand over to the Customer, the nominated representative shall be required to sign a handover sheet with any relevant comments.
- 7.8 Our tender is based upon all works being carried out in one continuous visit, per area/run. Mobilisation costs for further site visits may be required should the customer's programme necessitate this.
- 7.9 The offer is based on normal working hours (i.e. Mon Fri, 08:00 to 17:00 excluding public holidays) and requirements for task lighting have not been considered.
- 7.10 Broxap cannot be held responsible for delays caused by adverse weather conditions or "Inclement Weather".
- 7.11 The Customer is to be responsible for any restricted/exclusion or collapse zones for plant, site personnel and pedestrians during our installation.
- 7.12 Protection of the installation shall be the responsibility of Broxap until the contracted works are signed off and handed over to the Customer. Wherever practical, damage shall be cosmetically repaired locally by us during/post installation. For repairs required post-handover we will provide a quotation for acceptance prior to undertaking.
- 7.13 The Customer shall provide all reasonable out of hours security to protect our works/equipment/material.
- 7.14 No allowance has been made for participation in any contractor specific occupational health scheme.

### 8. Offer and Acceptance

- 8.1 This offer, together with these assumptions, shall be deemed to have been accepted by the customer by way of their ordering the selected goods and/or services tendered.
- 8.2 Any sub-contract or purchase order arising from acceptance of this offer, in the absence of a recognised form of Contract, shall be based on Broxap own Terms and Conditions of Sale.

- 9. Credit Rating, Payment and Valuations
- 9.1 Dependent on the final contract sum, approved credit status with Broxap's underwriter and programme phasing requirement, staged payments may be required.
- 9.2 Payments must be made for design and engineering before work commences on site.
- 9.3 Should, for whatever reason (other than a delay by Broxap), the confirmed delivery date of the goods be delayed, we reserve the right to invoice for goods and services undertaken to date, and payment will become due for the work(s) completed and invoiced.
- 9.4 Payments must be made for offsite materials, which shall be "vested" to the Customer and insured. Storage charges may apply; goods that have been vested and paid for shall be 'stored' by Broxap for 14 days without charge.
- 9.5 Unless agreed otherwise, the payment for the Goods and/or Services supplied shall be due 30 days from the date on which the Goods and/or Services were delivered or deemed to be delivered and the time for payment shall be of the essence.
- 9.6 No payments shall be deemed to have been received until Broxap has received cleared funds. All payments payable to the Seller under the Contract shall become due immediately on termination of this Contract despite any other provision.
- 9.7 The Customer shall not be entitled to withhold payment of any amount due to the Seller by reason of any disputed claim by the Buyer in connection with the Contract.
- 9.8 If the Customer fails to pay Broxap any sum due pursuant to the Contract the Customer will be liable to pay interest to the Seller on such sum from the due date for payment. Broxap is also entitled, at its discretion, to levy an additional charge which may be incurred by Broxap as a result of pursuing the Customer's payment.

### 10. Programme

- 10.1 Broxap agrees to carry out the Works in accordance with a mutually agreed Programme or Activity Schedule, subject to the timely receipt of all necessary information from the Customer.
- 10.2 Availability of certain materials is subject to manufacturer's stock levels and production dates. Broxap agrees at the date of acceptance to advise the Customer of any materials which are not available or have extended lead times which might affect the Customer's programme.
- 10.3 Any preliminary programme supplied in advance of any potential arrangement is for information and is subject to contract.
- 10.4 Broxap will not accept any clauses containing "time is of the essence" in relation to delivery.

### 11. Bill of Quantities, Compensation Events and Variations

- 11.1 Notwithstanding any Bill of Quantities, Specifications and/or the Drawings supplied by the Customer, the content and descriptions/specifications within this offer should be referred to as our (counter) offer.
- 11.2 So as to assist with any tender exercises or cost comparisons, Form of Tender and/or Bill of Quantities supplied by the Customer and completed by Broxap, are submitted for convenience and quick referral. This proposal shall take precedence.
- 11.3 Any changes to the quantities, specification, methods and/or sequence of construction provided by the Customer or any of its consultants after the date of acceptance may result in additional costs being incurred and the associated costs being charged as a variation.
- 11.4 Discoveries made either during any phase, which were not previously made aware to us, may trigger a Compensation Event, where Broxap will look to recover the loss thereof.
- 11.4 Written acceptance of extra costs and/or variations, from an authorised representative of the customer, must be received by Broxap before our agreement to undertake the additional works.

### 12. Bonds

- 12.1 No allowance has been made for providing any Bond.

### 14. Liquidated Ascertained Damages and Other Risk

14.1 This offer assumes that Liquidated Ascertained Damages shall be "Nil" for any contract between us. The offer does not consider any other 'risk'.



- 14.2 Where L.A.D.'s must be included these shall be limited to a maximum of 5% of our total Contract sum (for example; 1% per week for a maximum of 5 weeks). In this instance, this offer may be subject to review so as to consider such 'risk'.
- 14.3 Any other Contra-charges levied to Broxap shall be limited to 5% of our final contract sum.

#### 15. Retention

- 15.1 Allowances for a Retention amount, either as a percentage or monetary value, have not been considered within this proposal.
- 15.2 The initial defects liability period, of 12 months following our practical completion, is covered by Broxap standard Warranty by guarantee, which negates the need for the administration and cost of a retention percentage.
- 15.3 Where Retentions are to be included these shall be limited to 3% of the contract sum and shall not apply to any order less than £50,000.As no provision is made for retention, our offer sum will be subject to a review.
- 15.4 Retention release dates, where applicable, shall be triggered by Broxap's practical completion date for the first payment and 12 months' thereafter for the balance. "Practical completion" is determined by the installation being signed-off by a site representative.

### 16. Form of Contract

- 16.1 Any Order arising from acceptance of this offer to be based upon a recognised form of contract, in the absence of which, Broxap's Letter of Authority, together with these conditions supported by our Terms and Conditions of Sale (In that order), shall govern any contract.
- 16.2 Broxap's standard Terms and Conditions of sale are available to view on our website <u>www.broxap.com</u>. Posted hard copies or an electronic PDF can be supplied on request, should you require an enlarged-print copy please specify.

#### 17. Warranty Agreements

- 17.1 Our current insurance policy contains a statement that our Insurers will indemnify us for claims arising out of liability assumed under the standard Collateral Warranties published by the British Property Federation and the Construction Industry Council. Modifications to these standard forms of warranty will require a review prior to acceptance, which is subject to a nominal review fee (typ. £750).
- 17.2 Collateral Warranties can be agreed to in principle, subject to comment by Broxap's insurer. Subrogation clauses will not be accepted.

#### 18. Law

18.1 These General Terms & Conditions and any agreement and/or any other matter whatsoever arising from or in connection with this offer shall be governed by English Law and the jurisdiction of the English Courts shall apply.
