# **Alumni Platform- Redacted Statement of Requirements**

#### Introduction

The requirement is to procure a COTS Alumni platform service to allow active engagement with and management of Alumni of Defence Academy (DefAc) and Royal College Defence Studies (RCDS) professional military education courses.

# **Background**

This is a new requirement; there is no existing provision. It will be an internet-based, digital platform used by the Defence Academy and RCDS in Shrivenham and London respectively.

# Requirement

The requirement is for a professional alumni platform by end Jul 23, to provide a managed alumni service for Defence Academy and RCDS comprising:

- A web-based landing page providing general news and information
- A private members portal allowing:
  - Member only information
  - Education, research and other products to be 'pushed' to members
  - Host video content (and live stream events desirable)
  - Segmentation of course cohorts and ability to target communications to selected alumni
  - The ability for Members to connect with each other (send messages) and contribute content
- The chosen system will maximise automation of membership applications
- The system needs to provide management information/data analytics
- The system must meet all relevant statutory requirements, Defence requirements and
  Industry standards including Data Protection and Cyber security.
- The supplier will provide real-time technical support to the platform as agreed with the authority
- The supplier will provide continued professional, sector leading advice and guidance to ensure the operation of the platform, its content and outputs are informed by best practice and optimised for success.

### **Deliverables**

The supplier will provide the platform and all relevant support and technical services as agreed with the Authority.

The supplier will provide technical support to the platform as agreed with the authority. Office hours support Monday – Friday 0900-1600 will be the basic requirement.

The supplier will be required to provide training for MOD Alumni management staff using the system on an as required basis (estimated to less than 10 per annum TBC).

#### **Duration**

The initial contract would be for 36 months + option of 12 months extension in accordance with G Cloud 13 Terms and Conditions.

### **Milestones**

The platform is required to be developed and ready for use by the Authority and Alumni before end of July 2023 in order to capture the current course alumni prior to departure.

#### Location

Not Applicable. The system will be internet-based.


