ISG Central Services Limited, ISG Interior Services Group UK Limited, ISG Fit Out Limited, ISG Engineering Services Limited, ISG UK Retail Limited, ISG Retail Limited, ISG Construction Limited and ISG Jackson Limited - in Administration (together 'the Companies')

I write further to my appointment, together with as joint administrators ("the Administrators") to the Companies on 20 September 2024. The appointments were made by the High Court under the provisions of Paragraph 12(1)(b) of Schedule B1 to the Insolvency Act 1986.

The Administrators act as agents of the Companies without personal liability whether arising pursuant to the Insolvency Act 1986 or otherwise howsoever.

Prior to the Administrators' appointment, the Companies used the Oracle Aconex Cloud Services System ("Aconex") as its collaboration tool with clients for delivery of work on its contracts. Aconex (amongst other things) provided a single environment for holding project related information and data.

The Administrators have been in discussions with the Ministry of Justice ("MoJ" or "You") regarding the preservation of data and information contained and held in Aconex relating to MoJ projects.

We understand that you now wish pursue the 'third option' by Oracle which would entail:

- an MoJ employee to be created as a user under the ISG Ltd organisation in Aconex;
- the 71 projects detailed at Appendix I to this letter ("the Projects") being assigned to the MoJ by Oracle;
- MoJ becoming the Paying Organisation and ISG Ltd would becoming the Non-Paying Organisation (as defined in the Oracle Aconex Cloud Services System Project Assignment agreement)

Agreement to EY handling information

The Administrators will use reasonable endeavours to assist with the assignment of the Projects. However, no guarantee is offered by the Companies or Administrators that this will be achieved.

In order for the Administrators to facilitate the assignment of Projects assignment a former ISG employee is required to change the invitation setting on each of the Projects and invite an EY employee to each of the Projects. Following this, the Administrators will have sufficient access rights on the Projects to invite an MoJ employee to the Projects. We have held extensive discussions with Oracle on the matter who have advised that this is a viable route to enabling an assignment of the data relating to the Projects held

However, please be advised that this is not a process that has been performed by the Administrators since their appointment over the Companies, therefore we cannot guarantee the successful outcome of this process. For the avoidance of doubt we will not be engaging any third party to assist.

Limited resources are now available to the Administrators given the passage of time since communicating our original deadline to the MoJ of 29 November 2024 for any decisions on Aconex data. The time required to process the assignment of the Projects archives is uncertain; however, we estimate that this process could take up to two working weeks.

Acknowledgement of the terms of the transfer of information

We have set out below the basis in which the Administrators are able to assist with the assignment of information relating to the Projects.

The Administrators require payment of an Assignment Fee of **Contract Sectors** relating to costs (including the cost payable to the former ISG employee) associated with enabling the assignment of the Projects to MoJ. The Assignment Fee will be invoiced on receipt of this countersigned agreement.

Upon countersigning this agreement, you acknowledge and agree to the following terms:

- 1. To make immediate payment of the Assignment Fee upon completion of an MoJ employee being invited to each of the Projects by the Administrators;
- You acknowledge that in the event of it not being possible to invite an MoJ employee to certain projects for reasons outside of the Administrators' control, the Assignment Fee shall remain payable;
- 3. You acknowledge that neither the Companies nor the Administrators are responsible for any breach of confidentiality, security or other obligations (contractual or statutory) (if any) in respect of the data and information arising from the process of the assignment to MoJ;
- 4. You acknowledge that the Companies and the Administrators cease to have any responsibility or obligations for the data and information immediately on completion of the assignment;
- 5. You acknowledge that to facilitate the assignment of relevant data and information relating to the Projects, both the Administrators and a former ISG employee will be required to access the Projects and change invitation settings on Aconex to facilitate the process;
- 6. You consent to an MoJ employee being invited to each of the Projects by the Administrators;
- 7. You will be responsible for any ongoing costs payable to Oracle following the completion of the Oracle Aconex Cloud Services System Project Assignment agreement;
- 8. The Companies and the Administrators shall not be liable for any loss or damage of any kind whatever, consequential or otherwise arising out of or due to the transfer of data and information in connection with this agreement.

The Companies (acting by the Administrators) shall be entitled to cease providing support if:

- You fail to make payment of the Assignment Fee; or
- If it is no longer able to provide support, for example, as a result of a password reset not being possible on the former employee's ISG or Aconex accounts.

In the event that the assignment of the Projects cannot be completed for any reason, we will credit and refund to You any costs that have not been incurred.



Any agreement created by acceptance of this letter shall be governed by and construed in accordance with the laws of England and you hereby submit to the non-exclusive jurisdiction of the Courts of England in relation thereto.

Should you not wish to proceed with the assignment of the Projects, You are aware that the platform will be de-commissioned and all project related data will be deleted by Oracle.
