1. With reference to the contract dated 1 August 2019, as most recently amended by the letter dated 30 April 2020, both Parties have in principle agreed to the following variations to the Contract:

Section 1 – Form of Contract, 4. Financial Limit

DELETE: “Payments under this Contract shall not, in any circumstances, exceed **£12,732,370** exclusive of any government tax, if applicable”

INSERT: Payments under this Contract shall not, in any circumstances, exceed **£13,732,370** exclusive of any government tax, if applicable.

Section 3 – Terms of Reference

Add: “Addendum to the Terms of Reference (COVID-19 and Vaccine Acceptability Focus: Jan-Mar 21)”

Section 5 – Schedule of Payments

Add: “Addendum to the Schedule of Payments (Jan-Mar ’21)” **(REDACTED)**

2. This amendment relates to:

- a programme refocus in response to Covid -19, as outlined in Contract Amendment 1, and now expanding on those activities as outlined in the updated Addendum to the Terms of Reference. **(REDACTED)**
- The overall contract value is increasing by up to £1 million for the Covid -19 related activities taking place between January 2021 and March 2021.
- The Addendum to the Schedule of Payments, with a budget of £1 million, reflects only the work to be carried out for the Covid -19 pivot from January 2021 – March 2021. **(REDACTED)**
