REASON

The reason for this variation is to extended the end date to 29th of November 2019. (Previous end date was 31st of October 2019).

The extension is required for two reasons.

Firstly, there was a delay of around 2 weeks before the project commenced. An interview stage was added to the procurement process as the two highest bidders had the same score after the initial written bid stage. There was also a delay of some weeks in issuing and agreeing the contract. A letter of intent was issued to the provider in order to minimise project delays.

Secondly, primary evidence collection consisting visits to 7 Local Authorities took longer than anticipated: establishing contact and arranging suitable times to hold in-person interviews with LA SEND leads and their teams proved challenging over the summer months. This caused a further delay of around 2 weeks.

This variation is to extend the duration of the contract only. The total contract value is unchanged.

SCHEDULE ONE

18th July 2019 to 31st October 2019

Final report is to be signed off on the 29th of November instead of the 31st of October.

The contract was altered to involve additional support around the settings survey as there were difficulties around recruiting participants and following up in interviews with under-represented settings in the online survey. The advisory group also agreed that based on the undertaken case studies with local authorities, the project team had reached saturation point in interviews.

Therefore, the local authority survey as originally specified in the tender was not needed, and instead, the advisory group agreed to focus the remaining resource on developing recommendations for the different value for money options, and on carrying on evidence gathering through case studies and a re-opened survey in settings that were underrepresented in the original survey.


