Terms of Business

1. Parties to the agreement

This agreement is between BiteSize Learning Ltd of 5 Grove Place, Bedford MK40 3JJ and Health Education England of Stewart House, 4th Floor, 32 Russell Square, London, WC1B 5DN.

2. Purpose of the agreement

2.1 This agreement sets out the commercial and contract terms governing the provision of training and consulting services by BiteSize Learning Ltd to Health Education England.



3. Services to be provided

3.1 The services to be provided by BiteSize Learning Ltd to Health Education England are outlined in the proposal above.

4. **Commercial terms**

- 4.1 Fees for all work by BiteSize Learning Ltd for Health Education England will be charged in accordance with the Summary of Deliverables and Fees, included in the proposal or any subsequent written amendment signed by both parties. Invoices are payable within 30 days of receipt. All fees and expenses will be subject to VAT in accordance with VAT regulations.
- 4.2 Reasonable expenses, including travel and subsistence, and goods and services purchased on the client's behalf, are charged at cost. For travel, BiteSize Learning's standard policies apply which are to use second class rail and economy class air travel within the UK and business class or equivalent for overseas travel. If travelling by private vehicle our rates will be based upon the prevailing Inland Revenue Mileage Rates, currently 45p per mile. Expenses are not charged for the virtual delivery of programmes.

5. **Cancellation and Rescheduling**

- 5.1 Cancellations made by Health Education England 20 or more working days prior to the course are subject to a £100 charge per event to cover administration. This charge is waived where the event is rescheduled within 7 days of notification of the cancellation.
- 5.2 Bookings cancelled between 10 and 19 working days prior to the date of the course will be charged at 50% of the fee.
- 5.3 The full fee will be payable if less than 10 working days' notice of cancellation is given.
- 5.4 Where a cancelled course is rescheduled within 7 days of notification of the cancellation and takes place within three months of the original event date, an amount of 50% of the charged cancellation fee will be credited towards the rescheduled course.

6. Confidentiality

6.1 All information provided to BiteSize Learning Ltd by Health Education England about its business or employees or obtained by BiteSize Learning Ltd about Health Education England, which is not already in the public domain or generally known in the industry, shall be deemed as confidential and shall not be transmitted or communicated to any third parties.

7. Intellectual Property, Ownership and Retention of Copyright

- 7.1 BiteSize Learning Ltd retains copyright in all material provided to Health Education England or otherwise generated in the course of carrying out the engagement.
- 7.2 Health Education England shall keep confidential any methodologies and technology used by BiteSize Learning Ltd to carry out an engagement.
- 7.3 All papers and documents we produce in the course of our work for you will remain our property apart from letters and reports sent to you. We retain the copyright and all intellectual property rights in all original material provided to you.



7.4 We reserve the right to destroy correspondence and other papers once we believe they need no longer be retained for legal reasons.

8. Liabilities

8.1 BiteSize Learning Ltd shall not be liable for any loss, injury or damage suffered by Health Education England, its employees or any third party as a result of any of the advice given as part of this project.

9. Changes and amendments to this contract

9.1 From time to time, both parties may by mutual agreement change and/or amend this contract. All such changes must be agreed in writing between the parties and attached to this contract as an additional appendix.

10. Termination and settlement of disputes

Either party may, at its discretion and without penalty, cancel its relationship with the other by providing one month's written notice. BiteSize Learning Ltd will then invoice Health Education England for the work carried out to that date based on the quoted rate.

- 10.1 Termination, wholly or partially, may also occur immediately either by mutual consent between the parties or as a result of written notice being sent by one party to the other as a result of serious or material breach of contract / duty.
- 10.2 Where disputes arise between the parties, both parties agree to attempt to resolve them directly by face to face discussion as a matter of urgency.

11. Governing Law and Jurisdiction

11.1 This agreement shall, at all times and in all respects be governed by the laws of England.
