1. Definitions used in the contract

2. How the contract works

- 2.1 The Supplier is eligible for the award of Order Contracts during the DPS Contract Period.
- 2.2 CCS does not guarantee the Supplier any exclusivity, quantity or value of work under the DPS Contract.
- 2.3 CCS has paid one penny to the Supplier legally to form the DPS Contract. The Supplier acknowledges this payment.
- 2.4 If the Buyer decides to buy Deliverables under the DPS Contract it must use DPS Schedule 7 (Order Procedure) and must state its requirements using DPS Schedule 6 (Order Form Template and Order Schedules). If allowed by the Regulations, the Buyer can:
 - (a) make changes to DPS Schedule 6 (Order Form Template and Order Schedules);
 - (b) create new Order Schedules;
 - (c) exclude optional template Order Schedules; and/or
 - (d) use Special Terms in the Order Form to add or change terms.

2.5 Each Order Contract:

- (a) is a separate Contract from the DPS Contract;
- (b) is between a Supplier and a Buyer;
- (c) includes Core Terms, Schedules and any other changes or items in the completed Order Form; and (d) survives the termination of the DPS Contract.
- 2.6 Where the Supplier is approached by any Other Contracting Authority requesting Deliverables or substantially similar goods or services, the Supplier must tell them about this DPS Contract before accepting their order.
- 2.7 The Supplier acknowledges it has all the information required to perform its obligations under each Contract before entering into a Contract. When information is provided by a Relevant Authority no warranty of its accuracy is given to the Supplier.
- 2.8 The Supplier will not be excused from any obligation, or be entitled to additional Costs or Charges because it failed to either:

Core Terms - DPS

- (a) verify the accuracy of the Due Diligence Information; or (b) properly perform its own adequate checks.
- 2.9 CCS and the Buyer will not be liable for errors, omissions or misrepresentation of any information.
- 2.10 The Supplier warrants and represents that all statements made and documents submitted as part of the procurement of Deliverables are and remain true and accurate.
- 2.11 An Order Contract can only be created using the electronic procedures described in the FTS Notice as required by the Regulations.
- 2.12 A Supplier can only receive Orders under the DPS Contract while it meets the basic access requirements for the DPS stated in the FTS Notice. CCS can audit whether a Supplier meets the basic access requirements at any point during the DPS Contract Period.

What needs to be delivered

3.1 All deliverables

- 3.1.1 The Supplier must provide Deliverables:
 - (a) that comply with the Specification, the DPS Application and, in relation to an Order Contract, the Order Tender (if there is one);
 - (b) to a professional standard;
 - (c) using reasonable skill and care; (d) using Good Industry Practice;
 - (e) using its own policies, processes and internal quality control measures as long as they do not conflict with the Contract; (f) on the dates agreed; and (g) that comply with Law.
- 3.1.2 The Supplier must provide Deliverables with a warranty of at least 90 days from Delivery against all obvious defects.

3.2 Goods clauses

- 3.2.1 All Goods delivered must be new, or as new if recycled, unused and of recent origin.
- 3.2.2 All manufacturer warranties covering the Goods must be assignable to the Buyer on request and for free.
- 3.2.3 The Supplier transfers ownership of the Goods on Delivery or payment for those Goods, whichever is earlier.
- 3.2.4 Risk in the Goods transfers to the Buyer on Delivery of the Goods, but remains with the Supplier if the Buyer notices damage following Delivery and lets the Supplier know within 3 Working Days of Delivery.

Core Terms - DPS

- 3.2.5 The Supplier warrants that it has full and unrestricted ownership of the Goods at the time of transfer of ownership.
- 3.2.6 The Supplier must deliver the Goods on the date and to the specified location during the Buyer's working hours.
- 3.2.7 The Supplier must provide sufficient packaging for the Goods to reach the point of Delivery safely and undamaged.
- 3.2.8 All deliveries must have a delivery note attached that specifies the order number, type and quantity of Goods.
- 3.2.9 The Supplier must provide all tools, information and instructions the Buyer needs to make use of the Goods.
- 3.2.10 The Supplier must indemnify the Buyer against the costs of any Recall of the Goods and give notice of actual or anticipated action about the Recall of the Goods.
- 3.2.11 The Buyer can cancel any order or part order of Goods which has not been Delivered. If the Buyer gives less than 14 days notice then it will pay the Supplier's reasonable and proven costs already incurred on the cancelled order as long as the Supplier takes all reasonable steps to minimise these costs.
- 3.2.12 The Supplier must at its own cost repair, replace, refund or substitute (at the Buyer's option and request) any Goods that the Buyer rejects because they do not conform with Clause 3. If the Supplier does not do this it will pay the Buyer's costs including repair or re-supply by a third party.

3.3 Services clauses

- 3.3.1 Late Delivery of the Services will be a Default of an Order Contract.
- 3.3.2 The Supplier must co-operate with the Buyer and third party suppliers on all aspects connected with the Delivery of the Services and ensure that Supplier Staff comply with any reasonable instructions.
- 3.3.3 The Supplier must at its own risk and expense provide all Supplier Equipment required to Deliver the Services.
- 3.3.4 The Supplier must allocate sufficient resources and appropriate expertise to each Contract.
- 3.3.5 The Supplier must take all reasonable care to ensure performance does not disrupt the Buyer's operations, employees or other contractors.
- 3.3.6 The Supplier must ensure all Services, and anything used to Deliver the Services, are of good quality and free from defects.

Core Terms - DPS

3.3.7 The Buyer is entitled to withhold payment for partially or undelivered Services, but doing so does not stop it from using its other rights under the Contract.

Pricing and payments

- 4.1 In exchange for the Deliverables, the Supplier must invoice the Buyer for the Charges in the Order Form.
- 4.2 CCS must invoice the Supplier for the Management Levy and the Supplier must pay it using the process in DPS Schedule 5 (Management Levy and Information).
- 4.3 All Charges and the Management Levy:
 - (a) exclude VAT, which is payable on provision of a valid VAT invoice; and (b) include all costs connected with the Supply of Deliverables.
- 4.4 The Buyer must pay the Supplier the Charges within 30 days of receipt by the Buyer of a valid, undisputed invoice, in cleared funds using the payment method and details stated in the Order Form.
- 4.5 A Supplier invoice is only valid if it:
 - (a) includes all appropriate references including the Contract reference number and other details reasonably requested by the Buyer;
 - (b) includes a detailed breakdown of Delivered Deliverables and Milestone(s) (if any); and
 - (c) does not include any Management Levy (the Supplier must not charge the Buyer in any way for the Management Levy).
- 4.6 The Buyer must accept and process for payment an undisputed Electronic Invoice received from the Supplier.
- 4.7 The Buyer may retain or set-off payment of any amount owed to it by the Supplier if notice and reasons are provided.
- 4.8 The Supplier must ensure that all Subcontractors are paid, in full, within 30 days of receipt of a valid, undisputed invoice. If this does not happen, CCS or the Buyer can publish the details of the late payment or non-payment.
- 4.9 If CCS or the Buyer can get more favourable commercial terms for the supply at cost of any materials, goods or services used by the Supplier to provide the Deliverables, then CCS or the Buyer may require the Supplier to replace its existing commercial terms with the more favourable terms offered for the relevant items.

Core Terms - DPS

- 4.10 If CCS or the Buyer uses Clause 4.9 then the DPS Pricing (and where applicable, the Charges) must be reduced by an agreed amount by using the Variation Procedure.
- 4.11 The Supplier has no right of set-off, counterclaim, discount or abatement unless they are ordered to do so by a court.

The buyer's obligations to the supplier

- 5.1 If Supplier Non-Performance arises from an Authority Cause:
 - (a) neither CCS or the Buyer can terminate a Contract under Clause 10.4.1;
 - (b) the Supplier is entitled to reasonable and proven additional expenses and to relief from liability and Deduction under this Contract;
 - (c) the Supplier is entitled to additional time needed to make the Delivery; and (d) the Supplier cannot suspend the ongoing supply of Deliverables.
- 5.2 Clause 5.1 only applies if the Supplier:

5.

- (a) gives notice to the Party responsible for the Authority Cause within 10 Working Days of becoming aware;
- (b) demonstrates that the Supplier Non-Performance would not have occurred but for the Authority Cause; and
- (c) mitigated the impact of the Authority Cause.

6. Record keeping and reporting

- 6.1 The Supplier must attend Progress Meetings with the Buyer and provide Progress Reports when specified in the Order Form.
- 6.2 The Supplier must keep and maintain full and accurate records and accounts on everything to do with the Contract:
 - (a) during the Contract Period;
 - (b) for 7 years after the End Date; and (c) in accordance with UK GDPR, including but not limited to the records and accounts stated in the definition of Audit in Joint Schedule 1.
- 6.3 The Relevant Authority or an Auditor can Audit the Supplier.
- 6.4 During an Audit, the Supplier must:

- (a) allow the Relevant Authority or any Auditor access to their premises to verify all contract accounts and records of everything to do with the Contract and provide copies for an Audit; and
- (b) provide information to the Relevant Authority or to the Auditor and reasonable co-operation at their request.
- 6.5 Where the Audit of the Supplier is carried out by an Auditor, the Auditor shall be entitled to share any information obtained during the Audit with the Relevant Authority.
- 6.6 If the Supplier is not providing any of the Deliverables, or is unable to provide them, it must immediately:
 - (a) tell the Relevant Authority and give reasons;
 - (b) propose corrective action; and
 - (c) provide a deadline for completing the corrective action.
- 6.7 The Supplier must provide CCS with a Self Audit Certificate supported by an audit report at the end of each Contract Year. The report must contain:
 - (a) the methodology of the review;
 - (b) the sampling techniques applied; (c) details of any issues; and (d) any remedial action taken.
- 6.8 The Self Audit Certificate must be completed and signed by an auditor or senior member of the Supplier's management team that is qualified in either a relevant audit or financial discipline.

7. Supplier staff

- 7.1 The Supplier Staff involved in the performance of each Contract must:
 - (a) be appropriately trained and qualified;
 - (b) be vetted using Good Industry Practice and the Security Policy; and
 - (c) comply with all conduct requirements when on the Buyer's Premises.
- 7.2 Where a Buyer decides one of the Supplier's Staff is not suitable to work on a contract, the Supplier must replace them with a suitably qualified alternative.
- 7.3 If requested, the Supplier must replace any person whose acts or omissions have caused the Supplier to breach Clause 27.
- 7.4 The Supplier must provide a list of Supplier Staff needing to access the Buyer's Premises and say why access is required.

Core Terms - DPS

7.5 The Supplier indemnifies CCS and the Buyer against all claims brought by any person employed by the Supplier caused by an act or omission of the Supplier or any Supplier Staff.

Rights and protection

- 8.1 The Supplier warrants and represents that:
 - (a) it has full capacity and authority to enter into and to perform each Contract;
 - (b) each Contract is executed by its authorised representative;
 - (c) it is a legally valid and existing organisation incorporated in the place it was formed;
 - (d) there are no known legal or regulatory actions or investigations before any court, administrative body or arbitration tribunal pending or threatened against it or its Affiliates that might affect its ability to perform each Contract;
 - (e) it maintains all necessary rights, authorisations, licences and consents to perform its obligations under each Contract;
 - (f) it does not have any contractual obligations which are likely to have a material adverse effect on its ability to perform each Contract;
 - (g) it is not impacted by an Insolvency Event; and (h) it will comply with each Order Contract.
- 8.2 The warranties and representations in Clauses 2.10 and 8.1 are repeated each time the Supplier provides Deliverables under the Contract.
- 8.3 The Supplier indemnifies both CCS and every Buyer against each of the following:
 - (a) wilful misconduct of the Supplier, Subcontractor and Supplier Staff that impacts the Contract; and (b) non-payment by the Supplier of any Tax or National Insurance.
- 8.4 All claims indemnified under this Contract must use Clause 26.
- 8.5 The description of any provision of this Contract as a warranty does not prevent CCS or a Buyer from exercising any termination right that it may have for breach of that clause by the Supplier.
- 8.6 If the Supplier becomes aware of a representation or warranty that becomes untrue or misleading, it must immediately notify CCS and every Buyer.
- 8.7 All third party warranties and indemnities covering the Deliverables must be assigned for the Buyer's benefit by the Supplier.

Core Terms - DPS

9. Intellectual Property Rights (IPRs)

- 9.1 Each Party keeps ownership of its own Existing IPRs. The Supplier gives the Buyer a non-exclusive, perpetual, royalty-free, irrevocable, transferable worldwide licence to use, change and sub-license the Supplier's Existing IPR to enable it to both:
 - (a) receive and use the Deliverables; and
 - (b) make use of the deliverables provided by a Replacement Supplier.
- 9.2 Any New IPR created under a Contract is owned by the Buyer. The Buyer gives the Supplier a licence to use any Existing IPRs and New IPRs for the purpose of fulfilling its obligations during the Contract Period.
- 9.3 Where a Party acquires ownership of IPRs incorrectly under this Contract it must do everything reasonably necessary to complete a transfer assigning them in writing to the other Party on request and at its own cost.
- 9.4 Neither Party has the right to use the other Party's IPRs, including any use of the other Party's names, logos or trademarks, except as provided in Clause 9 or otherwise agreed in writing.
- 9.5 If there is an IPR Claim, the Supplier indemnifies CCS and each Buyer against all losses, damages, costs or expenses (including professional fees and fines) incurred as a result.
- 9.6 If an IPR Claim is made or anticipated the Supplier must at its own expense and the Buyer's sole option, either:
 - (a) obtain for CCS and the Buyer the rights in Clause 9.1 and 9.2 without infringing any third party IPR; or
 - (b) replace or modify the relevant item with substitutes that do not infringe IPR without adversely affecting the functionality or performance of the Deliverables.
- 9.7 In spite of any other provisions of a Contract and for the avoidance of doubt, award of a Contract by the Buyer and placement of any contract task under it does not constitute an authorisation by the Crown under Sections 55 and 56 of the Patents Act 1977 or Section 12 of the Registered Designs Act 1949. The Supplier acknowledges that any authorisation by the Buyer under its statutory powers must be expressly provided in writing, with reference to the acts authorised and the specific IPR involved.

10. Ending the contract or any subcontract

10.1 Contract Period

10.1.1 The Contract takes effect on the Start Date and ends on the End Date or earlier if required by Law.

Core Terms - DPS

10.1.2 The Relevant Authority can extend the Contract for the Extension Period by giving the Supplier no less than 3 Months' written notice before the Contract expires.

10.2 Ending the contract without a reason

- 10.2.1 CCS has the right to terminate the DPS Contract at any time without reason by giving the Supplier at least 30 days' notice.
- 10.2.2 Each Buyer has the right to terminate their Order Contract at any time without reason by giving the Supplier not less than 90 days' written notice.

10.3 Rectification plan process

- 10.3.1 If there is a Default, the Relevant Authority may, without limiting its other rights, request that the Supplier provide a Rectification Plan.
- 10.3.2 When the Relevant Authority receives a requested Rectification Plan it can either:
 - (a) reject the Rectification Plan or revised Rectification Plan, giving reasons; or
 - (b) accept the Rectification Plan or revised Rectification Plan (without limiting its rights) and the Supplier must immediately start work on the actions in the Rectification Plan at its own cost, unless agreed otherwise by the Parties.
- 10.3.3 Where the Rectification Plan or revised Rectification Plan is rejected, the Relevant Authority:
 - (a) must give reasonable grounds for its decision; and
 - (b) may request that the Supplier provides a revised Rectification Plan within 5 Working Days.
- 10.3.4 If the Relevant Authority rejects any Rectification Plan, including any revised Rectification Plan, the Relevant Authority does not have to request a revised Rectification Plan before exercising its right to terminate its Contract under Clause 10.4.3(a).

10.4 When CCS or the buyer can end a contract

- 10.4.1 If any of the following events happen, the Relevant Authority has the right to immediately terminate its Contract by issuing a Termination Notice to the Supplier:
 - (a) there is a Supplier Insolvency Event;
 - (b) there is a Default that is not corrected in line with an accepted Rectification Plan;
 - (c) the Supplier does not provide a Rectification Plan within 10 days of the request;
 - (d) there is any material Default of the Contract;
 - (e) there is any material Default of any Joint Controller Agreement relating to any Contract;

Core Terms - DPS

- (f) there is a Default of Clauses 2.10, 9, 14, 15, 27, 32 or DPS Schedule 9 (Cyber Essentials) (where applicable) relating to any Contract;
- (g) there is a consistent repeated failure to meet the Performance Indicators in DPS Schedule 4 (DPS Management);
- (h) there is a Change of Control of the Supplier which is not pre-approved by the Relevant Authority in writing;
- (i) if the Relevant Authority discovers that the Supplier was in one of the situations in 57 (1) or 57(2) of the Regulations at the time the Contract was awarded; or
- (j) the Supplier or its Affiliates embarrass or bring CCS or the Buyer into disrepute or diminish the public trust in them.
- 10.4.2 CCS may terminate the DPS Contract if a Buyer terminates an Order Contract for any of the reasons listed in Clause 10.4.1.
- 10.4.3 If any of the following non-fault based events happen, the Relevant Authority has the right to immediately terminate its Contract by issuing a Termination Notice to the Supplier:
 - (a) the Relevant Authority rejects a Rectification Plan;
 - (b) there is a Variation which cannot be agreed using Clause 24 (Changing the contract) or resolved using Clause 34 (Resolving disputes);
 - (c) if there is a declaration of ineffectiveness in respect of any Variation; or (d) any of the events in 73 (1) (a) or (c) of the Regulations happen.

10.5 When the supplier can end the contract

The Supplier can issue a Reminder Notice if the Buyer does not pay an undisputed invoice on time. The Supplier can terminate an Order Contract if the Buyer fails to pay an undisputed invoiced sum due and worth over 10% of the annual Contract Value within 30 days of the date of the Reminder Notice.

10.6 What happens if the contract ends

- 10.6.1 Where a Party terminates a Contract under any of Clauses 10.2.1, 10.2.2, 10.4.1, 10.4.2, 10.4.3, 10.5 or 20.2 or a Contract expires all of the following apply:
 - (a) The Buyer's payment obligations under the terminated Contract stop immediately.
 - (b) Accumulated rights of the Parties are not affected.
 - (c) The Supplier must promptly repay to the Buyer any and all Charges the Buyer has paid in advance in respect of Deliverables not provided by the Supplier as at the End Date.
 - (d) The Supplier must promptly delete or return the Government Data except where required to retain copies by Law.
 - (e) The Supplier must promptly return any of CCS or the Buyer's property provided under the terminated Contract.

Core Terms - DPS

- (f) The Supplier must, at no cost to CCS or the Buyer, co-operate fully in the handover and reprocurement (including to a Replacement Supplier).
- 10.6.2 In addition to the consequences of termination listed in Clause 10.6.1, where the Relevant Authority terminates a Contract under Clause 10.4.1 the Supplier is also responsible for the Relevant Authority's reasonable costs of procuring Replacement Deliverables for the rest of the Contract Period.
- 10.6.3 In addition to the consequences of termination listed in Clause 10.6.1, if either the Relevant Authority terminates a Contract under Clause 10.2.1 or 10.2.2 or a Supplier terminates an Order Contract under Clause 10.5:
 - (a) the Buyer must promptly pay all outstanding Charges incurred to the Supplier; and
 - (b) the Buyer must pay the Supplier reasonable committed and unavoidable Losses as long as the Supplier provides a fully itemised and costed schedule with evidence the maximum value of this payment is limited to the total sum payable to the Supplier if the Contract had not been terminated.
- 10.6.4 In addition to the consequences of termination listed in Clause 10.6.1, where a Party terminates under Clause 20.2 each Party must cover its own Losses.
- 10.6.5 The following Clauses survive the termination or expiry of each Contract: 3.2.10, 4.2, 6, 7.5, 9, 11, 12.2, 14, 15, 16, 17, 18, 31.3, 34, 35 and any Clauses and Schedules which are expressly or by implication intended to continue.

10.7 Partially ending and suspending the contract

- 10.7.1 Where CCS has the right to terminate the DPS Contract it can suspend the Supplier's ability to accept Orders (for any period) and the Supplier cannot enter into any new Order Contracts during this period. If this happens, the Supplier must still meet its obligations under any existing Order Contracts that have already been signed.
- 10.7.2 Where CCS has the right to terminate a DPS Contract it is entitled to terminate all or part of it.
- 10.7.3 Where the Buyer has the right to terminate an Order Contract it can terminate or suspend (for any period), all or part of it. If the Buyer suspends a Contract it can provide the Deliverables itself or buy them from a third party.
- 10.7.4 The Relevant Authority can only partially terminate or suspend a Contract if the remaining parts of that Contract can still be used to effectively deliver the intended purpose.
- 10.7.5 The Parties must agree any necessary Variation required by Clause 10.7 using the Variation Procedure, but the Supplier may not either:

Core Terms - DPS

- (a) reject the Variation; or
- (b) increase the Charges, except where the right to partial termination is under Clause 10.2.
- 10.7.6 The Buyer can still use other rights available, or subsequently available to it if it acts on its rights under Clause 10.7.

10.8 When subcontracts can be ended

At the Buyer's request, the Supplier must terminate any Subcontracts in any of the following events:

- (a) there is a Change of Control of a Subcontractor which is not pre-approved by the Relevant Authority in writing;
- (b) the acts or omissions of the Subcontractor have caused or materially contributed to a right of termination under Clause 10.4; or
- (c) a Subcontractor or its Affiliates embarrasses or brings into disrepute or diminishes the public trust in the Relevant Authority.

How much you can be held responsible for

- 11.1 Each Party's total aggregate liability in each Contract Year under this DPS Contract (whether in tort, contract or otherwise) is no more than £1,000,000.
- 11.2 Each Party's total aggregate liability in each Contract Year under each Order Contract (whether in tort, contract or otherwise) is no more than one hundred and twenty five percent (125%) of the Estimated Yearly Charges unless specified in the Order Form.
- 11.3 No Party is liable to the other for:
 - (a) any indirect Losses; or
 - (b) Loss of profits, turnover, savings, business opportunities or damage to goodwill (in each case whether direct or indirect).
- 11.4 In spite of Clause 11.1 and 11.2, neither Party limits or excludes any of the following:
 - (a) its liability for death or personal injury caused by its negligence, or that of its employees, agents or Subcontractors;
 - (b) its liability for bribery or fraud or fraudulent misrepresentation by it or its employees;
 - (c) any liability that cannot be excluded or limited by Law;
 - (d) its obligation to pay the required Management Levy or Default Management Levy.
- 11.5 In spite of Clauses 11.1 and 11.2, the Supplier does not limit or exclude its liability for any indemnity given under Clauses 7.5, 8.3(b), 9.5, 31.3 or Order Schedule 2 (Staff Transfer) of a Contract.

Core Terms - DPS

- 11.6 In spite of Clauses 11.1, 11.2 but subject to Clauses 11.3 and 11.4, the Supplier's aggregate liability in each and any Contract Year under each Contract under Clause 14.8 shall in no event exceed the Data Protection Liability Cap.
- 11.7 Each Party must use all reasonable endeavours to mitigate any Loss or damage which it suffers under or in connection with each Contract, including any indemnities.
- 11.8 When calculating the Supplier's liability under Clause 11.1 or 11.2 the following items will not be taken into consideration:
 - (a) Deductions; and
 - (b) any items specified in Clauses 11.5 or 11.6.
- 11.9 If more than one Supplier is party to a Contract, each Supplier Party is jointly and severally liable for their obligations under that Contract.

12. Obeying the law

- 12.1 The Supplier must use reasonable endeavours to comply with the provisions of Joint Schedule 5 (Corporate Social Responsibility).
- 12.2 To the extent that it arises as a result of a Default by the Supplier, the Supplier indemnifies the Relevant Authority against any fine or penalty incurred by the Relevant Authority pursuant to Law and any costs incurred by the Relevant Authority in defending any proceedings which result in such fine or penalty.
- 12.3 The Supplier must appoint a Compliance Officer who must be responsible for ensuring that the Supplier complies with Law, Clause 12.1 and Clauses 27 to 32.

13. Insurance

The Supplier must, at its own cost, obtain and maintain the Required Insurances in Joint Schedule 3 (Insurance Requirements) and any Additional Insurances in the Order Form.

14. Data protection

- 14.1 The Supplier must process Personal Data and ensure that Supplier Staff process Personal Data only in accordance with Joint Schedule 11 (Processing Data).
- 14.2 The Supplier must not remove any ownership or security notices in or relating to the Government Data.
- 14.3 The Supplier must make accessible back-ups of all Government Data, stored in an agreed off-site location and send the Buyer copies every 6 Months.

Core Terms - DPS

- 14.4 The Supplier must ensure that any Supplier system holding any Government Data, including back-up data, is a secure system that complies with the Security Policy and any applicable Security Management Plan.
- 14.5 If at any time the Supplier suspects or has reason to believe that the Government Data provided under a Contract is corrupted, lost or sufficiently degraded, then the Supplier must notify the Relevant Authority and immediately suggest remedial action.
- 14.6 If the Government Data is corrupted, lost or sufficiently degraded so as to be unusable the Relevant Authority may either or both:
 - (a) tell the Supplier to restore or get restored Government Data as soon as practical but no later than 5 Working Days from the date that the Relevant Authority receives notice, or the Supplier finds out about the issue, whichever is earlier; and/or
 - (b) restore the Government Data itself or using a third party.
- 14.7 The Supplier must pay each Party's reasonable costs of complying with Clause 14.6 unless CCS or the Buyer is at fault.

14.8 The Supplier:

- (a) must provide the Relevant Authority with all Government Data in an agreed open format within 10 Working Days of a written request;
- (b) must have documented processes to guarantee prompt availability of Government Data if the Supplier stops trading;
- (c) must securely destroy all Storage Media that has held Government Data at the end of life of that media using Good Industry Practice;
- (d) securely erase all Government Data and any copies it holds when asked to do so by CCS or the Buyer unless required by Law to retain it; and
- (e) indemnifies CCS and each Buyer against any and all Losses incurred if the Supplier breaches Clause 14 and any Data Protection Legislation.

15. What you must keep confidential

15.1 Each Party must:

- (a) keep all Confidential Information it receives confidential and secure;
- (b) except as expressly set out in the Contract at Clauses 15.2 to 15.4 or elsewhere in the Contract, not disclose, use or exploit the Disclosing Party's Confidential Information without the Disclosing Party's prior written consent; and

Core Terms - DPS

- (c) immediately notify the Disclosing Party if it suspects unauthorised access, copying, use or disclosure of the Confidential Information.
- 15.2 In spite of Clause 15.1, a Party may disclose Confidential Information which it receives from the Disclosing Party in any of the following instances:
 - (a) where disclosure is required by applicable Law or by a court with the relevant jurisdiction if, to the extent not prohibited by Law, the Recipient Party notifies the Disclosing Party of the full circumstances, the affected Confidential Information and extent of the disclosure;
 - (b) if the Recipient Party already had the information without obligation of confidentiality before it was disclosed by the Disclosing Party;
 - (c) if the information was given to it by a third party without obligation of confidentiality;
 - (d) if the information was in the public domain at the time of the disclosure;
 - (e) if the information was independently developed without access to the Disclosing Party's Confidential Information;
 - (f) on a confidential basis, to its auditors;
 - (g) on a confidential basis, to its professional advisers on a need-to-know basis; or
 - (h) to the Serious Fraud Office where the Recipient Party has reasonable grounds to believe that the Disclosing Party is involved in activity that may be a criminal offence under the Bribery Act 2010.
- 15.3 In spite of Clause 15.1, the Supplier may disclose Confidential Information on a confidential basis to Supplier Staff on a need-to-know basis to allow the Supplier to meet its obligations under the Contract. The Supplier Staff must enter into a direct confidentiality agreement with the Relevant Authority at its request.
- 15.4 In spite of Clause 15.1, CCS or the Buyer may disclose Confidential Information in any of the following cases:
 - (a) on a confidential basis to the employees, agents, consultants and contractors of CCS or the Buyer;
 - (b) on a confidential basis to any other Central Government Body, any successor body to a Central Government Body or any company that CCS or the Buyer transfers or proposes to transfer all or any part of its business to;
 - (c) if CCS or the Buyer (acting reasonably) considers disclosure necessary or appropriate to carry out its public functions;
 - (d) where requested by Parliament; or (e) under Clauses 4.7 and 16.
- 15.5 For the purposes of Clauses 15.2 to 15.4 references to disclosure on a confidential basis means disclosure under a confidentiality agreement or arrangement including terms as strict as those required in Clause 15.
- 15.6 Transparency Information is not Confidential Information.

Core Terms - DPS

15.7 The Supplier must not make any press announcement or publicise the Contracts or any part of them in any way, without the prior written consent of the Relevant Authority and must take all reasonable steps to ensure that Supplier Staff do not either.

16. When you can share information

- 16.1 The Supplier must tell the Relevant Authority within 48 hours if it receives a Request For Information.
- 16.2 Within five (5) Working Days of the Buyer's request the Supplier must give CCS and each Buyer full cooperation and information needed so the Buyer can:
 - (a) publish the Transparency Information;
 - (b) comply with any Freedom of Information Act (FOIA) request; and/or (c) comply with any Environmental Information Regulations (EIR) request.

16.3 The Relevant Authority may talk to the Supplier to help it decide whether to publish information under Clause 16. However, the extent, content and format of the disclosure is the Relevant Authority's decision in its absolute discretion.

L7. Invalid parts of the contract

If any part of a Contract is prohibited by Law or judged by a court to be unlawful, void or unenforceable, it must be read as if it was removed from that Contract as much as required and rendered ineffective as far as possible without affecting the rest of the Contract, whether it is valid or enforceable.

18. No other terms apply

The provisions incorporated into each Contract are the entire agreement between the Parties. The Contract replaces all previous statements, agreements and any course of dealings made between the Parties, whether written or oral, in relation to its subject matter. No other provisions apply.

19. Other people's rights in a contract

No third parties may use the Contracts (Rights of Third Parties) Act 1999 (CRTPA) to enforce any term of the Contract unless stated (referring to CRTPA) in the Contract. This does not affect third party rights and remedies that exist independently from CRTPA.

20. Circumstances beyond your control

20.1 Any Party affected by a Force Majeure Event is excused from performing its obligations under a Contract while the inability to perform continues, if it both:

Core Terms - DPS

- (a) provides a Force Majeure Notice to the other Party; and
- (b) uses all reasonable measures practical to reduce the impact of the Force Majeure Event.
- 20.2 Either Party can partially or fully terminate the affected Contract if the provision of the Deliverables is materially affected by a Force Majeure Event which lasts for 90 days continuously.

21. Relationships created by the contract

No Contract creates a partnership, joint venture or employment relationship. The Supplier must represent themselves accordingly and ensure others do so.

22. Giving up contract rights

A partial or full waiver or relaxation of the terms of a Contract is only valid if it is stated to be a waiver in writing to the other Party.

23. Transferring responsibilities

- 23.1 The Supplier cannot assign, novate or transfer a Contract or any part of a Contract without the Relevant Authority's written consent.
- 23.2 The Relevant Authority can assign, novate or transfer its Contract or any part of it to any Central Government Body, public or private sector body which performs the functions of the Relevant Authority.
- 23.3 When CCS or the Buyer uses its rights under Clause 23.2 the Supplier must enter into a novation agreement in the form that CCS or the Buyer specifies.
- 23.4 The Supplier can terminate a Contract novated under Clause 23.2 to a private sector body that is experiencing an Insolvency Event.
- 23.5 The Supplier remains responsible for all acts and omissions of the Supplier Staff as if they were its own.
- 23.6 If CCS or the Buyer asks the Supplier for details about Subcontractors, the Supplier must provide details of Subcontractors at all levels of the supply chain including:
 - (a) their name;
 - (b) the scope of their appointment; and
 - (c) the duration of their appointment.

Core Terms - DPS

24. Changing the contract

- 24.1 Either Party can request a Variation which is only effective if agreed in writing and signed by both Parties.
- 24.2 The Supplier must provide an Impact Assessment either:
 - (a) with the Variation Form, where the Supplier requests the Variation; or
 - (b) within the time limits included in a Variation Form requested by CCS or the Buyer.
- 24.3 If the Variation cannot be agreed or resolved by the Parties, CCS or the Buyer can either:
 - (a) agree that the Contract continues without the Variation; or
 - (b) terminate the affected Contract, unless in the case of an Order Contract, the Supplier has already provided part or all of the provision of the Deliverables, or where the Supplier can show evidence of substantial work being carried out to provide them; or
 - (c) refer the Dispute to be resolved using Clause 34 (Resolving Disputes).
- 24.4 CCS and the Buyer are not required to accept a Variation request made by the Supplier.
- 24.5 If there is a General Change in Law, the Supplier must bear the risk of the change and is not entitled to ask for an increase to the DPS Pricing or the Charges.
- 24.6 If there is a Specific Change in Law or one is likely to happen during the Contract Period the Supplier must give CCS and the Buyer notice of the likely effects of the changes as soon as reasonably practical. They must also say if they think any Variation is needed either to the Deliverables, DPS Pricing or a Contract and provide evidence:
 - (a) that the Supplier has kept costs as low as possible, including in Subcontractor costs; and
 - (b) of how it has affected the Supplier's costs.
- 24.7 Any change in the DPS Pricing or relief from the Supplier's obligations because of a Specific Change in Law must be implemented using Clauses 24.1 to 24.4.
- 24.8 For 101(5) of the Regulations, if the Court declares any Variation ineffective, the Parties agree that their mutual rights and obligations will be regulated by the terms of the Contract as they existed immediately prior to that Variation and as if the Parties had never entered into that Variation.

25. How to communicate about the contract

25.1 All notices under the Contract must be in writing and are considered effective on the Working Day of delivery as long as they are delivered before 5:00pm on a Working Day. Otherwise the notice is effective

Core Terms - DPS

on the next Working Day. An email is effective at 9:00am on the first Working Day after sending unless an error message is received.

- 25.2 Notices to CCS must be sent to the CCS Authorised Representative's address or email address indicated on the Platform.
- 25.3 Notices to the Buyer must be sent to the Buyer Authorised Representative's address or email address in the Order Form.
- 25.4 This Clause does not apply to the service of legal proceedings or any documents in any legal action, arbitration or dispute resolution.

26. Dealing with claims

- 26.1 If a Beneficiary is notified of a Claim then it must notify the Indemnifier as soon as reasonably practical and no later than 10 Working Days.
- 26.2 At the Indemnifier's cost the Beneficiary must both:
 - (a) allow the Indemnifier to conduct all negotiations and proceedings to do with a Claim; and
 - (b) give the Indemnifier reasonable assistance with the claim if requested.
- 26.3 The Beneficiary must not make admissions about the Claim without the prior written consent of the Indemnifier which can not be unreasonably withheld or delayed.
- 26.4 The Indemnifier must consider and defend the Claim diligently using competent legal advisors and in a way that does not damage the Beneficiary's reputation.
- 26.5 The Indemnifier must not settle or compromise any Claim without the Beneficiary's prior written consent which it must not unreasonably withhold or delay.
- 26.6 Each Beneficiary must take all reasonable steps to minimise and mitigate any losses that it suffers because of the Claim.
- 26.7 If the Indemnifier pays the Beneficiary money under an indemnity and the Beneficiary later recovers money which is directly related to the Claim, the Beneficiary must immediately repay the Indemnifier the lesser of either:
 - (a) the sum recovered minus any legitimate amount spent by the Beneficiary when recovering this money; or
 - (b) the amount the Indemnifier paid the Beneficiary for the Claim.

Core Terms - DPS

27. Preventing fraud, bribery and corruption

- 27.1 The Supplier must not during any Contract Period:
 - (a) commit a Prohibited Act or any other criminal offence in the Regulations 57(1) and 57(2); or
 - (b) do or allow anything which would cause CCS or the Buyer, including any of their employees, consultants, contractors, Subcontractors or agents to breach any of the Relevant Requirements or incur any liability under them.
- 27.2 The Supplier must during the Contract Period:
 - (a) create, maintain and enforce adequate policies and procedures to ensure it complies with the Relevant Requirements to prevent a Prohibited Act and require its Subcontractors to do the same;
 - (b) keep full records to show it has complied with its obligations under Clause 27 and give copies to CCS or the Buyer on request; and
 - (c) if required by the Relevant Authority, within 20 Working Days of the Start Date of the relevant Contract, and then annually, certify in writing to the Relevant Authority, that they have complied with Clause 27, including compliance of Supplier Staff, and provide reasonable supporting evidence of this on request, including its policies and procedures.
- 27.3 The Supplier must immediately notify CCS and the Buyer if it becomes aware of any breach of Clauses 27.1 or 27.2 or has any reason to think that it, or any of the Supplier Staff, has either:
 - (a) been investigated or prosecuted for an alleged Prohibited Act;
 - (b) been debarred, suspended, proposed for suspension or debarment, or is otherwise ineligible to take part in procurement programmes or contracts because of a Prohibited Act by any government department or agency;
 - (c) received a request or demand for any undue financial or other advantage of any kind related to a Contract; or
 - (d) suspected that any person or Party directly or indirectly related to a Contract has committed or attempted to commit a Prohibited Act.
- 27.4 If the Supplier notifies CCS or the Buyer as required by Clause 27.3, the Supplier must respond promptly to their further enquiries, co-operate with any investigation and allow the Audit of any books, records and relevant documentation.
- 27.5 In any notice the Supplier gives under Clause 27.3 it must specify the:
 - (a) Prohibited Act;
 - (b) identity of the Party who it thinks has committed the Prohibited Act; and
 - (c) action it has decided to take.

Core Terms - DPS

28. Equality, diversity and human rights

- 28.1 The Supplier must follow all applicable equality Law when they perform their obligations under the Contract, including:
 - (a) protections against discrimination on the grounds of race, sex, gender reassignment, religion or belief, disability, sexual orientation, pregnancy, maternity, age or otherwise; and
 - (b) any other requirements and instructions which CCS or the Buyer reasonably imposes related to equality Law.
- 28.2 The Supplier must take all necessary steps, and inform CCS or the Buyer of the steps taken, to prevent anything that is considered to be unlawful discrimination by any court or tribunal, or the Equality and Human Rights Commission (or any successor organisation) when working on a Contract.

29. Health and safety

- 29.1 The Supplier must perform its obligations meeting the requirements of:
 - (a) all applicable Law regarding health and safety; and
 - (b) the Buyer's current health and safety policy while at the Buyer's Premises, as provided to the Supplier.
- 29.2 The Supplier and the Buyer must as soon as possible notify the other of any health and safety incidents or material hazards they are aware of at the Buyer Premises that relate to the performance of a Contract.

30. Environment

- 30.1 When working on Site the Supplier must perform its obligations under the Buyer's current Environmental Policy, which the Buyer must provide.
- 30.2 The Supplier must ensure that Supplier Staff are aware of the Buyer's Environmental Policy.

31. Tax

- 31.1 The Supplier must not breach any Tax or social security obligations and must enter into a binding agreement to pay any late contributions due, including where applicable, any interest or any fines. CCS and the Buyer cannot terminate a Contract where the Supplier has not paid a minor Tax or social security contribution.
- 31.2 Where the Charges payable under a Contract with the Buyer are or are likely to exceed £5 million at any point during the relevant Contract Period, and an Occasion of Tax Non-Compliance occurs, the Supplier must notify CCS and the Buyer of it within 5 Working Days including:

Core Terms - DPS

- (a) the steps that the Supplier is taking to address the Occasion of Tax Non-Compliance and any mitigating factors that it considers relevant; and
- (b) other information relating to the Occasion of Tax Non-Compliance that CCS and the Buyer may reasonably need.
- 31.3 Where the Supplier or any Supplier Staff are liable to be taxed or to pay National Insurance contributions in the UK relating to payment received under an Order Contract, the Supplier must both:
 - (a) comply with the Income Tax (Earnings and Pensions) Act 2003 and all other statutes and regulations relating to income tax, the Social Security Contributions and Benefits Act 1992 (including IR35) and National Insurance contributions; and
 - (b) indemnify the Buyer against any Income Tax, National Insurance and social security contributions and any other liability, deduction, contribution, assessment or claim arising from or made during or after the Contract Period in connection with the provision of the Deliverables by the Supplier or any of the Supplier Staff.
- 31.4 If any of the Supplier Staff are Workers who receive payment relating to the Deliverables, then the Supplier must ensure that its contract with the Worker contains the following requirements:
 - (a) the Buyer may, at any time during the Contract Period, request that the Worker provides information which demonstrates they comply with Clause 31.3, or why those requirements do not apply, the Buyer can specify the information the Worker must provide and the deadline for responding;
 - (b) the Worker's contract may be terminated at the Buyer's request if the Worker fails to provide the information requested by the Buyer within the time specified by the Buyer;
 - (c) the Worker's contract may be terminated at the Buyer's request if the Worker provides information which the Buyer considers is not good enough to demonstrate how it complies with Clause 31.3 or confirms that the Worker is not complying with those requirements; and
 - (d) the Buyer may supply any information they receive from the Worker to HMRC for revenue collection and management.

32. Conflict of interest

- 32.1 The Supplier must take action to ensure that neither the Supplier nor the Supplier Staff are placed in the position of an actual or potential Conflict of Interest.
- 32.2 The Supplier must promptly notify and provide details to CCS and each Buyer if a Conflict of Interest happens or is expected to happen.
- 32.3 CCS and each Buyer can terminate its Contract immediately by giving notice in writing to the Supplier or take any steps it thinks are necessary where there is or may be an actual or potential Conflict of Interest.

Core Terms - DPS

33. Reporting a breach of the contract

- 33.1 As soon as it is aware of it the Supplier and Supplier Staff must report to CCS or the Buyer any actual or suspected breach of:
 - (a) Law;
 - (b) Clause 12.1; or
 - (c) Clauses 27 to 32.
- 33.2 The Supplier must not retaliate against any of the Supplier Staff who in good faith reports a breach listed in Clause 33.1 to the Buyer or a Prescribed Person.

34. Resolving disputes

- 34.1 If there is a Dispute, the senior representatives of the Parties who have authority to settle the Dispute will, within 28 days of a written request from the other Party, meet in good faith to resolve the Dispute.
- 34.2 If the Dispute is not resolved at that meeting, the Parties can attempt to settle it by mediation using the Centre for Effective Dispute Resolution (CEDR) Model Mediation Procedure current at the time of the Dispute. If the Parties cannot agree on a mediator, the mediator will be nominated by CEDR. If either Party does not wish to use, or continue to use mediation, or mediation does not resolve the Dispute, the Dispute must be resolved using Clauses 34.3 to 34.5.
- 34.3 Unless the Relevant Authority refers the Dispute to arbitration using Clause 34.4, the Parties irrevocably agree that the courts of England and Wales have the exclusive jurisdiction to:
 - (a) determine the Dispute;
 - (b) grant interim remedies; and/or
 - (c) grant any other provisional or protective relief.
- 34.4 The Supplier agrees that the Relevant Authority has the exclusive right to refer any Dispute to be finally resolved by arbitration under the London Court of International Arbitration Rules current at the time of the Dispute. There will be only one arbitrator. The seat or legal place of the arbitration will be London and the proceedings will be in English.

3.1 The Supplier:

 - 1.4.5 for the Buyer, the Key Sub-Contract price expressed as a percentage of the total projected Charges over the Order Contract Period; and
 - 1.4.6 (where applicable) Credit Rating Threshold (as defined in Joint Schedule 7 (Financial Distress)) of the Key Subcontractor.

1. In this Schedule, the following words shall have the following meanings and they shall supplement Joint Schedule 1 (Definitions):

"Processor Personnel"

all directors, officers, employees, agents, consultants and suppliers of the Processor and/or of any Subprocessor engaged in the performance of its obligations under a Contract;

Status of the Controller

- 5. The Processor shall provide all reasonable assistance to the Controller in the preparation of any Data Protection Impact Assessment prior to commencing any Processing. Such assistance may, at the discretion of the Controller, include:
- (a) a systematic description of the envisaged Processing and the purpose of the Processing;

- Process that Personal Data only in accordance with Annex 1 (Processing (a) Personal Data), unless the Processor is required to do otherwise by Law. If it is so required the Processor shall notify the Controller before Processing the Personal Data unless prohibited by Law;
- ensure that it has in place Protective Measures, including in the case of the (b) Supplier the measures set out in Clause 14.3 of the Core Terms, which the Controller may reasonably reject (but failure to reject shall not amount to approval by the Controller of the adequacy of the Protective Measures) having taken account of the:
 - nature of the data to be protected; (i)
 - harm that might result from a Personal Data Breach; (ii)
 - (iii) state of technological development; and
 - (iv) cost of implementing any measures;
- ensure that: (c)
 - the Processor Personnel do not Process Personal Data except in (i) accordance with the Contract (and in particular Annex 1 (Processing Personal Data));
 - it takes all reasonable steps to ensure the reliability and integrity (ii) of any Processor Personnel who have access to the Personal Data and ensure that they:
 - (A) are aware of and comply with the Processor's duties under this Joint Schedule 11, Clauses 14 (Data protection), 15 (What you must keep confidential) and 16 (When you can share information);
 - are subject to appropriate confidentiality undertakings with (B) the Processor or any Subprocessor;
 - are informed of the confidential nature of the Personal Data (C) and do not publish, disclose or divulge any of the Personal Data to any third party unless directed in writing to do so by the Controller or as otherwise permitted by the Contract;
 - (D) have undergone adequate training in the use, care, protection and handling of Personal Data;
- not transfer Personal Data outside of the UK or EU unless the prior written (d) consent of the Controller has been obtained and the following conditions are fulfilled:

- (i) the Controller or the Processor has provided appropriate safeguards in relation to the transfer (whether in accordance with UK GDPR Article 46 or LED Article 37) as determined by the Controller:

- (iii) the Processor complies with its obligations under the Data Protection Legislation by providing an adequate level of protection to any Personal Data that is transferred (or, if it is not so bound, uses its best endeavours to assist the Controller in meeting its obligations); and

- (c) receives any other request, complaint or communication relating to either Party's obligations under the Data Protection Legislation;
- (d) receives any communication from the Information Commissioner or any other regulatory authority in connection with Personal Data Processed under the Contract;
- (e) receives a request from any third Party for disclosure of Personal Data where compliance with such request is required or purported to be required by Law; or
- (f) becomes aware of a Personal Data Breach.
- 8. The Processor's obligation to notify under paragraph 6 of this Joint Schedule 11 shall include the provision of further information to the Controller, as details become available.
- Taking into account the nature of the Processing, the Processor shall provide the Controller with assistance in relation to either Party's obligations under Data Protection Legislation and any complaint, communication or request made under paragraph 6 of this Joint Schedule 11 (and insofar as possible within the timescales reasonably required by the Controller) including by immediately providing:

- the Controller with full details and copies of the complaint, communication or (a) request;
- such assistance as is reasonably requested by the Controller to enable it to (b) comply with a Data Subject Access Request within the relevant timescales set out in the Data Protection Legislation;
- the Controller, at its request, with any Personal Data it holds in relation to a (c) Data Subject:
- assistance as requested by the Controller following any Personal Data Breach; (d) and/or
- assistance as requested by the Controller with respect to any request from the (e) Information Commissioner's Office, or any consultation by the Controller with the Information Commissioner's Office.
- 10. The Processor shall maintain complete and accurate records and information to demonstrate its compliance with this Joint Schedule 11. This requirement does not apply where the Processor employs fewer than 250 staff, unless:

- (b) the Controller determines the Processing includes special categories of data as referred to in Article 9(1) of the UK GDPR or Personal Data relating to criminal convictions and offences referred to in Article 10 of the UK GDPR; or
- the Controller determines that the Processing is likely to result in a risk to the (c) rights and freedoms of Data Subjects.
- The Processor shall allow for audits of its Data Processing activity by the 11. Controller or the Controller's designated auditor.
- 12. The Parties shall designate a Data Protection Officer if required by the Data Protection Legislation.
- 13. Before allowing any Subprocessor to Process any Personal Data related to the Contract, the Processor must:
- (a) notify the Controller in writing of the intended Subprocessor and Processing;
- obtain the written consent of the Controller: (b)
- enter into a written agreement with the Subprocessor which give effect to the (c) terms set out in this Joint Schedule 11 such that they apply to the Subprocessor; and
- provide the Controller with such information regarding the Subprocessor as (d) the Controller may reasonably require.
- 14. The Processor shall remain fully liable for all acts or omissions of any of its Subprocessors.

- Taking into account the state of the art, the costs of implementation and the 23. nature, scope, context and purposes of Processing as well as the risk of varying likelihood and severity for the rights and freedoms of natural persons, each Party shall, with respect to its Processing of Personal Data as Independent Controller, implement and maintain appropriate technical and organisational

 - (ii) provide any information and/or assistance as reasonably requested by the other Party to help it respond to the request or correspondence in the timeframes specified by Data Protection Legislation.
- 26. Each Party shall promptly notify the other Party upon it becoming aware of any Personal Data Breach relating to Personal Data provided by the other Party pursuant to the Contract and shall:
- (a) do all such things as reasonably necessary to assist the other Party in mitigating the effects of the Personal Data Breach;
- (b) implement any measures necessary to restore the security of any compromised Personal Data;
- (c) work with the other Party to make any required notifications to the Information Commissioner's Office and affected Data Subjects in accordance with the Data Protection Legislation (including the timeframes set out therein); and
- (d) not do anything which may damage the reputation of the other Party or that Party's relationship with the relevant Data Subjects, save as required by Law.

- 2.3.5 a failure of the Supplier or any Subcontractor to discharge or procure the discharge of all wages, salaries and all other benefits and all PAYE tax deductions and national insurance contributions relating to the Transferring Supplier Employees in respect of the period up to (and including) the Service Transfer Date);
- 2.3.6 any claim made by or in respect of any person employed or formerly employed by the Supplier or any Subcontractor other than a Transferring Supplier Employee identified in the Supplier's Final Supplier Personnel List for whom it is alleged the Buyer and/or the Replacement Supplier and/or any Replacement Subcontractor may be liable by virtue of the relevant Contract and/or the Employment Regulations and/or the Acquired Rights Directive; and
- 2.3.7 any claim made by or in respect of a Transferring Supplier Employee or any appropriate employee representative (as defined in the Employment Regulations) of any Transferring Supplier Employee relating to any act or omission of the Supplier or any Subcontractor in relation to its obligations under regulation 13 of the Employment Regulations, except to the extent that the liability arises from the failure by the Buyer and/or Replacement Supplier to comply with regulation 13(4) of the Employment Regulations.
- 2.4 The indemnities in Paragraph 2.3 shall not apply to the extent that the Employee Liabilities arise or are attributable to an act or omission of the Replacement Supplier and/or any Replacement Subcontractor whether occurring or having its origin before, on or after the Service Transfer Date including any Employee Liabilities:
 - 2.4.1 arising out of the resignation of any Transferring Supplier Employee before the Service Transfer Date on account of substantial detrimental changes to his/her working conditions proposed by the Replacement Supplier and/or any Replacement Subcontractor to occur in the period on or after the Service Transfer Date); or

- 2.13.8 any claim made by or in respect of a Transferring Supplier Employee identified in the Supplier's Final Supplier Personnel List or any appropriate employee representative (as defined in the Employment Regulations) of any such Transferring Supplier Employee relating to any act or omission of the Replacement

1.1 The Buyer and the Supplier recognise that, where specified in DPS Schedule 4 (DPS Management), the Buyer may give CCS the right to enforce the Buyer's rights under this Schedule.

If the Buyer deems gainshare to be applicable then the Supplier shall update the Continuous Improvement Plan so as to include details of the way in which the proposal shall be implemented in accordance with an agreed gainshare ratio.



UK Shared Business Services (UK SBS), on behalf of The Department for Energy Security and Net Zero (DESNZ) wish to appoint a supplier to commission research on rebound effects from industrial resource efficiency (RE) and energy efficiency (EE) measures. This will be used to inform the assessment of carbon abatement potential from RE and EE measures, scenario modelling, and policy appraisals.

Broadly, rebound effects relate to behavioural and systemic responses to improved efficiency, which can diminish environmental benefits. Published evidence indicates that rebound effects for industrial energy and resource efficiency measures could be large, though with significant variation depending on how rebound is defined, and between countries and sectors. Established energy and emissions models struggle to account for potential rebound effects, due to evidence gaps. This means we may be misrepresenting the potential net carbon savings from RE and EE actions.

Carbon savings from RE and EE are critical to meeting industry's CB5 and CB6 targets. RE and EE measures are currently projected to deliver 11 MtCO2e of industrial carbon savings per year by 2035. Understanding the nature and potential magnitude of rebound effects, including where rebound effects are most likely, will help identify and address risks of delivery of industrial emissions savings.

While rebound arising from efficiency gains can provide benefits, in terms of productivity, jobs and economic growth, it can make the task of achieving overall energy and emissions targets harder. We need to understand these dynamics so that we have a robust way to appraise the impacts of our policy interventions, and to design policies that maximise overall benefits for society.

<u>OverviewofrequirementsforindustrialREandEErebound</u>

The focus is on rebound in UK energy or resource use, and associated territorial greenhouse gas emissions, consistent with the accounting approach for carbon budget modelling.

Industrial RE and EE measures differ considerably in nature. We expect that rebound effects arising from RE and EE measures will also differ in terms of mechanisms, magnitude, and complexity. Resource efficiency measures are more varied and, arguably, more complex than EE measures. Scoping work to inform this specification has found that that significantly more evidence is available for industrial EE than RE rebound (including quantitative evidence), and that EE rebound is generally well-explained by economic productivity effects. By contrast, rebound effects for RE measures are poorly understood and quantitative evidence is extremely limited. Consequently, the research will involve two related but distinct workstreams for investigating RE and EE rebound:

1) Workstream A: Industrial resource efficiency rebound: The focus is on providing a detailed understanding of the different mechanisms through which rebound can occur for a small subset of RE sectors & measures, an assessment of which factors contribute to rebound effects, and for which

sectors / measure types rebound may be largest. This information will be used to inform policy prioritisation and scenario analysis. While literature review will be important, we expect that conceptual work to set out a framework for understanding and assessing potential RE rebound effects will be required, as well as some limited fieldwork (e.g. a small number of interviews and/or workshops) to test and develop the framework. Quantitative estimates of RE rebound for use in policy analysis are not a requirement, due to lack of evidence and feasibility.

Workstream B: Industrial energy efficiency rebound: The focus is on assessing evidence on the potential magnitude of rebound effects in quantitative terms, and how this may vary between sectors, along with advice for applying quantitative estimates in economic appraisals and carbon abatement modelling. We are also seeking guidance on valuing industrial rebound effects for energy efficiency measures in monetary terms. Given that the EE rebound is relatively well-understood, with a more developed literature, we expect that the work will primarily involve literature review and synthesis.

The requirements for these two workstreams are specified in more detail below. The focus on UK territorial emissions is consistent with the accounting approach for carbon budget modelling.

WorkstreamA:Industrialreboundefficiencyreboundrequirements

A.1. Industrial Resource Efficiency Rebound: Definition & Scope

Recently published research undertaken for DESNZ, <u>Unlocking Resource Efficiency</u>, defined resource efficiency measures as actions which "[optimise]... resource use so that a given level of final consumption can be met with fewer resources."¹ These can act on production, consumption, and end-of-life, and are often associated with a shift towards a circular economy. Some of these may be cost-saving productive efficiency improvements, where the productivity rebound mechanism will be prevalent, as for industrial EE measures. However, rebound in territorial energy use and emissions for RE is complicated by several, sometimes interacting, factors, including but not limited to:

- The effect of reduced demand for a commodity due to lightweighting, which
 may or may not result in production cost savings, on UK territorial production,
 energy use, emissions and trade (e.g. the effect of lightweighting in UK car
 production on UK steel production).
- The effect of RE measures that improve productive efficiency, leading to reduced production costs and associated substitution, output and income effects.

¹ Phase 1 of this research focussed on four priority sectors: cement and concrete, construction, steel and vehicles, and was published in November 2023. Phase 2 covered textiles, chemicals, glass, paper, plastics, electricals and food & drink, and was published in April 2024.

- The effect of measures that act on consumption (potential effects of changing consumption patterns (renting, life extension etc.), potential substitution effects of switching to other products and income effect of increasing consumption, depending on cost savings).
- Effects of measures that reuse materials and wastes between sectors e.g. industrial symbiosis, where some parts of the chain could experience higher costs vs savings for others.
- The effect on production costs of material substitution, the producer response
 to these costs, in terms of output prices, and any resulting change in output
 volume and consumption. Substituted materials may be more or less costly or
 entail changes to production processes that increase or reduce costs.

Depending on the type of measure, the effect on UK territorial emissions will therefore be determined by, among other factors, economic price effects, supply chain and cross-sector dynamics, consumer behaviour, production capacity and trade effects. We are keen to understand the potential importance of these 'wider market effects', in addition to conventional economic rebound effects, so that we better capture the possible effects that may arise for various RE measures.

Given this complexity, and the lack of published evidence, a key part of this work will be to develop a conceptual framework for assessing resource efficiency rebound (including wider market effects). At this stage, we are not seeking advice or recommendations on quantitative estimates of RE rebound to use in modelling and policy appraisals; however, to the extent that sufficient evidence is available, we are seeking an understanding of the potential magnitude of rebound for RE measures and of which types of sectors and measures may incur the largest rebound.

To keep the requirements manageable, the RE component of this research should focus on the following sectors and measure types:

The conceptual mapping and findings for these sectors and measures will serve to provide a framework that could later be extended to other RE measures.

A.2. Industrial RE Rebound: Objectives and Research Questions

The work on industrial RE rebound effects should address **three key research objectives**:

- Critically review available evidence on industrial resource efficiency rebound. Given the limited published evidence, it is likely that the scope of this review will need to consider publications on resource efficiency measures in general, including where these are captured by literature on the circular economy, though it should place particular focus on the prioritised measures and sectors provided in Table 1.
- Develop a conceptual mapping and framework of rebound effects for the prioritised industrial RE sectors and measures. This should map the key effects and mechanisms through which rebound occurs for each of the prioritised RE sectors and measures, which will provide a clear framework for assessing the effects and inform future methodology and data requirements. It will also be used to identify the key metrics that could be used to monitor / measure rebound effect in RE measures. This should include small scale fieldwork with industry and academic experts in the field to test the conceptual mapping and literature review findings.
- Synthesise evidence and provide findings and guidance on the research questions below, to provide insights for UK carbon abatement policy and modelling work.

In doing so, the research should seek to answer the following key research questions:

- a) What are the main factors that contribute to rebound effects for industrial RE measures, and the mechanisms through which they take effect?
- b) Where available, what does the evidence suggest about the potential magnitude of rebound effects for industrial RE measures in the UK context?
- c) How are RE rebound effects likely to vary between sectors and different types of measures? Which of the priority measure and sector types (Table 1) are most likely generate large rebound effects?
- d) What is the extent and quality of evidence available on industrial RE rebound effects, in terms of the methodologies used, relevance of the study population, sample size, etc?
- e) What are the main evidence gaps? How could these be addressed by further research?
- f) What evidence is available on policies or strategies to mitigate the negative impacts of RE rebound, including the potential risks and unintended consequences of doing so?
- g) What are the key metrics and data that have been used to monitor and measure rebound effect in RE measures? What are their limitations?

These questions are presented in priority order, which should serve as a guide to the share of project resource to allocate to each.

A.3. Industrial RE Rebound: Suggested Methodology

We anticipate that Workstream A will involve the following steps, though these are provided as a guide. We invite suppliers to develop and propose alternative approaches where this would meet the research objectives more effectively.

I. Literature Review: Industrial RE Rebound Effects

An important part of this work will be to compile and critically review relevant research on industrial RE rebound effects, addressing the respective research questions above. While some literature may cover both RE and EE measures and rebound effects, we observe that the RE and EE literature is largely separate, and this may in practice require two largely distinct literature reviews.

The literature review should cover relevant, published research, grey literature and case studies, as well as government policy appraisals and evaluations. It will need to critically assess the quality and relevance of the available evidence, including theoretical / modelling work, empirical studies, and meta-analyses, using criteria agreed with DESNZ.

A key challenge for the research will be identifying relevant, generalisable findings from the literature, given that rebound effects vary considerably by definition and context. Bids should set out the proposed approach to identifying relevant research, how these will be analysed, and how conclusions will be drawn across study contexts.

II. Conceptual Mapping

Given evidence gaps, we anticipate that an important starting point – and itself a useful output of this work – will be to develop a conceptual framework for assessing rebound effects for industrial RE measures. In practice, we expect this will involve undertaking conceptual mapping exercises for the prioritised RE measures in Table 1, which could be iterated with literature review work. This mapping should decompose and capture the main effects and mechanisms that influence industrial RE rebound effects.

For example, we expect the map to explore how the incidence of costs and savings are a key driver of how actors in the supply chain respond to the effects of efficiency measures, and consequently any net rebound effect. It is possible that an RE rebound effect in one part of the supply chain may be counteracted by a "reverse rebound effect" if costs have increased in another part of the supply chain. It is likely that cost implications will differ substantially between different RE measures. In general, this step should attempt to capture a theoretical map of the consequences up and down the supply chain of an actor implementing an RE measure.

We expect this will include incentives, elasticities, market supply chain effects, trade effects, etc, informed by theoretical considerations (e.g. economic theory) and literature review.

III. Small Scale Field Work: Industrial RE Rebound

Given the evidence gaps and complexity on RE rebound, we expect that it will be important to test and validate the conceptual mapping and literature review findings with experts in field, which could include experts on prioritised sectors (e.g. trade stakeholder organisations, professional associations and key manufacturers) and academics.

We expect that this would primarily involve a small number of facilitated workshops, maximum of one per priority sector (i.e. 4 in total, though there may be scope to combine these where measures, sectors or stakeholder groups align), to test key aspects, relationships or mechanisms identified in the conceptual mapping (e.g. as to their direction, importance, linkages). Additionally, there may be scope to gather limited case study evidence from a small number of organisations that have implemented the priority RE measures to provide an illustration of potential rebound effects.

Bids should outline the expected number, type and format of planned fieldwork, which would then be refined based on the outcome of conceptual mapping and literature review work and agreed with DESNZ. The contractor would need to develop supporting materials for the field work, including topic guides, questions, presentations and summary outputs.

IV. Evidence Synthesis, Findings and Reporting

The contractor will need to consider the evidence generated in steps 1 to 3 to develop findings and recommendations addressing the key research questions in Section A.2. The recommendations should reflect the quality and relevance of evidence, highlight limitations in proposed approach(es) and specify where further research is required to develop a stronger basis for analysis. Further information on requirements for outputs is provided below.

A.4. Industrial RE Rebound: Outputs and Deliverables

I. Interim Report: Literature Review and Conceptual Mapping Outputs

A combined interim report covering Workstreams A and B is required. For Workstream A (RE), this should include but is not limited to:

- the RE literature review, including initial findings regarding the research questions outlined in section A.2. This should cover the literature referenced and methodology, including where any expert judgment was applied and the extent to which uncertainties are present. The interim reports should be clear and provide details of how the outputs in response to the research questions were formed.
- The initial conceptual maps for each priority sector (four in total), including a visual representation of these maps with written discussion of the main factors and dynamics driving rebound effects.

• Proposal for the fieldwork, including the number and format of fieldwork, and the questions and material to be tested with stakeholders.

II. Fieldwork Outputs

We require:

- A methodology note outlining the proposed method for fieldwork, including quality assurance of outputs, to facilitate discussion and agreement with DESNZ ahead of the fieldwork being carried out.
- A list of recommended and actual experts for fieldwork (interviews and / or workshops), with input from DESNZ.
- Topic notes and material used for interviews and workshops.
- Anonymised transcripts of interviews and workshops undertaken.

III. Final Outputs

A combined final report is required covering Workstreams A and B, at a maximum of around 50 pages, with further information in appendices and annexes as required. For Workstream A (RE), this should include but is not limited to: the project methodology, conceptual mapping work, literature review findings, fieldwork, evidence synthesis and advice addressing the key research questions. This will build on the interim report.

The final report will need to be suitable for publication and accessible to a public audience.

We also require:

- An online presentation of results to an internal analytical and policy audience.
- A summary slide pack for use in cross-government and external presentations.
- A Quality Assurance (QA) document detailing the QA processes undertaken. QA should be completed in accordance with the standards set out in the HMT <u>Aqua</u> and <u>Magenta</u> books.
- A searchable, user-friendly dataset including all literature analysed, in addition to a database of search strings used in literature searching.

WorkstreamB:IndustrialEnergyEfficiencyReboundRequirements

B.1. Industrial EE Rebound: Definition & Scope

Industrial EE measures can be defined as technical or behavioural changes that reduce the energy intensity of production. Cost-saving measures are likely to be well-represented by economic rebound and productivity effects, where reduced production costs stimulate demand and energy use via substitution and output/income effects.

Detailed information on energy efficiency measures for UK industry is provided in the <u>2015</u> <u>IndustrialDecarbonisationandEnergyEfficiencyRoadmaps</u>, covering 8 priority sectors (iron and steel, chemicals, oil refining, food and drink, pulp and paper, cement, glass, and ceramics).² The scope of the present project should be limited to measures applicable in these sectors, though we expect that there will be evidence gaps for some/many sectors and so it may be necessary to focus on a smaller number of sectors for which more evidence is available.

We are also seeking evidence on approaches to valuing industrial energy efficiency rebound effects in monetary terms. Current HMT <u>GreenBook</u> supplementary guidance advises that "the direct energy rebound effect should be valued at the retail price of the energy, as this captures the gain in welfare (the retail price acts as a proxy for the consumer's willingness-to pay)". Alternative approaches, such as gross valued added per unit of energy, may provide a more suitable proxy for monetising social welfare gains in the industrial context.

B.2. Industrial EE rebound: Objectives and Research Questions

The work on Industrial EE Rebound should address two Research Objectives:

- 1) Critically review available evidence on magnitude, drivers, and variability of industrial EE rebound effects, and on valuing related output effects in monetary terms. A key focus of this review is to identify suitable quantitative estimates of EE rebound effects that could be applied in the UK industrial context. This should address the key research questions below and further considerations in 'B.3 Suggested Methodology' below.
- 2) Develop guidance on suitable estimates of EE rebound effects for application in economic appraisals and carbon abatement assessments, and considerations in their use. This should synthesise the literature review evidence to develop suitable estimate(s) of rebound effects for application in UK economic appraisals and carbon abatement modelling and address the research questions below. It may be necessary to undertake some limited academic engagement to test evidence gaps and emerging findings.

In doing so, the contractor should answer the following **key research questions**:

- a) What quantitative evidence is available on the magnitude of rebound effects from industrial energy efficiency measures?
 - i. How do these estimates vary
 - o by the scope and definition of rebound used?
 - o between sectors and different types of measures?
 - ii. What are the main factors that contribute to the size of the rebound effect?
 - iii. What is the extent and quality of this evidence, in terms of the methodologies used, relevance of the study population, sample size, etc?
- b) What estimates of the magnitude of rebound effects are most suitable for quantifying rebound from industrial EE measures in the UK context? Please provide, i) suitable estimate(s) for applying across all industry sectors; ii) sector-specific estimates, where the evidence supports this.
- c) What methodologies are used in the literature to value industrial EE rebound in monetary terms and what are their relative merits? What are the main considerations for applying these valuation approaches in UK policy appraisals?
- d) What are the main evidence gaps relating to questions a-c? How could these be addressed by further research?

These questions are presented in priority order, which should serve as a guide to the share of project resource to allocate to each.

B.3. Industrial EE Rebound: Suggested Methodology

We anticipate that Workstream B will involve the steps outlined below, though these are provided as a guide. Relative to Workstream A (RE rebound), we expect the literature review and synthesis to account for the vast majority for Workstream B. While there is no requirement for formal conceptual or field work, we expect that it will be necessary to undertake some limited, targeted academic engagement to identify relevant research, clarify evidence gaps, and seek feedback on emerging findings.

We invite suppliers to develop and propose alternative approaches to that set out below, where this would meet the research objectives more effectively.

I. Literature Review

A key part of this work will be to compile and critically review relevant research on industrial EE rebound effects, addressing the research questions in Section B.2. As with Workstream A, this should cover relevant, published research, grey literature and case studies, as well as government policy appraisals and evaluations, for example the Made Smarter programme, IEEA programme and Climate Change Agreements (CCAs).⁴ The review will need to critically assess the quality and relevance of the available evidence,

using criteria agreed with DESNZ, including theoretical / modelling work, empirical studies, and meta-analyses.

A key challenge, particularly when assessing quantitative estimates of industrial EE rebound effects, will be identifying relevant, generalisable findings from the literature, given that rebound estimates vary considerably by definition and context. It will be important to determine the definition(s) of rebound applied in each study and the scope of impacts accounted for so that results can be interpreted and, where possible, standardised.

An additional consideration is that many EE (and RE) measures can have other quality effects that can stimulate changes in production and demand independently of effects on energy costs. For example, a more energy efficient furnace may also be quicker / save time. More generally, newer equipment may confer benefits aside from energy or resource efficiency (e.g. size, ease of use), further increasing the context-variability of rebound effects. The literature review should identify the extent to which quality and other contextual factors are accounted for.

Bids should set out the proposed approach to identifying relevant research, how these will be analysed, and how conclusions will be drawn across study contexts.

II. Evidence Synthesis, Findings and Recommendations

The contractor will need to synthesise the evidence generated in step 1 to develop findings and practical recommendations addressing the key research questions in Section B.2. This should include quantitative estimates of rebound effects for EE measures suitable for application in UK policy appraisals and analysis. The recommendations will reflect the quality and relevance of evidence, highlight limitations in proposed approach(es) and specify where further research is required to develop a stronger basis for analysis.

B.4. Industrial EE Rebound: Outputs and Deliverables

I. Interim Report: Literature Review

A combined interim report covering Workstreams A and B is required. For Workstream B (EE), this should include but is not limited to:

- The EE literature review, including initial findings regarding the research questions outlined in section B.2. This should cover the literature referenced and methodology, including where any expert judgment was applied and the extent to which uncertainties are present. The interim report should be clear and provide details of how initial outputs in response to the research questions were formed.
- A summary of key evidence gaps against the research questions.
- Proposals for further engagement to be undertaken before final report to test findings and evidence gaps.

II. Final Outputs:

A combined final report is required covering Workstreams A and B, at a maximum of around 50 pages, with further information in appendixes and annexes as required. For Workstream B (EE), this should include: the project methodology, literature review findings, further engagement undertaken, evidence synthesis and guidance addressing the key research questions. This will build on the interim report.

The final report should provide guidance on suitable quantitative estimates of EE rebound effects for use in UK policy appraisals, and on valuing rebound benefits in monetary terms, clearly setting out considerations for application, including limitations.

The final report will need to be suitable for publication and accessible to a public audience.

We also require:

- An online presentation of results to an internal analytical and policy audience.
- A summary slide pack for use in cross-government and external presentations.
- A Quality Assurance (QA) document detailing the QA processes undertaken. QA should be completed in accordance with the standards set out in the HMT <u>Aqua</u> and <u>Magenta</u> books.
- a searchable, user-friendly dataset including all literature analysed, in addition to a database of search strings used in literature searching.

<u>AdditionalProjectRequirements</u>

Quality Assurance

All bids should state the quality assurance (QA) processes that will be applied to different activities and outputs. Where necessary, deliverables that will provide evidence of QA should be specified. Sign-off for quality assurance must be done by someone of sufficient seniority within the contractor organisation to be able to take responsibility for the work done. Acceptance of the work by DESNZ will take this into consideration.

DESNZ reserves the right to refuse to sign off outputs which do not meet the required standard specified in this Mini Competition and/or the contractor's QA plan. QA should cover all aspects of the project undertaken by the contractors, including data collection, analysis and reporting.

To demonstrate an effective process to produce high quality reporting, the contactor must ensure that QA is done by individuals who were not directly involved in that particular piece of research or analysis.

Bidders should note that DESNZ may appoint its own peer reviewer(s), such as engineering colleagues to QA publishable outputs. Consideration should be given to how the external peer reviewer(s) will be included in the QA process. Where complex or innovative methods are proposed, bidders should specify how additional QA will be provided. Where necessary, this should include the use of external experts. A DESNZ appointed peer reviewer will not be expected to provide detailed QA; their role will be focused on higher level peer review.

Outputs will be subject to DESNZ internal approvals. The more substantive the output, the longer the approval time required. Published reports will require two rounds of comments, which should be factored into the timelines.

The successful bidder will be responsible for any work supplied by sub-contractors. For primary research, contractors should be willing to facilitate DESNZ research staff to attend interviews as part of the QA process.

Data Security

The successful bidder must comply with the UK General Data Protection Regulation (GDPR) and any information collected, processed and transferred on behalf of the Department, and in particular personal information, must be held and transferred securely. Bidders must provide assurances of compliance with GDPR and set out in their bids details of the practices and systems they have in place for handling data securely, including transmission between the field and head office and then to the Department. The successful supplier will have responsibility for ensuring that they and any subcontractor who processes or handles information on behalf of the Department is conducted securely. ContractManagementandCommunications

An initial kick-off meeting shall be scheduled as soon as possible with DESNZ once the contract has been awarded. It is expected that there will be some parallel working, such as across RE and EE literature reviews.

The successful supplier will be expected to identify one named point of contact through whom all enquires can be filtered. A DESNZ project manager will be assigned to the project and will be the central point of contact.

DESNZ will form a steering group of government stakeholders to inform key project decisions and feedback on progress and emerging outputs. We expect that the steering group will meet at a minimum of three key points during the project – at inception, at interim report stage, and at final output stage.

In addition, the contractor will be required to provide regular project updates throughout the course of the project, the frequency of which is likely to vary in line with the nature of the activities at the time. It should be expected that fortnightly Microsoft Teams calls will be required between the supplier and DESNZ project manager. The supplier will be required to provide regular updates on progress for each stage of research and outstanding actions for both the supplier and DESNZ. The regularity of these updates should be decided during the inception phase of the project.

On occasion, DESNZ may ask the successful supplier to attend a DESNZ office for a faceto-face meeting. This is not expected to be regular occurrence and online meetings will be the default. Attendance will be at the successful supplier's own expense.

The supplier should appoint a project management structure that ensures synergies and opportunities for efficiencies between sequential or parallel aspects of the project, along with delivery risks, are identified and robustly managed. It is expected that the successful supplier will keep project trackers and risk logs up to date in advance of each project management meeting, including an invoice schedule and overview of the budget for each phase of research. DESNZ expects this to be made accessible for the department to monitor progress.
