QUOTE SHEET APRIL 2020 - MARCH 2023

Highway Grass Verges (136 Agreement):

Cut all highway grass verges (Areas 1 - 8 as listed on the Specification Sheet) once every three weeks, weather permitting, from April to October

Seating Areas

Monthly maintenance visits April – October (Areas listed on the Specification Sheet)

Special Areas:

Kettering Road A43

4 cuts per year approx Mid April, Mid June, Mid Aug and Mid Oct, dependent upon season

Public Gardens, Church Street

Mow and strim weekly from April – October, plus March if needed

Trim conifer hedge once a year, during the winter

Annual trim of boundary hedge, laurel hedge around storage shed and hedges either side of vehicle entrance

Lunchfield Triangle, Lunchfield Lane

Mow fortnightly from April – October

Rose Tree Close (Mulberry Gardens), Boughton Road - Public Open Space

Mow and strim fortnightly from April – October

Busby's Meadow, The Grove

Grass nearest houses (Church View)

Mow fortnightly (leaving grass cuttings) approx 1m wide strip around path

1 full mow late July (leaving grass cuttings)

1 full mow in the autumn (removing all grass cuttings from site)

Stream Side

Mow fortnightly (leaving grass cuttings) approx 1m wide strip around path and a 1m wide strip from path leading to dipping platform

1 full mow late July (leaving grass cuttings)

1 full mow in the autumn (removing all grass cuttings from site)

Additional Area

Mow fortnightly path cuts (leaving grass cuttings)

1 full mow in the autumn (removing all grass cuttings from site)

Trim hedge twice a year - June and September

Annual trim of boundary hedge Church View and Thompsons Lane

Carey Fields (whole site)

To mow POS areas once every 3 weeks weather permitting from April – October

To maintain Wildlife Corridor once a month from April – October

To maintain newly planted areas once a month from April – October

To maintain newly planted hedge to Southern Boundary once a month from April – October

To mow Play area once a week weather permitting from April – October

Attenuation Basins within site

To mow every 4 weeks weather permitting from April – October

Inspect drainage and water flow April-October and March

Thin out excess growth to retain adequate flow in channel annually

Check balancing lagoons at each monthly visit for blockages/litter removal and bank stability and clear debris as required - April - March

Leaf clearance operations monthly October – January

Maintain bank side vegetation/weed cover to a minimum to prevent chocking of channel April - September

Sandy Hill

To mow POS areas once every 3 weeks weather permitting from April – October

To maintain newly planted areas once a month from April – October

To mow 2no Play areas once a week weather permitting from April – October

Attenuation Basins within site

To mow every 4 weeks weather permitting from April – October

Inspect drainage and water flow April-October and March

Thin out excess growth to retain adequate flow in channel annually

Check balancing lagoons at each monthly visit for blockages/litter removal and bank stability and clear debris as required - April - March

Leaf clearance operations monthly October – January

Maintain bank side vegetation/weed cover to a minimum to prevent chocking of channel April - September

DWH 2 - Morning Star Lane

To mow POS areas once every 3 weeks weather permitting from April – October

Trim rear and front boundary hedges June and September

Attenuation Basins within site

To mow every 4 weeks weather permitting from April – October

Inspect drainage and water flow April-October and March

Thin out excess growth to retain adequate flow in channel annually

Check balancing lagoons at each monthly visit for blockages/litter removal and bank stability and clear debris as required - April - March

Leaf clearance operations monthly October – January

Maintain bank side vegetation/weed cover to a minimum to prevent chocking of channel April - September

Marsh Spinney/Balfour Beatty/Sand Hills

To mow POS areas once every 3 weeks weather permitting from April – October

Trim boundary hedge June and September

Attenuation Basins within site

To mow every 4 weeks weather permitting from April – October

Inspect drainage and water flow April-October and March

Thin out excess growth to retain adequate flow in channel annually

Check balancing lagoons at each monthly visit for blockages/litter removal and bank stability and clear debris as required - April - March

Leaf-clearance operations monthly October–January

Maintain bank side vegetation/weed cover to a minimum to prevent chocking of channel April - September

Mow and strim weekly play area from April – October

To mow POS areas once every 3 weeks weather permitting from April – October

To maintain newly planted areas once a month from April – October

To maintain existing and newly planted trees

Maintain tree belt between site and existing tree copses

Attenuation Basins within site

To mow every 4 weeks weather permitting from April – October

Inspect drainage and water flow April-October and March

Thin out excess growth to retain adequate flow in channel annually

Check balancing lagoons at each monthly visit for blockages/litter removal and bank stability and clear debris as required - April - March

Leaf-clearance operations monthly October–January

Maintain bank side vegetation/weed cover to a minimum to prevent chocking of channel April - September

Maintain boundary hedges

Millbrook Grange (Barwood)

To mow POS areas once every 3 weeks weather permitting from April – October

To maintain newly planted areas once a month from April – October

Maintain boundary hedge

MPC Cemetery

To carry out grass cutting/strimming based on weekly visits April-October, plus March

To carry out herbicide application based on monthly applications April-October, plus March

To carry out full shrub/hedge trimming as required during the growing season

To carry out winter leaf clearing based on fortnightly visits

To mark out burials as required

To straighten headstones as necessary

To re-edge paths and top up with pea shingle during the winter

All debris and litter to be removed during each visit

Moulton Community Centre Site

SITE VISITS:

To visit site on a fortnightly basis April to October and on a monthly basis November to March

GRASS AREAS:

To mow all grass areas on a fortnightly basis during April-October, plus March, removing grass cuttings

To trim all edges to paths, shrub areas and around trees as required during the growing season

In early summer apply a selective herbicide to grass areas

SHRUB AREAS:

To control weed growth in these areas by regular herbicide applications

To carry out a full prune of shrubs once during the summer and once during the winter

To prune growth around signs, fire exits and manholes as necessary during the season

FOOTPATHS, CAR PARKS, HARD STANDING AREAS:

To control weed growth in these areas by regular herbicide applications

DEBRIS REMOVAL:

To remove wind-blown litter from all areas during each visit

To remove fallen leaves from all areas during the winter visits

SITE INSPECTIONS:

To report any damage or replacement plant material that may be required together with a quotation.

DISPOSAL:
