#### CONCLUSION

We look forward to working with DEFRA/APHA for the Services associated with the Mechanical Inspection Works. Our organisation has considerable experience in the work that needs to be carried out, having performed the work on many previous shutdowns.

#### COMPETENCE, TRAINING AND EXPERIENCE OF STAFF

Our staff are trained to the necessary standards to carry out the work they are to undertake and have considerable experience of this work scope. The Company specialises in shutdown work and has, on several occasions, previously carried out the mechanical work and cleaning on site.

#### Work Scope

We will provide a team on site for the above work scope with respective DEFRA representatives and complete the removal of 4 sets of louvers and 2 electric actuators, after this is complete do an inspection and comb the fins back straight with relevant tooling. We will then clean the ACHE x 2 with ASL detergent (COSHH assessment can be provided if needed) and then refit louvers and actuators.

Anticipated duration 6 days but may differ according to actual work scope, working in conjunction with the project/mechanical teams.

#### Method Statements

Final method statements will be made available to DEFRA/APHA following the award of the contract.

#### Plant and equipment

We operate a program where all operational plant and equipment are regularly maintained to ensure maximum efficiency on site. All equipment must be covered for damage and loss to the value of like-for-like new replacements. This is based on all site services being available to us.

Additional work will be undertaken using our 2023 Rate Schedule, beginning on a specified date for 6 days, usually starting on a Monday. If we are to start on another day/date different to the agreed date(s) then rates could change due to overtime hours etc. if the work scope is split in any way this will incur further mobilisation and de-mobilisation costs.
