WHEREAS the **BUYER** and the **SUPPLIER** entered into a Call-Off Contract for the provision of Invotra Digital Workplace to DWP on a software-as-a-service basis dated 09/12/2019, under the Terms of the G-Cloud 11 Framework Agreement (RM1557.11).

IT IS AGREED BETWEEN: Department for Work & Pensions (DWP) ("**the Buyer**") and Invotra Limited ("**the Supplier**") that the Call Off Contract is varied as follows (in accordance with Clause 32 (Variation process) and shall take effect on the date signed by both Parties: as follows:

1. Part A - Order Form and Schedule 2 sections of the Call-Off Contract shall be amended as set out below.
2. Save as herein amended, all other terms and conditions of the Call-Off Contract inclusive of any previous Variations shall remain in full force and effect.

Target date for implementing proposed change 31/03/2021

Description for proposed change

The Buyer wishes to amend Part A – Order Form and Schedule 2 as follows:

Part A – Order Form, amend the row “Call-Off Contract Charges” in the section “Call-Off Contract charges and payment” by adding the following new paragraphs into that row:

“The charge for April 2021 shall be increased by £44,954.00 (ex VAT) in recognition of the Supplier making a payment to AWS for reserved instances.

The charge for March 2022 shall be reduced by £73,333.00 (ex VAT) in recognition of the savings achieved by the Supplier through paying AWS for reserved instances.”.

Schedule 2 – Call-Off Contract charges shall be amended by the addition of new clauses 1d and 1e as follows:

“d. The charge for April 2021 shall be increased by £44,954.00 (ex VAT) in recognition of the Supplier making a payment to AWS for reserved instances.

e. The charge for March 2022 shall be reduced by £73,333.00 (ex VAT) in recognition of the savings achieved by the Supplier through paying AWS for reserved instances.”

Words and expressions in this Variation shall have the meanings given to them in the Call Off Contract.

The Call Off Contract, including any previous Variations, shall remain effective and unaltered except as amended by this Variation.
