# **Section 1: The Invitation**

This procurement is being carried out by Defra group Commercial in accordance with the Open Procedure as set out in the Public Contract Regulations 2015 ("PCR") on behalf of the Animal & Plant Health Agency ("APHA").

The Bidder Pack comes in two parts. The first part, The Core Requirements, provides details of the General Requirements, Government Transparency Agenda and Government Priorities. This, **the second part**, **the Procurement Specific Requirements**, provides details of the Specification Requirements, Terms and Conditions of Contract, Evaluation Methodology, Procurement Timetable and Definitions.

The tendering process seeks to determine capable bidders that pass both the Qualification and Technical evaluations in order to award multiple suppliers a place on the Framework. The Authority will evaluate the Tenders using the tender evaluation criteria and weightings listed in Section 4, Evaluation Methodology.

# **The Opportunity**

The Department for Environment, Food and Rural Affairs (the "**Authority**") has responsibility for improving and protecting the environment. We aim to grow a green economy and sustain thriving rural communities. We also support our world-leading food, farming and fishing industries.

APHA has a critical role in the control and eradication of endemic and infectious diseases, most notably bovine tuberculosis ("**TB**"). The scale of infection and the associated costs make TB one of the biggest challenges that the livestock farming industry faces, particularly in the west and southwest of Great Britain ("**GB**"). The costs of TB control measures for Government are also significant. The Government is committed to eradicate bovine TB to support the food and farming industry and reduce costs for farmers and taxpayers. TB testing and Reactor Removal plays a crucial role in identifying infected herds and controlling TB, thus helping to reduce further spread of the disease.

The following United Kingdom (UK) public sector bodies will be authorised to use the resulting framework agreement: the Department for Environment Food & Rural Affairs, the Animal and Plant Health Agency ("APHA"); the Scottish Government; and the Welsh Government.

The specification sets out the requirements in full, but by way of summary, this requirement is for the provision of management, collection, slaughter, salvage and disposal of farmed livestock for TB control purposes (we often refer to these services as "Reactor Removal"). The requirement is separated into different sections, with each section referred to as a "Lot". You can bid for one, two or all three Lots depending on what you want to supply to us. The three Lots are summarised in the table below.

All timescales are set using a 24-hour clock and when referring to "days" it means calendar days unless otherwise specified (for example, working days).

#### **Variant Tenders**

The Authority shall not accept variant Tenders.

For the avoidance of doubt, if the Authority has reserved a right to waive a requirement in this Bidder Pack and chooses to exercise such discretion, the Tender will not be considered a variant Tender.

#### **Abnormally Low Tenders**

If the Authority considers your Tender to appear abnormally low, an initial assessment will be undertaken using a comparative analysis of the pricing proposals received from all Tenderers and the Authority's valuation of the procurement. If that assessment indicates that your Tender is abnormally low, the Authority will request a written explanation of your Tender, or of those parts of your Tender which the Authority considers contribute to your Tender being abnormally low. The Authority reserves the right to reject your Tender if the response does not satisfactorily account for the low level of price or costs proposed.

The assessment of abnormally low tenders will be undertaken strictly in accordance with Regulation 69 of the Public Contracts Regulations 2015, which outlines how abnormally low tenders must be assessed and the circumstances in which the contracting authority can reject the tender.

## **Pricing Anomalies**

If in the opinion of the Authority your Tender contains any pricing anomalies (for example apparent discrepancies between the financial submission and other parts of your response) the Authority may seek clarification. If the clarification response indicates that the pricing anomaly was the result of a clear and obvious error, in the interest of fairness the resulting change will be taken into consideration. If the clarification response results in a change to the initial tendered Commercial Response and price, it will not be taken into account.

# **Section 2: The Specification of Requirements**

Appendix 3 sets out the Specification of Requirements.

### **Division of the Contract into Lots**

This procurement is sub-divided into three Lots as set out in the Specification of Requirements. Tenderers must make clear which Lot they are bidding for. Each Lot will be evaluated separately in accordance with the details set out in Section 4: Evaluation Methodology.

The Authority is seeking to appoint multiple suppliers and intends to appoint all Tenderers who meet the required technical standards (in accordance with Section 4: Evaluation Methodology) for each Lot onto the Framework. There is no maximum limit on the number of suppliers that can be awarded a place on the Framework, for either Lot.

There are no limits on the number of Lots in which any one Tenderer can be awarded and if a Tenderer is successful in more than one Lot, the Authority may enter into a single Framework Agreement for all Lots awarded to that Tenderer.

# Section 3: Terms and Conditions of Contract

The Terms and Conditions of the Framework Agreement and resulting Call-Off Contracts for this procurement are contained within the Atamis portal.

The Authority proposes to enter into a Framework Agreement for a maximum period of four years with the successful Tenderer(s). The initial framework term shall be four years with no potential for extension.

The anticipated commencement date is: On or before: 1 February 2025 (subject to change).

#### Suggested Changes to Conditions of the Framework Agreement or Calloff Contract

Tenderers may raise clarification questions relating to the amendment of the Framework Agreement or Call-Off Contract terms during the clarification period only, as specified in the Timetable, if it can be demonstrated that there is a legal or statutory reason why they cannot be accepted. Where a legal or statutory reason cannot be substantiated the Authority has the right to reject the proposed changes.

Such requests must follow the Clarifications Sought by the Tenderer process set out in the Core Requirements element of this Bidder Pack.

# **Section 4: Evaluation Methodology**

The overall aim of the evaluation process is to appoint tenderers to the Framework Agreement on terms that are economically advantageous to the Authority, having regard to the Authority's overall objectives and the criteria set out below. Whilst the Authority is seeking to appoint as many contractors as possible to the Framework Agreement, the award of specific Call-Off Contracts is subject to the methodology set out in the specification of requirement in section 18, the text in section 18 of the specification is also replicated in Schedule 4 of the Framework Agreement.

Evaluation of Tenders will comprise of the stages set out in the tables below.

The Authority will carry out its evaluations of the Technical and Commercial elements according to the criteria, sub-criteria and weightings set out in the tables below.

The Technical evaluation will account for 60% of the total score for each Lot. In each Lot, for each technical question that is passed, a score of 100 will be awarded, the score of 100 will then be multiplied by the weighting stated above to arrive at a technical score for that question. All responses will be scored in accordance with the detailed guidance within the Authority's eSourcing System.

To ensure that all Tenderers appointed to the Framework meet the minimum technical standards, under the technical criteria for Lot 1, Tenderers must achieve a pass score in questions E01 to E04 in order to progress to the Commercial Evaluation.

To ensure that all Tenderers appointed to the Framework meet the minimum technical standards under the technical criteria for Lot 2, Tenderers must achieve a pass score in questions E05 to E08 in order to progress to the Commercial Evaluation.

To ensure that all Tenderers appointed to the Framework meet the minimum technical standards, under the technical criteria for Lot 3, Tenderers must achieve a pass score in questions E09 to E10 in order to progress to the Commercial Evaluation.

The Commercial evaluation will account for 40% of the total score. All responses will be scored in accordance with the criteria set out below.

Prices will be separately evaluated for each Lot.

The price used for evaluation is the price calculated in the pricing workbooks final sheet entitled *price* for evaluation.

A score of 100 will be awarded to the Tenderer which submits the lowest price for evaluation. The remaining Tenderers will receive scores on a pro rata basis from the lowest to the highest price. This will be used to calculate the weighted commercial score using the following mechanism (for this example we have used 40% as the Commercial Weighting):

Score = Lowest Tender Price / Tender Price x 40%

For example, if three Tenders are received and Tenderer A has £3,000 as their total price, Tenderer B has £5,000 and Tenderer C has £6,000 then the calculation will be as follows:

Tenderer A Score = £3000/£3000 x 40% (Maximum available marks) = 40

Tenderer B Score = £3000/£5000 x 40% (Maximum available marks) = 24

Tenderer C Score = £3000/£6000 x 40% (Maximum available marks) = 20

#### Evaluation Criteria: Qualification Stage (Selection Questionnaire) - Financial Standing

The Authority will review the economic information provided as part of the Selection Questionnaire response to evaluate a Tenderer's economic and financial standing. The Authority's evaluation will be based on all the information reviewed and will not be determined by a single indicator. If, based on its assessment of the information provided in a Response, the Authority decides that a Tenderer does not meet the Authority's required level of economic standing, the Authority may:

- ask for additional information, including information relating to the Tenderer's parent company, if applicable; and/or
- require a parent company guarantee, performance bond or other security.

If the Authority decides that a parent company guarantee, performance bond or other security is required, the Authority will reject a Response if the Tenderer is unable to offer a commitment to make such provision. In addition to the information provided in a Response, the Authority may, at its discretion, consult Dun & Bradstreet reports and other credit rating or equivalent reports depending on where a Tenderer is located.

The Authority's assessment of economic and financial standing will consider financial strength and risk of business failure. Financial strength is based on tangible net worth and is rated on

a scale of 5A (strongest) to H (weakest) obtained from Dun & Bradstreet. There are also classifications for negative net worth and net worth undetermined (insufficient information). Financial strength will be assessed relative to the estimated annual contract value.

The Authority will also consider annual turnover. For this procurement, the Authority expects the contractor to have an annual turnover for each of its last two financial years of at least £100,000.

In the case of a joint venture or a consortium bid, the annual turnover is calculated by combining the turnover of the relevant organisations in each of the last two financial years. In addition, the annual turnover of at least one of those organisations is expected to be £100,000.

Risk of Business Failure is rated on a scale of 1 (minimal) to 4 (significant) obtained from Dun & Bradstreet. There is also a classification of insufficient information. The Authority regards a score of 4 as indicating inadequate economic and financial standing for this procurement. The Authority will also calculate and evaluate the Tenderer's:

- operating performance: growth or reductions in sales, gross profit, operating profit, profit before tax and earnings before interest, tax, depreciation, amortisation, exceptional items and profit/loss on sale of businesses;
- liquidity: net current assets, movements in cash flow from operations, working capital and quick ratios, and average collection and payments periods; and
- financial structure: gearing ratios and interest cover.

## **Evaluation of Responses**

Evaluation of Responses will be undertaken by a panel appointed by the Authority. Each panel member will first undertake an independent evaluation of the Responses applying the relevant evaluation criteria for each question. Then, a moderation meeting will be held at which the evaluation panel will reach a consensus on the marking of each question.

During the consensus meeting, the decision may be taken that a Response will not be carried forward to the next evaluation stage if the consensus view is that the Tenderer has failed to meet any minimum or mandatory requirements, and/or provided a non-compliant response.

# **Scoring Criteria**

The following scoring criteria is to be used when evaluating responses to Stage 4 Technical Questionnaire. A Tenderer's response will be assessed against the detailed criteria provided for each question and be assigned a Descriptor and score from the table below.

For Questions E01 to E10:

Descriptor	Definition

#### **Calculation Method**

For both elements, providing the Tenderer has met any mandatory criteria and minimum quality thresholds, the total weighted scores are calculated as follows:

#### **Technical Score (WT)**

$$\frac{Tenderer's \ Total \ Technical \ Score}{Highest \ Technical \ Score} \ x \ 100 = X \qquad then: \qquad \frac{X}{100} \ x \ 60 = WT$$

# **Commerical Score (WC)**

$$\frac{Lowest\ Commercial\ Score}{Tenderers\ Total\ Commercial\ Score}\ x\ 100 = X \qquad then: \qquad \frac{X}{100}\ x\ 40 = WC$$

The Total Score (weighted) is then calculated by adding the Total Weighted Technical Score to the Total Weighted Commercial Score: **WT + WC**.
