II.1.5) Short description of the contract or purchases(s):

BRACE II builds on lessons learned in a two year BRACE I pilot project phase which ended in July 2015. The approach adopted in that programme was food and cash for assets. BRACE II is an approved five year programme that intends to leverage long term positive change in community food security and livelihoods - by making these more resilient to climate variability and extremes and localised resource conflicts. It will do this through creation and enhancement of shared community assets. The first two and a half years are funded through the UK Government's Climate Fund - this covers various components of the programme. This PIN and potential tender and any contracts awarded will be for an initial 30 months. Continuation beyond 30 months will depend on a review of performance at the two year stage - and subject to approval of further funding. The geographical focus is five states: BRACE II will remain operational in the three previous programme states of Western Bahr el Ghazal, Northern Bahr el Ghazal and Warrap. It will extend into two new states -- possibly Lakes and Eastern Equatoria. This call to competition covers these two additional states only. The programme will be independently monitored and evaluated - partners will be expected to work in close collaboration with an external service provider. The desired outcome is increased capacity to absorb, anticipate and adapt to climate variability and extremes. Expected changes are A) Communities adopt practices that improve management of their natural resources which results in more secure livelihoods and less communal conflict B) Up to 400,000 people work together to improve and maintain their shared agricultural and natural resource assets and C) Effective community participation in asset and skills building. This programme will address immediate food insecurity which has been increased by the current crisis. Hunger and famine will be averted. Communities will receive a variety of support that improves their resilience against climate damage to agricultural assets. This will improve protection and management of the

environment so that food production is better able to withstand disasters. Indirectly, collective community work will also increase social cohesion. The programme will be evaluated by an independent service provider who will provide real time feedback to suppliers. This is intended to ensure that the programme levers positive impact and is responsive and accountable to community voices.
