1 SITE INFORMATION

1.1 Site boundary, extents and access arrangements

The following surveys are required:

- Cores
- DCP

At the following locations:

- A1 Northbound dual carriageway including slip roads
 - Marker Post 120/9 to 133/2
 - OS Grid References 473891, 370987 to 464762, 378197 to Refer to Location Plan HE607429-KIER-GEN-A1_A_TUXFORD_Z-DE-Z-0000-01 Location Plan.

1.2 Pavement

The existing carriageway construction is anticipated to be typical highway construction for trunk roads.

1.3 Drainage

There are highway drainage assets throughout the extents.

1.4 Geotechnical

Works are confined to the carriageway.

1.5 Soft Estate and Environment

An Environmental Impact Assessment has been requested and will be made available.
