Executive Summary

UK Shared Business Services Ltd (UK SBS) on behalf of UK Research and Innovation (UKRI), wishes to establish a Contract for the purchase of several thousand Hybrid circuits for Atlas Upgrade (plus an optional extra for a noncommittal additional 20% to be ordered within the lifespan of the contract) as per the specification below.

UK SBS is managing this procurement process in accordance with the Public Contracts Regulations 2015 (as may be amended from time to time) (the "Regulations").

This is a Supplies Contract being procured under the Open OJEU Procedure regulations.

This RFP sets out details of the Contract and expectations of any successful supplier.

This Contract will be awarded to a sole supplier.

An additional tender will be held for the SMD population of these circuits, the winning bidder of each tender will be required to work together ensuring the production schedule in maintained.


ITk Barrel Strip Hybrid X Flex Circuit Array Specification

Ver:1.0 Rev A 25/02/2020

This specification is common across the flexible circuits ABCStar Hybrid X and associated test coupons ITk Barrel QC Coupon and ITk Barrel QA Coupon that are contained within an 8-Up array.

Details

The circuits come as 4-layer flexes using the DuPont Pyralux family of materials, with a mix of microvias and precision non-plated through-holes. The circuits are to be fabricated in accordance to IPC-6011/6013 Class 3, their material usage and stack-up (top-down) is as shown below:



Double-sided Cu core etched to single-sided Cu layer

It is important to note that the copper thicknesses shown above are finished thickness after plating. The tolerance on these thicknesses should meet Class 3 minimum specification and should match the following:

- For the outer layers, L1 and L4, the nominal finished thickness is 38μm.
- $\bullet~$ For the internal layers, L2 and L3, the nominal finished thickness is 14 μm .

Nominal finished build thickness, excluding top layer solder resist, is \sim 375 μ m \pm 10%.

Further circuit requirements

- Via hole finished size is a mix of 125μm and 150μm diameters
 - O Micro-via L2-L3 with plating thickness of minimum 20μm
 - o With filled micro-vias on L1 L2 and L4 L3
- One precision non-plated laser cut through hole of 2.55mm (±40μm tolerance).
- The surface finish is Electroless Nickel Immersion Gold (ENIG) to IPC Spec 4552.
- Solder-resist is required to both sides with full coverage on the back, colour Green of nominal thickness of 20µm.
 - Also required is a Peelable solder mask, Peters SD 2955 of ≤150µm thickness, applied to top surface only.
- Silkscreen to top side only, colour white.

- Circuit routing/profiling is to be by laser.
- The circuit bonding and lamination stage is to follow the procedure of the top side being pressed against a stainless-steel separator with conforming materials used only on the back/bottom side.

Controlled Impedance Requirements

- $100\Omega \pm 10\%$ differential Edge-coupled Microstrip geometry on the top layer referenced to adjacent Inner Layer 1.
 - o Test coupon and measurement certification to be provided by the manufacturer.




Circuit Array Specification and Identification

The circuits come as an 8-up array, measuring 265 x 118mm, composed of 6 x ABCStar Hybrid X's and one of each test coupon ITk Barrel QC Coupon and ITk Barrel QA Coupon respectively. Their orientation and placement can be found in the mechanical drawing: ITk Barrel Strip Hybrid X Array Ver 2.0 Mechanical Drawing.pdf

Both the array and circuits within are to come with a unique human readable screen-printed identifier which is to be added to the top surface on areas of non-exposed Cu only. Their format is to be in the form of Date Code <xxxx>, Panel ID <xxxxx> (this refers to the 18 x 12" standard manufacturers panel) and Array ID <A-C> (3 arrays per panel). 





ITk Barrel Strip Hybrid X & Y Flex Circuit In-House Quality Control

Ver:1.0 Rev A 25/02/2020

This document describes the Quality Control (QC) steps involved in the acceptance of bare circuits from the manufacture and their QC following surface mount assembly involving a Lead-Free Solder Reflow process.

Details

All circuit arrays will be obliged to follow a QC procedure to ensure their suitability both before and after SMD attachment. The steps involved are as follows:

Pre-SMD attachment – Hybrid array per production batch

Metrology of fiducials within individual hybrids to confirm their positioning is correct, this will be performed on 10% of arrays within the batch. It is planned to target the fiducials within the circuit to be able to identify any deviation in fiducial positioning that is outside the allowed linear tolerance of ± 0.1 mm.

Pre-SMD attachment – QC Test Coupon per circuit array

- 1. Measurement of test coupon thickness to confirm that it matches specification at a predefined point.
- 2. Metallisation of the circuits and their suitability for AL Wedge wire-bonding will be confirmed by the placement of 100 wire-bonds with source-destination added linearly to facilitate pull testing on a pre-defined area of the coupon. The specification is for >5g for all bonds with a mean strength >8g (SD 1.5g) with 90% heel breaks.
- 3. Automated 4-wire (Kelvin) resistance measurement of the 5 via chains within the test coupon checking that there are no open-circuits are high resistance ($>2\Omega$).
- 4. The test coupon will then be thermally stressed to try to identify failing vias within a via chain. The test procedure will involve the coupon being exposed to a standard Lead-free reflow soldering profile over 3 cycles with a cool down period of >10 minutes per cycle. To be then followed by a repeated 4-wire resistance measurement on the 5 via chains, where a failing via chain is identified as one which shows >10% increase in resistance or open-circuit when compared to the pre-reflow measurement. Any failing via chains will then be referred to the circuit manufacture for further investigation.

Pre-SMD attachment – QA Test Coupon per circuit array

This will follow a modified version of the QC steps 1-4 as outlined above plus an additional step:

- 1. As above.
- 2. As above.
- 3. As above.
- 4. Not done.
- 5. Capacitance measurement of 3 parallel plate structures embedded within the coupon and compare against expectation to confirm correct dielectric thicknesses are being used.

Successful completion of the fore-mentioned QC steps will allow for the circuit arrays to proceed for SMD passive attachment. Prior to their shipment the QC test coupon will be removed from the array whilst the QA test coupon will remain for additional QC upon the circuits return.

Post-SMD attachment – QA Test Coupon per circuit array

The received QA test coupon will be subjected to the following QC steps:

- 1. Visual inspection of ALL circuits checking component placement, their alignment and for solder splash contamination of bond pads and ASIC lands.
- 2. Check of build thickness of coupon at predefined point and compare to pre-flow value. The measured value should be within the specification of nominal thickness ±10%.
- 3. Perform wire-bond pull test at dedicated bond off pad with 100 bonds, as outlined above.
- Automated 4-wire Kelvin) resistance measurement of the 5 via chains and compare the data against the Pre-SMD measurement. Checking for failing vias, as described in 3. in the Pre-SMD attachment – QC Test Coupon per circuit array QC procedure.
- 5. Capacitance measurement of 3 parallel plate structures embedded within the coupon to check for delamination, with a reduction of 5% in the measured capacitance when compared against the pre-reflow measurement requiring further investigation.

Quantities and Delivery Phases

Procurement phases:

- 1. Pre-production of 5% of the total nominal number of hybrids.
- 2. If pre-preproduction hybrids pass our requirements and are deemed to be of sufficient quality, then a subsequent production order of 95% of the nominal total value of hybrids will be placed.
- 3. A potential follow on order may be placed should there be unexpected component losses in the wider international project.

Quantities Required:

We require the quantities of hybrids specified in the table below for procurement phases 1 and 2. For procurement phase 3 we may opt to order up to the number specified if required. The scheduling of X or Y hybrids to be ordered during the procurement phases will be discussed with us so that we can coordinate production within the broader context of the international project we are working on.

Conditions of Contract

- 1. If two test-structures on two test coupons from two differing circuit arrays, within a drop, show similar failure mode will require intervention by the vendor for further investigation.
- 2. Arrays will be rejected if both test coupons fail the manufacture QC.
- 3. We require a circuit yield on a panel to be at least 90% or rounded to the nearest integer number of circuits.
- 4. We require 95% of good circuits tested in a drop to pass our QA/QC process, as specified. Drops failing to meet this requirement will be rejected and we will require intervention and dialogue with the vendor to understand how to mitigate the issue(s).
- 5. If the number of arrays passing the previous constraints, and our QA/QC, in a production batch falls below two thirds then we reserve the right to reject that entire batch.

6. The designs provided are based on what is currently known at the moment and STFC reserves the right to undertake any modifications which may become apparent during the design phase of the contract.

Contract Duration

The Contract duration shall be for a period of 37 months.

Terms and Conditions

Bidders are to note that any requested modifications to the Contracting Authority Terms and Conditions on the grounds of statutory and legal matters only, shall be raised as a formal clarification during the permitted clarification period.

Section 5 – Evaluation model

Award Evaluation of criteria

Non-Price elements

Each question will be evaluated on a score from 0 to 100, which shall be subjected to a multiplier to reflect the percentage of the evaluation criteria allocated to that question.

Where an evaluation criterion is worth 20% then the 0-100 score achieved will be multiplied by 20%.

Where the scoring criterion is worth 50% then the 0-100 score achieved will be multiplied by 50

In the example if a supplier scores 80 from the available 100 points this will equate to 40% by using the following calculation: Score/Total Points multiplied by 50 ($80/100 \times 50 = 40$)

The lowest score possible is 0 even if the price submitted is more than 100% greater than the lowest price.

- 7.9.9. Responses received after the date indicated in <u>Section 3</u> shall not be considered by the Contracting Authority, unless the Bidder can justify that the reason for the delay is solely attributable to the Contracting Authority
 - 7.9.9.1. The Bidder must demonstrate irrefutable evidence in writing they have made best endeavours to ensure the Response was received on time and that the issue was beyond their control.
 - 7.9.9.2. Any request for a late Response to be considered must be emailed to the Buyer in <u>Section 3</u> in advance of 'the deadline' if a bidder believes their Response will be received late.
 - 7.9.9.3. The Contracting Authority reserves the right to accept or reject any late Response without justification to the affected Bidder and make no guarantee it will consider any request for a late Response to be considered.
- 7.9.10. Do not seek changes to the Bid after responses have been submitted and the deadline (date and time) for receipt of responses has passed.

7.10. Canvassing

7.10.1. Any Bidder who directly or indirectly canvasses any employee, or agent of UK SBS, the Contracting Authority or its members or any relevant OPB or any of its employees concerning the establishment of the Contract or who directly or indirectly obtains or

attempts to obtain information from any such officer, member, employee or agent or concerning any other Bidder, Response or proposed Response will be disqualified.

7.11. Disclaimers

- 7.11.1. Whilst the information in this RFP, Due Diligence Information and supporting documents has been prepared in good faith, it does not purport to be comprehensive nor has it been independently verified.
- 7.11.2. Neither UK SBS, the Contracting Authority, nor any relevant OPB's nor their advisors, nor their respective directors, officers, members, partners, employees, other staff or agents:
 - 7.11.2.1. makes any representation or warranty (express or implied) as to the accuracy, reasonableness or completeness of the RFP; or
 - 7.11.2.2. accepts any responsibility for the information contained in the RFP or for their fairness, accuracy or completeness of that information nor shall any of them be liable for any loss or damage (other than in respect of fraudulent misrepresentation) arising as a result of reliance on such information or any subsequent communication.
- 7.11.3. Any persons considering making a decision to enter into contractual relationships with the Contracting Authority and/or, as applicable, relevant OPB following receipt of the RFP should make their own investigations and their own independent assessment of the Contracting Authority and/or, as applicable, relevant OPB and its requirements for the supplies and services and should seek their own professional financial and legal advice. For the avoidance of doubt the provision of clarification or further information in relation to the RFP or any other associated documents (including the Schedules) is only authorised to be provided following a query made in accordance with Paragraph 7.15 of this RFP.

7.12. Collusive behaviour

7.12.1. Any Bidder who:

- 7.12.1.1. fixes or adjusts the amount of its Response by or in accordance with any agreement or arrangement with any other party; or
- 7.12.1.2. communicates to any party other than UK SBS, the Contracting Authority or, as applicable, relevant OPB the amount or approximate amount of its proposed Response or information which would enable the amount or approximate amount to be calculated (except where such disclosure is made in confidence in order to obtain quotations necessary for the preparation of the Response or insurance or any necessary security); or
- 7.12.1.3. enters into any agreement or arrangement with any other party that such other party shall refrain from submitting a Response; or
- 7.12.1.4. enters into any agreement or arrangement with any other party as to the amount of any Response submitted; or
- 7.12.1.5. offers or agrees to pay or give or does pay or give any sum or sums of money, inducement or valuable consideration directly or indirectly to any party for doing or having done or causing or having caused to be done in relation to any other Response or proposed Response, any act or omission,

shall (without prejudice to any other civil remedies available to the Contracting Authority and without prejudice to any criminal liability which such conduct by a Bidder may attract) be disqualified.

7.13. No inducement or incentive

7.13.1. The RFP is issued on the basis that nothing contained in it shall constitute an inducement or incentive nor shall have in any other way persuaded a Bidder to submit a Response or enter into the Contract or any other contractual agreement.

7.14. Acceptance of the Contract

- 7.14.1. The Bidder in submitting the Response undertakes that in the event of the Response being accepted by the Contracting Authority and the Contracting Authority confirming in writing such acceptance to the Bidder, the Bidder will within 7 of being called upon to do so by the Contracting Authority execute the Contract in the form set out in the Contract Terms or in such amended form as may subsequently be agreed.
- 7.14.2. The Contracting Authority shall be under no obligation to accept the lowest priced or any Response.

7.15. Queries relating to the Response

- 7.15.1. All requests for clarification about the requirements or the process of this procurement shall be made in through the e-sourcing tool unless where the e-sourcing tool is unavailable due to Delta eSourcing system maintenance or failure, in this instance all clarifications shall be by email to the contact defined in Section 3.
- 7.15.2. The Contracting Authority will endeavour to answer all questions as quickly as possible but cannot guarantee a minimum response time.
- 7.15.3. In the event of a Bidder requiring assistance uploading a clarification to the esourcing portal they should use the contact details defined in <u>Section 3</u>.
- 7.15.4. No further requests for clarifications will be accepted after 7 days prior to the date for submission of Responses.
- 7.15.5. In order to ensure equality of treatment of Bidders, the Contracting Authority intends to publish the questions and clarifications raised by Bidders together with the Contracting Authority's responses (but not the source of the questions) to all participants on a regular basis.
- 7.15.6. Bidders should indicate if a query is of a commercially sensitive nature where disclosure of such query and the answer would or would be likely to prejudice its commercial interests. However, if the Contracting Authority at its sole discretion does not either; consider the query to be of a commercially confidential nature or one which all Bidders would potentially benefit from seeing both the query and the Contracting Authority's response, the Contracting Authority will:
 - 7.15.6.1. invite the Bidder submitting the query to either declassify the query and allow the query along with the Contracting Authority's response to be circulated to all Bidders; or
 - 7.15.6.2. request the Bidder, if it still considers the query to be of a commercially confidential nature, to withdraw the query prior to the end of the closing date and time for Bidder clarifications.

7.15.7. The Contracting Authority reserves the right not to respond to a request for clarification or to circulate such a request where it considers that the answer to that request would or would be likely to prejudice its commercial interests.

7.16. Amendments to Response Documents

7.16.1. At any time prior to the deadline for the receipt of Responses, the Contracting Authority may modify the RFP by amendment. Any such amendment will be numbered and dated and issued by the Contracting Authority to all prospective Bidders. In order to give prospective Bidders reasonable time in which to take the amendment into account in preparing their Responses, the Contracting Authority may, at its discretion, extend the time and/or date for receipt of Responses.

7.17. Modification and withdrawal

- 7.17.1. Bidders may modify their Response where allowable within the e-sourcing tool. No Response may be modified after the deadline for submission of Responses.
- 7.17.2. Bidders may withdraw their Response at any time prior the deadline for submission of Responses [or any other time prior to accepting the offer of a Contract]. The notice to withdraw the Response must be in writing and sent to the Contracting Authority by recorded delivery or equivalent service and delivered to the Head of Policy UK SBS at UK Shared Business Services Ltd, Procurement, Polaris House, North Star Avenue, Swindon, Wiltshire, SN2 1ET

7.18. Right to disqualify or reject

- 7.18.1. The Contracting Authority reserves the right to reject or disqualify a Bidder where
 - 7.18.1.1. the Bidder fails to comply fully with the requirements of this Request for Proposal or presents the response in a format contrary to the requirements of this document; and/or
 - 7.18.1.2. the Bidder is guilty of serious misrepresentation in relation to its Response; expression of interest; or the Response process; and/or
 - 7.18.1.3. there is a change in identity, control, financial standing or other factor impacting on the selection and/or evaluation process affecting the Bidder.

7.19. Right to cancel, clarify or vary the process

- 7.19.1. The Contracting Authority reserves the right to:
 - 7.19.1.1. cancel the evaluation process at any stage; and/or
 - 7.19.1.2. require the Bidder to clarify its Response in writing and/or provide additional information. (Failure to respond adequately may result in the Bidder not being selected).

7.20. Notification of award

- 7.20.1. The Contracting Authority will notify the successful Bidder of the Contract award in writing and will publish an Award Notice in the Official Journal of the European Union in accordance with the Regulations within 30 days of the award of the contract.
- 7.20.2. As required by the Regulations all successful and unsuccessful Bidders will be provided with an email advising the outcome of the submission of their RFP response.
