1. Terminal Points

2. Stopping Arrangements

All buses operating on the Services must serve all stops on the line of route designated for the route.

Drivers must pick up/set down at all bus stops where passengers wish to board and/or alight. If a driver is certain no passengers wish to board or alight, they may continue. If the driver is in any doubt, they must stop.

Limes Farm Estate Stand

Stand for 1 bus on Copperfield, on south side (westbound) between footpath adjacent to No.16 and footpath adjacent to No.18 85 metres east of Amanda Close.

Buses proceed from Copperfield to stand, departing to Copperfield.

Set down in Copperfield, Z (BP6102 - Limes Farm / Copperfield) and pick up in Copperfield, Z (BP6102 - Limes Farm / Copperfield).

AVAILABILITY:	At any time.
OPERATING RESTRICTIONS:	No more than 1 bus on Route 462 should be scheduled to stand at any one time.

Grange Hill, Manford Way (from Ilford High Road, Hainault Street)

Set down in Manford Way, at Stop C (BP740 - Manor Road / Grange Hill Station) and pick up in Manford Way, at Stop D (BP739 - Manor Road).

Hainault, the Lowe (from Ilford High Road, Hainault Street)

Public stand for one bus on north side of Manford Way, commencing opposite party wall of Nos 198/200 and extending 19 metres west.

Buses proceed from Elmbridge Road, New North Road, Kielder Close, Manford Way to stand, departing to Manford Way.

Set down in Elmbridge Road, at stop at Elmbridge Rd (BP6046 - Elmbridge Road) and pick up in Manford Way, at stop Z (35437 - The Lowe).

AVAILABILITY:	At any time.
OPERATING RESTRICTIONS:	No more than 1 bus on Route 462 should be scheduled to stand at any one time.

Barkingside High Street (from Ilford High Road, Hainault Street)

Public stand for three buses on east side of Barkingside High Street, commencing opposite the party wall of Nos 155/157 and extending 33 metres north.

From Limes Farm Estate

Buses proceed from Barkingside High Street to stand, departing via Barkingside High Street, Baron Gardens, Craven Gardens, Tanners Lane to Barkingside High Street.

Set down in High Street, at stop D (20198 - Fullwell Cross) and pick up in High Street, at stop A (34310 - Fullwell Cross).

From ILFORD HIGH ROAD, HAINAULT STREET

Buses proceed from Barkingside High Street, Fullwell Cross, Barkingside High Street to stand, departing to Barkingside High Street.

Set down in High Street, at stop A (34310 - Fullwell Cross) and pick up in High Street, at stop D (20198 - Fullwell Cross).

Gants Hill Station (from Limes Farm Estate)

Buses proceed from Woodford Avenue direct to stand.

Set down in Woodford Avenue, at Stop WQ (13450 - Gants Hill Station / Woodford Avenue) and pick up in Woodford Avenue, at Stop WS (13449 - Gants Hill Station / Woodford Avenue).

Set down in Cranbrook Road, at stop D (FC46 - Ilford Station) and pick up in Cranbrook Road, at stop H (FC42 - Beal Road).

AVAILABILITY:	At any time.
OPERATING RESTRICTIONS:	Turning Point Only - Buses must not stand
BLIND DISPLAY:	Ilford Station.

Ilford, Hainault Street

Private stand for 18 buses standing abreast in marked bays in Bus Parking Area on east side of Hainault Street, with the first 4 bays (nearest entrance) restricted to midi- buses.

Buses proceed from Ilford High Road, Hainault Street to stand, departing via Ley Street, Griggs Approach, Winston Way, Riches Road to Ilford High Road.

Set down in High Road, at Stop S (R0868 - Hainault Street) and pick up in High Road, at Stop W (FC04 - Hainault Street).

AVAILABILITY:

At any time.

OPERATING RESTRICTIONS:

No more than 1 bus on Route 462 should be scheduled to stand at any one time.

MEAL RELIEFS:

No meal relief vehicles to stand at any

* For this Route Agreement, clause 46 of Annex B of the Framework Agreement shall be deleted in its entirety and replaced by the following clause:

“46. INCENTIVE PROVISIONS

46.1 The provisions contained in this Route Agreement in relation to Performance Payments only and not the Contract Extension Criteria shall for the purposes of this clause 46 be referred to as the “Incentive Provisions”.

46.2 The following Contract Extension Criteria provisions shall not apply to this Route Agreement:

46.3.1 clause 2 and clause 44.2; and
46.3.2 Schedule IX in its entirety.

All other provisions of the Route Agreement shall continue to apply provided that where any other part of the Route Agreement relates to or can reasonably be inferred as relating to clauses 46.3.1 or 46.3.2 or any part thereof, such parts shall apply mutatis mutandis.”

6. Spare Vehicle – The Operator shall ensure that the following number of spare vehicles, which are specified in Schedule IIA Part 1, are available for the provision of the Services. 1
7. Existing Vehicles – The Operator shall ensure that all vehicles entering service on this route undergo refurbishment to the April 2021 Refurbishment Specification prior to entering service.
8. Route Risk Assessment - The Corporation acknowledges receipt of the Route Risk Assessment pertaining to route 462.
9. Contract Price Adjustment – applied from Tranche 730 onwards:

Paragraph 9.2.2 is deleted and replaced by the following:

The percentage price adjustment (R) is a 12-month rolling average given by:

-

$$R = W \times \frac{1}{12} \times \sum_{i=1}^{n=12} \frac{P_{i+1} - P_{i+13}}{P_{i+13}}$$

Where:

W = 0.85 representing the proportion of the Contract Price that is to be adjusted by movement in the Consumer Price Index.

P_{i+1} = The Consumer Prices Index published for the month that is i+1 month prior to the anniversary of the Date of Tender as set out in Table 462BT published by the Office for National Statistics (ONS).

P_{i+13} = The Consumer Prices Index published for the month that is i+13 months prior to the anniversary of the Date of Tender as set out in Table 462BT published by the Office for National Statistics (ONS).

For the avoidance of doubt 15% of the prevailing Contract Price is non- adjustable.

10. In accordance with the award letter dated 31 July 2023, this contract may be extended by one further year, subject to mutual agreement. The Corporation will serve a minimum of one year's notice prior to the end of the six-year term.
