2024 SPONSORSHIP AGREEMENT

1. The Conference

- 2.3 The Sponsor may be responsible for Conference marketing and/or hotel expenses incurred as a result of special programs requested by the Sponsor.
- 3. Term & Termination
- 3.1 This Agreement will become effective upon its signature by both parties and, subject to this Section 3, will continue until Crain has provide Sponsor with the full sponsorship benefits related to the Conference(s). Due to the unique nature of the sponsorship benefits to be received by Sponsor under this Agreement, Sponsor and Crain agrees that neither may terminate or assign this Agreement except as provided in this Section or unless the parties mutual agree to modify this Agreement and incorporate the changes in a document signed by both parties.

3.2 In the event that Crain cancels or delays the Conference(s) or is not able to provide all of the sponsorship benefits as scheduled due to force majeure reasons or business conditions that make it inadvisable to hold the Conference as scheduled, Crain shall notify Sponsor in writing as soon as possible. Crain, as its sole obligation as to any such cancellation or delay, will have the option to provide Sponsor with the sponsorship benefits at a later time or in an alternative manner (such as, but not limited to, through use of a virtual event, custom programs or webinars, etc.). If Crain is not able to provide the full sponsorship benefits within 6 months, Crain will provide Sponsor a Pro Rata Credit (based on the value of the sponsorship benefits not received by Sponsor) which may be used by Sponsor for future events or advertising. At the request of Sponsor, Crain will provide a cash refund of the Pro Rata Credit within 15 days.

3.3 Additionally, either party shall have the right at any time to terminate this Agreement immediately for cause by giving written notice to the other party in the event that other party has committed a material breach (which is not due to force majeure circumstance) of any of its material obligations under this Agreement (including failure to timely pay the Sponsorship Fee) and breaching party does not remedy such breach within 20 days of receipt of the written notice, to the event this Agreement is terminated by Sponsor due to breach by Crain, Sponsor will receive a Pm Rata Credit, and may apply the Pro Rata Credit to future events or advertising or request a cash refund. In the event the Agreement is terminated by Crain due to breach by Sponsor, Sponsor will pay any remaining portion of the sponsorship fee within 15 days. Crain will, however, diligently seek replacement sponsors for the sponsorship benefits and will refund to Sponsor the amount of sponsorship fees Crain actually receives from replacement sponsors fess Crain's costs to secure such replacement sponsors.

4. Copyright & Attribution

- 4.1 Sponsor's corporate logo which is a trademark of Sponsor is solely owned by Sponsor. Crain does not acquire any ownership interest in the corporate logo of the Sponsor. Crain agrees that Sponsor's corporate logo will not be altered in any manner except for changing the size in proportion to the size received and shall be used only in connection with the Conference and in accordance with the terms of this Agreement Crain's right to use Sponsor's corporate logo shall terminate upon termination of this Agreement, unless otherwise agreed to in writing by Sponsor.
- 4.2 Crain and Pensions & investments and WorldPensionSummit are each a trademark of Crain and Sponsor does not acquire any ownership interest in this trademark
- 4.3 Sponsor must have express written permission from Crain to use or distribute any copy, articles, transcripts, audio recordings or video footage from the Conference, Conference supplements or any live, video or web event or published report that occurs in conjunction with this Conference. However, Sponsor may link to Crain's published content on Crain's website for any of the above listed information or information related to a webcast on Sponsor's website or by including the link in an email.
- 4,4 If permission is granted to use any of the above listed information, Sponsor must include provided attribution and copyright line with each use, (This will be provided with written permission).
- 5. General
- 5.1 In the event that either party is unable to perform under this Agreement due to force majeure, or if Crain cancels or delays the Conference or is not able to provide all of the Sponsorship Benefits as scheduled due to business conditions that make it inadvisable to hold the event as scheduled, such party shall notify the other party in writing as soon as possible. Crain, as its sole obligation as to any such cancellation or delay, will have the option to provide Sponsor with the Sponsorship Benefits at a later time or in an alternative manner (such as, but riot limited to, through use of a virtual event, custom programs or webinars, etc.). If Crain is not able to provide the Full Sponsorship Benefits within six (6) months, Crain will provide Sponsor a pro rata credit (based on the value of the Sponsorship Benefits not received by Sponsor), which may be used by Sponsor for future events or advertising. At the request of Sponsor, Crain will provide a cash refund of the pro rata credit within 15 days.
- 5.2 Crain will comply with all applicable data protection laws in relation to the Conference and will take all commercially reasonable steps to ensure that the processing of any personal data relating to staff of Sponsor and the provision of any information relating to participants, attendees, or other data subjects to the Sponsor, in each case complies with such applicable laws.
