PREAMBLES TO THE SCHEDULE OF WORKS

GENERAL

- 1 Attention is here drawn to the Form of Tender and the Drawings; those documents are to be used in conjunction with the Schedule of Rates.
- 2 The preambles are applicable to the whole of the works included in this Schedule of Rates irrespective of the section in which the measured item appears.
- 3 The Contractor will be deemed to have allowed for all costs and charges in conforming to these preambles, whether or not a measured item appears separately. No additional costs for complying with these preambles will be accepted.
- 4 Headings and sub-headings are not necessarily repeated at the start of each new page which contains items to which they apply.
- 5 General directions and descriptions of work and materials given in the Specification are not necessarily repeated in the Schedule of Rates and reference is to be made to the Specification and the Drawings for this information.
- 6 Where British Standards are specified they shall be those current at the date of tender.
- 7 Where proprietary products are required they shall be deemed to be incorporated in the Works in accordance with the manufacturer's printed instructions unless specified to the contrary. Where proprietary articles are specified, other equivalents may be substituted providing written approval is obtained from the Engineer. The Contractor is to obtain the Engineer's approval to any alternatives prior to the submission of his tender and is also to confirm with his tender submission any alternatives upon which he has based his tender. Schedule descriptions shall be deemed to include this provision.
- 8 The Schedule of Rates describes the works only. Any quantities should be considered approximate within ±10% only and verified by the Tenderer as far as practicable. Any apparent inaccuracies should be notified to the Engineer. It is the Tenderer's responsibility to use the Schedule of Rates as a means of producing a firm price for the Works based on the drawings and Specification.
- 9 Where the terms "approved", "selected" or "directed" are used within the Schedule of Rates, they shall mean respectively approved, selected or directed by the Engineer. Approvals shall be obtained in writing.

- 10 Any items of completed work that are to be measured for payment purposes shall be measured with no allowance made for the bulking of materials, for cutting to waste, for working space (except where specifically measured) etc, which the Contractor shall allow for in his unit rates.
- 11 Any total quantities included in the final valuation for items will be measured to the nearest whole unit relevant to that item.
- 12 Prices or rates inserted in the Schedule of Rates are to include all costs and expenses which may be required in and for the construction of the work described and are to include for all obligations and liabilities imposed by the Contract Documents, whether or not such details are specifically set out in the Schedule of Rates.
- 13 The Clauses of the Conditions of Contract and relevant British Standards will be equally binding as if they had been fully repeated in the Schedule of Rates and the Contractor must make provision in his tender for carrying out all the provisions contained therein, whether the same are referred to in the Schedule of Rates or not.
- 14 Material billed by weight must be weighed over an approved weighbridge and the weight tickets tendered on delivery.
- 15 A price or rate is to be inserted against each item in the Schedule of Rates, whether quantities are stated or not, but no items are to be added (except where requested) nor are any alterations to be made unless requested specifically by the Employer. No item is to be left unpriced even if the rate is nil.
- 16 Payment of no more than 80% of amounts for materials on site in interim valuations will only be certified when title to the materials is held by the Contractor. Proof of title, e.g. receipt invoices, may be required before the Engineer can certify payment.
- 17 ADJUSTMENT ITEM: For the purposes of Clause 7 (Payment) of the Conditions of Contract, interim additions or deductions on account of the amount, if any, of the Adjustment Item shall be made by instalments in interim certificates, in the proportion that the amount referred to in Clause 7 bears to the total of the Schedule of Rates before the addition or deduction of the amount of the Adjustment Item. Such interim additions or deductions shall be made before deduction of the retention monies and shall not exceed in aggregate the amount of the Adjustment Item in the Tender.

- 18 DISPOSAL: Where disposal is stated in item descriptions it shall be deemed to mean disposal off the site to a suitably licenced facility. All rules containing disposal shall be deemed to mean disposal off the site.
- 19 CONTRACTOR DESIGNED WORK: All work (specified to be) designed and detailed by the Contractor shall comply in every particular with the Specification. The Contractor's rates will include for everything necessary to comply with the requirements of the Contract.
- 20 SCHEDULE OF WORKS: This shall be priced by the Tenderer on the basis of the works described by the drawings listed at the front of the Tender document and other such information that the Tenderer may derive from enquiries, site inspection, or determine from the experience of similar projects, in order to complete the Works in accordance with the Specification.
- 21 UNIT RATES: Where the Schedule of Rates requires an element of work to be quantified as an 'Item' tenderers may be required to provide a breakdown of assumed quantities and rates for each item for the purpose of valuing site measure.
- 22 The Contractor shall include in this Schedule of Rates for all costs associated with testing and sampling required by the Specification or the drawings.
- 23 METHOD RELATED CHARGES: The Contractor shall allow under Method Related Charges for all items not covered elsewhere in the Schedule of Rates but nevertheless necessary for the execution and completion of the Works, including but not limited to those items set out in Class A3 of the Civil Engineering Standard Method of Measurement (CESMM) or detailed hereafter.
- 24 In particular, the Contractor shall include as Method Related Charges for compliance with the special environmental/health and safety safeguards that apply to works at this site.
- 25 Any such items not described and priced separately shall be deemed to be covered by the rates and prices entered elsewhere in the Schedule of Rates.
- 26 Method Related Charges shall be certified and paid pursuant to Clause 7 (Payment) of the Conditions of Contract.

27 PROVISIONAL ITEMS: The rates for Provisional Items should be priced in such a way that the sole effect of undertaking or not undertaking any of these items is the inclusion or exclusion of the product of the rate and the measured quantity. All testing required for the satisfactory execution of these items shall be included in the rates. The Tenderer shall identify any programme implications of undertaking or of not undertaking works measured under Provisional Items.

DEMOLITION AND SITE CLEARANCE

- 28 General clearance has been measured as an item to include all demolition and site clearance necessary to do the work.
- 29 Rates should include for the disposal of material off site to a licenced tip unless stated otherwise.

EXCAVATION

- 30 Definition of rock: The term rock shall be deemed to include only solid, hard rock capable of being broken only by means of hammers or wedges or mechanical drills. Stratified hard material capable of being loosened in layers by means of a pick, auger, or mechanical face shovel may not be deemed rock e.g. slates, shales mudstones.
- 31 The rate for excavation in rock shall include for all overbreak and making up to correct levels with material to the approval of the Engineer. Rates are also to include for all side trimming, working space etc. and all allowances for overbreak and making up over excavation in a material instructed by the Engineer.
- 32 Hand excavation, if necessary, has not been separately defined. Should the Contractor decide that hand excavation will be necessary, he must make any allowance within his rates to cover all works associated with hand excavation.
- 33 The rates for excavation shall include for all works necessary to transport and deposit the material off site, and similarly, rates for filling shall allow for selection, loading and transport from the temporary stockpiles to the Permanent Works. Nevertheless, the Contractor may arrange his operations to enable excavated material for re-use to be placed immediately in the Permanent Works, providing there are no specific requirements to the contrary.
- 34 All rates for excavation shall include for protecting the bottom and sides of excavation from damage and making good backfilling and consolidating where required.

35 Scheduled excavation quantities and site measured quantities for valuations will not include working space, over excavation etc., e.g. excavation quantities for pipe work at a location would comprise the product of the nominal trench width and the depth.

IN SITU CONCRETE

36 Rates for concrete shall include for the material consumed in approving and monitoring the quality and the cost of undertaking and reporting tests.

CONCRETE ANCILLARIES

- 37 Rates for bar and fabric reinforcement shall include for supports to top reinforcement. Chairs and other supports shall not be subject to admeasure.
- 38 Grouting under plates shall include supply and installation of all necessary shuttering.

MISCELLANEOUS METALWORK

39 The rates for supplying and fixing miscellaneous metalwork shall include for taking on-site measurements, production of working drawings for approval and the re-submission if necessary, and for all and any materials including all fixings necessary to complete the installation in accordance with the specification and the manufacturer's instructions and recommendations. They shall include for drilling for or casting in fixings and fixing securely to the supporting concrete, steelwork or other member, and rectifying as specified any damage to a painted, coated, galvanised or zinc sprayed caused before or after erection.

The rates for "daywork" shall apply to work instructed by the Engineer to be carried out on a daywork basis at any time <u>up to the expiry of</u> <u>the Defects Correction Period</u> .		
After the date of the issue of the Certificate of Completion the Contractor may be allowed a proportion of his travelling time as determined by the Engineer.		
The Daywork schedule for this Contract is incorporated in the following clauses which enable the Contractor to quote rates and percentage variation for any work which may be ordered to be paid for on a daywork basis.		
Daywork Labour		
The Contractor is required to <u>price and extend</u> the following provisional hours of labour to be applied to any dayworks ordered. The rates shall be <u>fully inclusive</u> .
