and Zimbabwe

With reference to the contract dated 04<sup>th</sup> July 2018, as most recently amended by the letter dated 27<sup>th</sup> March 2020, both Parties have in principle agreed to the following variations to the Contract:

## Section 1, Form of Contract, Paragraph 2, Commencement Date and End Date of Initial Period

**Delete:** "The Services shall commence on 01sth July 2018 and the end date of the Initial Period shall be 31st March 2021."

**Insert:** "The Services shall commence on 01st July 2018 and the end date of the Initial Period shall be 30th June 2021."

## Section 1, Form of Contract, Paragraph 4, Financial Limit

**Delete:** "Payments under this Contract shall not, in any circumstances, exceed £24,500,000 exclusive of any government tax, if applicable.

**Insert:** "Payments under this Contract shall not, in any circumstances, exceed £37,892,822 exclusive of any government tax, if applicable.

## Section 5, Schedule of Prices

**Delete** the Section 5 Proformas in toto and **replace** with the Section 5 Schedule of Prices revised March 2021 attached.

- 2. These amendments relate to a 3 month extension of the contract to 30<sup>th</sup> June 2021 with an increased Financial Limit of £37,892,822, that includes £12,204,957 for the 12 month extension captured in Amendment 2 as well as an additional £1,187,865 increase for this 3 month extension, and a revised Schedule of Prices to reflect the actual costs to date and the proposed costs for the extension period.
- 3. Please confirm in writing by signing and returning one copy of this letter, within **15 working days** of the date of signature on behalf of FCDO that you accept the variations set out herein.
- 4. The Contract, including any previous variation, shall remain effective and unaltered except as amended by this letter.
- 5. Words and expressions in this letter shall have the meanings given to them in the Contract.
