Payments under this Contract shall not, in any circumstances, exceed £288,575.00 exclusive of any government tax, if applicable.



TERMS OF REFERENCE

1. Introduction

1.1 DFID Nigeria wishes to appoint ICF Consulting Serivices Ltd. (ICF) to finalise the outstanding research reports detailed in paragraph 4.

1.2 The submission of the final outputs of the research project will deliver research publications and policy briefings to DFID and other stakeholders. The research will cover the outputs agreed under the previous contract with ICF that ended on 20 August 2017: *Urbanisation and Infrastructure Research and Evaluation Manager Nigeria (UIREM)*. This contract ended before the submission of the final reports and DFID is therefore seeking to tender a new contract that will enable these outputs to be published.

2. Objective

2.1 DFID is seeking to appoint ICF to complete their role as Independent Research Manager until March 2018 to:

- Submit the final research reports and peer reviewed articles that can enhance understanding of urban development in Nigeria, influence policy as well as reports that speak to international research agendas on urbanisation. These outputs will address the agreed knowledge gaps on urbanisation in Nigeria.
- 2.2 The **expected outcomes** of this contract will be:
 - Rigorous research across key themes in urban development which generate new knowledge and evidence on urbanisation for Nigeria and for cities in Sub-Saharan Africa. This knowledge will inform future urban development policy and programming both in DFID and more widely.

3. Recipient

3.1 The recipient of this work will be DFID Nigeria, DFID Research and Evidence Division, the Government of Nigeria and other partners and the wider community of infrastructure and urbanisation development professionals.

4.2 Dissemination

Open Access ouputs

Research outputs must be made 'open access.' This covers the whole range of final outputs produced by the project, including research reports, policy briefings, peer-reviewed journal articles, and edited books. In addition, collected raw or derived datasets will be deposited in a suitable open access discipline or institutional repository within 12 months of the last data collection period in a data repository. Open access to research and data will benefit the full range of stakeholders and actors in the Nigerian urban sector, and may lead to an increase of impact, through increased access for the target audience; and increased visibility and usage of the research results.

End of project conference

The end-of-project conference is planned for November 2017 will provide a good entry point to support the formation of institutional networks, such as the recently established National Resilient Cities Network (NCRN) hosted at Ahmadu Bello University (ABU), and will offer the opportunity to discuss and share urban research, policy, planning and project and programme level experiences and information. The conference has been endorsed by the Minister of Works, Power and Housing, H.E. Babatunde Fashola, and is being planned with staff from the Ministry, notably Arch. Eucharia Alozie (Head of PPP) and O. A. Lana (Deputy Director the Department of Urban and Regional Development). Finally, Urban Research Nigeria researchers sit in advisory

positions on international scientific bodies providing further scope for academic and policy influence.

5. Contract Management Arrangements

- 5.1 The project lead in ICF is responsible to submitting the research outputs to the programme manager in DFID Nigeria by the dates specified.
- 5.2 The quality of the research reports will be signed-off by the Team Leader in the Evidence into Action team in DFID's Research and Evidence Division.

6. Contractual Arrangements

- 6.1 DFID will issue a contract for the full project duration.
- 6.2 DFID reserves the right to scale back or discontinue this project at any point (in line with our Terms and Conditions) if it is not achieving the results anticipated. Conversely, we may also scale up the project should it prove to be having a strong impact and has the potential to yield better results.
- 6.3 DFID will use an output based milestone payment plan for this contract, where payment will be explicitly linked to supplier performance and effective delivery of project outputs listed in paragraph 4.
- 6.4 The total value of the contract will not exceed £288,575.

7. Timing

This contract will commence in October 2017 and finish on 31 March 2018.

8. Personnel

The contract will be awarded to ICF in order to finalise the research reports and bring the programme to an end on time and within budget. ICF will demonstrate an appropriate mix of personnel and programme management skills to achieve this outcome. Within the technical and commercial criteria ICF will provide composition of the team, detailed timeline of activities and outputs to achieve programme closure by March 2018.

9. Payment Mechanism

The assignment will be managed by a result based payment system, to be monitored by the SRO. The quality of the final research reports will be signedoff by the Research and Evidence Division.

10. Duty of Care

- 10.1 The Service Provider is responsible for the safety and well-being of their personnel and Third Parties affected by their activities under this contract, including appropriate security arrangements. They will also be responsible for the provision of suitable security arrangements for their domestic and business property.
- 10.2 DFID will share available information with the Supplier on security status and developments in-country where appropriate. DFID will provide the following:
- 10.3 A copy of the DFID visitor notes (and a further copy each time these are updated), which the Supplier may use to brief their Personnel on arrival.
- 10.4 Updates on security developments to the in-country programme manager, which they may use to brief their Personnel.
- 10.5 All such Personnel must register with their respective Embassies to ensure that they are included in emergency procedures.
- 10.6 ICF are responsible for ensuring appropriate safety and security briefings for all of their personnel working under this contract and ensuring, where appropriate that their personnel register and receive briefing as outlined above. Travel advice is also available on the FCO website and ICF must ensure they (and their personnel) are up to date with the latest position.
- 10.7 ICF will be responsible for ensuring that appropriate arrangements, processes and procedures are in place for their personnel, taking into account the environment they will be working in and the level of risk involved in delivery of the Contract (such as working in dangerous, fragile and hostile environments etc.). ICF must ensure their personnel receive the required level of security training, relevant to their organisational arrangements.
- 10.8 ICF must confirm that:
 - They fully accept responsibility for Security and Duty of Care.
 - They understand the potential risks and have the knowledge and experience to develop an effective risk plan.
 - They have the capability to manage their Duty of Care responsibilities throughout the life of the contract.
- 10.9 Acceptance of responsibility must be supported with evidence of Duty of Care capability and DFID reserves the right to clarify any aspect of this evidence.
