<p>Background of Work Package:</p> <p>In January 2023, the Supplier was commissioned by the FSA to undertake a review of the Novel Foods Regulatory Framework. The output of this work was a final report, which identified a series of models, options and opportunities for potential reform, some of which related more broadly to the service and approvals process of Regulated Products. Following the conclusion of the review, Regulatory Reform and Innovation policy colleagues undertook an initial appraisal of the options presented in the final report.</p> <p>At the FSA Board meeting in June 2023, discussion between FSA Board members highlighted the potential for radical reform to the Regulated Products process with Board Members agreeing they would like to see examples of what this may look like.</p> <p>In response, Regulated Products Project Reform has been established by policy colleagues across the Regulatory Reform, Innovation and Engagement Unit. The objective of the project is to explore, scope and develop policy options in preparation for the presentation of a Board or 'green paper' to FSA Board in March 2024.
