With reference to the contractual letter dated 23 November 2011 (as most recently amended by the letter dated 28 May 2013) whereby your firm was engaged to carry out the Terms of Reference, I confirm that the UK Government wishes to make the following further amendments to the letter of 23 November 2011:

**Section 1 Form of Contract, Paragraph 3, Commencement and Duration of the Services**

**Delete:** 'and shall complete them by 31 December 2014 the (End Date)'.

**Insert:** 'and shall complete them by 31 March 2015 the (End Date)'.

**Section 1 Form of Contract, Paragraph 4, Financial Limit**

**Delete:** 'Payments under this Contract shall not, in any circumstances, exceed £3,161,113 exclusive of any government tax, if applicable (the "Financial Limit")'.

**Insert:** 'Payments under this Contract shall not, in any circumstances, exceed £4,110,663 exclusive of any government tax, if applicable (the "Financial Limit")'.

**Section 3, Terms of Reference**

**Delete** Section 3 Schedule of Prices in toto and **Replace** with Section 3, Terms of Reference (Revised October 2014) as attached.

**Section 5 Schedule of Prices**

**Delete** Section 5 Schedule of Prices in toto and **Replace** with Section 5, Schedule of Prices (Revised October 2014) as attached.

2. These amendments relate to a costed extension to the end of March 2015, with revised Terms of Reference and budget.

3. Please confirm in writing by signing and returning one copy of this letter, within **15 working days** of the date of signature on behalf of DFID that you accept the amendment[s] set out herein.

4. Please note the provision in the contractual letter that the financial limit of the UK Government's liability to the Supplier under this engagement shall not exceed the sum specified unless the amount of any such excess has been agreed by the Department for International Development in writing before the Supplier takes any action which might result in the financial limit being exceeded.
