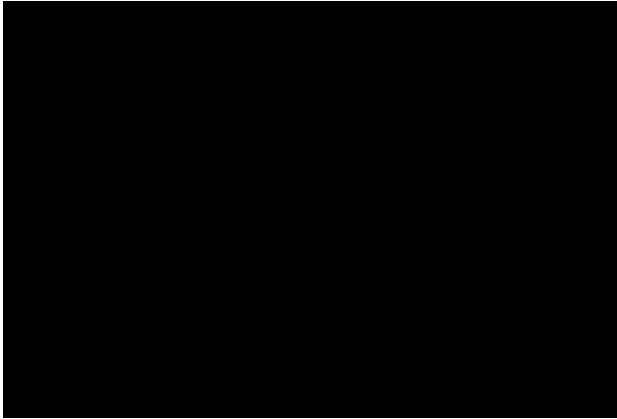

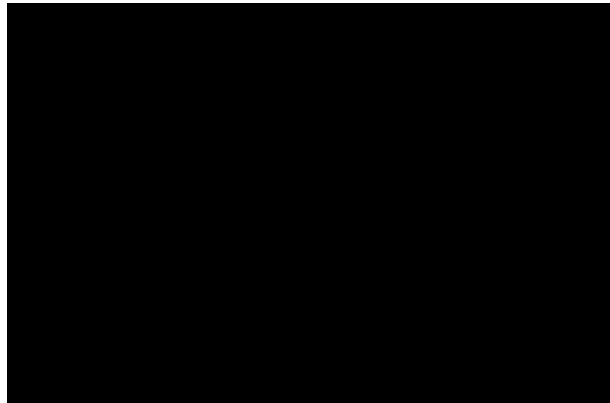
2. Save as herein amended all other terms of the Original Contract shall remain effective.
