ANNEX B – SPECIFICATION

The project requirement is to:

- Identify strengths and weaknesses in the Uzbek national IP regime by engaging with informed sources.
- DBT UZB and IP UZB will arrange for policy colleagues to be available for this consultation
- Draft a detailed analytical report which can be used to engage with Uzbekistan's Ministry of Justice to identify short-, medium- and long-term improvements.
- The analysis contained in the report should enable some prioritisation of resources and change management to maximise IP UZB's time
- Create a roadmap and a list of recommendations for the Uzbek Ministry of Justice to align Uzbekistan with global standards in IP (e.g. TRIPS and International Treaties), as well as on introducing best practice IP regime, improving Uzbek legal framework and strengthening IP enforcement
- Delivering the update in a considered but sensitive tone
- Engage with DBT colleagues at Post and have the experience and professional approach to assist Uzbekistan's Ministry of Justice in starting the journey to improvement.
- Working with the project team (DBT UZB / DBT UK and IPO) to ensure that updates on progress are made allowing IP UZB to be aware of progress
- The report would be designed to be shared with the Uzbek government, DBT, the IPO and with other government departments as required.
- The funding is capped at £15k in total, and bids which exceed this will not be considered. Any bid which attracts VAT must be within this figure.
- The project needs to be completed within three months.
