## Background

The Royal Navy (RN) and the Royal Air Force (RAF) recruitment are reviewing their enduring requirement for the provision of Pre-joining Fitness Tests (PJFT). The Authority has a requirement for Civilian Fitness Centres (CFCs) to conduct a standard PJFT for applicants wishing to join the Royal Navy, Royal Air Force and Royal Air Force Reserves. A new test focused on strength as well as fitness will be referred to as the Pre-Joining Fitness Test Plus (PJFT+) and will be used by the Royal Marines and Royal Navy Divers.

## The Event

A Market Interest Event to set out the scope of the requirement will be held virtually at 10:00 on 03 August 2022. The event is expected to last approximately 1 hour.

The event will involve a presentation from the Royal Navy and the Royal Air Force and the opportunity to book 1-to-1 sessions to inform options available to the Royal Navy/Royal Air Force.

The event will provide potential suppliers and sub-contractors with:

- Background and detail on the potential requirement.
- The opportunity to speak to the Project Team and other Royal Navy/Royal Air Force stakeholders.
- The opportunity to ask questions in a 1-to-1 forum.
- The opportunity to further inform Royal Navy/Royal Air Force thinking.

The team would welcome industry feedback on their proposed approach.

Suppliers should limit the number of attendees at the presentation to 5 per company and the maximum for the 1-to-1 is 3 attendees.

The potential requirement includes:

- Pre-Joining Fitness test Royal Navy
- Pre-Joining Fitness Test Royal Air Force / Royal Air Force Reserves
- Pre-Joining Fitness Test Plus Royal Marines and Royal Navy Divers

The following are the expected outcomes of the contracted-out services as envisioned at present:

- Provision of PJFT and PJFT+
- The provision and maintenance of the necessary equipment to enable the Fitness Tests to be undertaken within a Civilian Fitness Centre.
- The ability to deliver these tests to enable candidates to move on to joining the Royal Navy /Royal Air Force.
- The ability to support the Authority to moving the candidates into their next stage of their application.

Outputs from the Market Interest Event will be made available to all suppliers who registered an interest and/or attended and may be included as part of a prospective tender documentation pack. Therefore, no technical, financial, or commercially sensitive information should be included in information provided by any respective supplier at this stage.
