# Digital Label Converting Machine

#### 1 Background

KCS Print are a specialist print manufacturer with a wealth of experience. Experts in producing innovative integrated label products alongside more conventional print.

We are looking to purchase a digital label converting machine.

The commissioning of this work is part of a grant funded application process and therefore procurement will be subject to grant approval of the project as a whole. We will compare tenders received on a compliance basis only.

# 2 Project Specification

#### 2.1 Cantilevered Ø800mm Unwind Module

Pneumatically braked unwind module complete with programmable end of roll slow or stop, automatic tension control, Ø76mm air expanding unwind mandrel and localised HMI controls. Electronic web guide with ultrasonic edge guide sensor and adjustable splice table, interlocked web clamps and tape dispenser

#### 2.2 Servo Driven Semi Rotary Quick Change Re Register Flexographic Printing Station

Semi rotary flexographic print station complete with servo driven semi rotary shuttle suitable for flood coating, spot varnish and printing complete with light weight ink cartridge, Teflon coated high capacity ink pan for easy wash up, rubber pick up roller, ceramic anilox roller, reverse angle doctor blade and one 11" rubber covered coating roller (coating width of 325mm as standard). E2C low energy air cooled UV curing station 140w/cm. Servo driven full rotary infeed nip assembly with pneumatically pressurised nip roller to the flexo module. Re-register sensor and 1 plate cylinder. Additional flexo cartridge complete with anilox, ink tray, reverse angle doctor blade and pickup roller to be included.

# 2.3 Servo Driven Semi Rotary Die Cutting Station

Servo driven semi rotary die cutting station complete with magnetic cylinder suitable for semi-rotary die cutting only. Complete with automatic die pressure on/off, re-register servo drive, electronic longitudinal register control and manual lateral register control. Servo driven shuttle assembly for semi rotary web motion. Servo driven full rotary infeed nip assembly with pneumatically pressurised nip roller.

# 2.4 Servo Driven flat bed hot foiling station

Servo driven flat bed hot foiling station complete with electrically heated chase suitable for hot foiling or embossing; Complete foil feed system with 76mm foil unwind and rewind shafts; 450mm dia unwind and roll capacity, quick thread dancer, intelligent foil save system, re-register servo drive, electronic longitudinal register control and manual lateral register control. Servo driven shuttle assembly for intermittent web motion. Servo driven full rotary infeed nip assembly with pneumatically pressurised nip roller. Interchangeable with laminate system when not in use. With or without a rail system.

#### 2.5 Knives

- Scissor slitting module complete with lift out knife shafts & 5 sets of knives.
- Razor Slitting with set of 5 knives.
- Backscorer with 2 knives.

# 2.6 Die cut pressure adjustment

Gapmaster system for changing pressure on die cut with lubrication system for semi rotary and full rotary re-register die cutting, fixed - not moveable.

# 2.7 Servo Driven Waste Matrix Stripping

Servo driven waste matrix stripping assembly, with lay on roller, independently motor driven for precise tension control, maximum roll of  $\emptyset 800$ mm. Foot pedal for easy setup of the waste matrix stripping.

#### 2.8 Servo Controlled Rewind Module

Single spindle (upper position) product rewinder complete with Ø76mm air expanding rewind mandrel suitable for winding labels in/out with variable tension control, maximum roll of Ø600mm including label count sensor with batch and pause facility.

Lower position rewind with 76mm air shaft; suitable for 800mm dia. rolls; capable of winding labels in and out; including taper tension control as standard

#### 2.9 Web advance system

Brings material in line with cores to ensure reels are neatly wound to centre of cores.

#### 2.10 Controls

HMI PC touch screen machine controls mounted on sliding console and complete with all "optional" modular software for ease of machine upgrade. Including all label and length counting and machine controls. Remote access monitoring/support for electronics.
