



1. The information contained within the Transformation As-Built Model ("ABM") files were provided by the Lockheed Development Corporation (LLDC) and created by ATKINS. All ABM records provided by LLDC and used within the ABM are provided "as is" without any warranty, express or implied, by Lockheed Development Corporation or ATKINS.

2. The information contained within this model has been collated based on transformation as-built model files only. No as-built information from pre-transformation works has been included as part of this model but should be reviewed prior to any design/construct work.

3. Information provided for this model is indicative (for information only) and users should refer to the relevant as-built information (including Olympic Games model) prior to undertaking any design/construct work.

4. The location, depths, sizes, number and lengths of services/utilities should be verified on site by a competent contractor prior to undertaking any design/construct work.

5. The existing services have been identified by the Network Utility Register (NUR) and confirmed by the Users. Where confirmed by a competent contractor, the retention of services, the services have been shown as live. Services should be verified as abandoned by a competent contractor where required before any work is commenced.

6. The red-line boundary shows the extents of the transformation as-built model. It is likely that information shown outside of this boundary may contain anomalies or have missing information.

7. The Network Utility Register (NUR) within this model has been identified as abandoned by a competent contractor and should be confirmed by the Users prior to undertaking any design/construct work.

8. Chobham Manor is currently under construction and as such all services shown within this area are subject to change and have therefore been coloured grey. Contractor to update as-built utility information for this area when works have been completed.

9. A collection of Olympic Park As-Built CAD records and Ordnance Survey information has been used to generate background information. Where conflicts have arisen precedence has been given to the as-built records. ATKINS takes no responsibility for any inaccuracies that may be present within the background model.
