#### 1. Introduction

UKCEH operates four sites in the United Kingdom, the largest of which is based at Wallingford and is also the primary location, which houses the central financial function.

#### 2. Background

UKCEH became an independent company limited by guarantee on the 1<sup>st</sup> of December 2019 and has rolled over many of its services contracts, including cleaning and security services at all four of its sites.

As a majority public-sector funded organisation we are required to openly tender for requirements which exceed government thresholds, therefore this contract is being openly advertised.

As of January 2021 our Wallingford site has a cleaning contractor in place, however due to the change in ways of working caused by the coronavirus pandemic UKCEH does not currently have security provision.

#### 3. Scope of the Contract

The aim of this contract is to award, through an open tender in two-stages, to a contractor to provide either cleaning services (Lot A), security services (Lot B) or combined cleaning and security services (Lot C). Bidders should only bid for one Lot, e.g. where bidding for cleaning and security bidders must submit for Lot C and not two separate bids for Lots A and B.
