Surgery Location

The surgery is located within the South East Essex Clinical Commissioning Group. The local council is Southend on Sea Borough Council.

Southend is located in the south eastern peninsula of Essex and covers an area of approximately 16.12 square miles. The main populous areas are around the town centre and also along the coast, which includes Westcliff on Sea.

Background

St Luke's GP-led health centre was commissioned by South East Essex Primary Care Trust (PCT) in 2008 as part of the national improving access in primary care programme led by Lord Darzi. The current APMS contract has previously been extended and now expires on 31st March 2016. NHS England has decided to offer the contract out for re-tender, again via an APMS contract and the term will be for 10 years with the option to extend for two plus three years. NHS England is seeking to identify a provider who will deliver General Medical Services for patients of St Luke's Health Centre under an APMS contract only. It should be noted that the practice has received a CQC rating and has an overall rating of good.

Current Contract Position

- The current contractual arrangements will expire at the end of March 2016. It is expected that the new contract will commence on 1st April 2016.
- The incumbent provider currently leases the premises at Pantile Avenue from a private landlord. Patients currently receive primary care services from a modular building situated in the car park of Cumberlege Intermediate Care Centre (Pantile Avenue, Southend on Sea, Essex SS2 6RL) and planning permission is in place for this building until early Spring 2017. Alternative premises are being actively sought and Southend Borough Council, along with all other relevant stakeholders, is included in the Project Board which is working to prepare an Outline Business Case to identify new premises, supported by both NHS England and Southend CCG.
- The contract offered will be an Alternative Provider of Medical Services (APMS) agreement
- Contract offer will be for 10 years, with the possibility for extensions of up to a further five years should the commissioner require.
- The walk-in element of the current service provision is not being re-procured.
- APMS contracts will be subject to all relevant Regulations, Directions and Legislation
- Staff will be subject to TUPE arrangements

Population Growth in Southend
