of a roadside repair and recovery service to MOD owned and registered vehicles. A
full service must be available 24 hours a day, for 365 days of the year (366 in the event
of a Leap Year). The service must be available in the United Kingdom (includes
Scottish Islands, and Northern Ireland), Europe and extends to Morocco in North
Africa.

2. This Prior Information Notice (PIN) is intended to notify Industry of the Authority's request for suppliers to express interest in participating in a Request for Information (RFI) relating to the Authority Risk Register. This will allow the Authority to obtain feedback on the Risk Register. Should suppliers express interest in participating in this exercise, the Authority Risk Register and corresponding RFI will be issued to suppliers with a specific response period timeframe – please see Section 3 below for further details.

Background:

- 4. The Authority would like to notify the market of a potential upcoming requirement and hear from suppliers to assist with the development of a Risk Register by obtaining contributions from Industry.
- 5. This requirement is for the provision of a roadside repair and recovery service to MOD owned and registered vehicles, ranging from cars, motorcycles, light commercial vehicles and trailers through to heavy commercial vehicles. Armoured and tracked vehicles are also included up to a maximum gross weight of 44 tonnes (44,000kg).

The National Roadside Repair & Recovery contract does not require assistance to the following:

- · Leased vehicles,
- Spot Hired vehicles,
- Private Vehicles,
- No support to be provided in an Operational environment,
- No off-road recovery, except where a vehicle has left the public highway as the result of a road traffic collision,
- Whilst the Contractor must be competent in dealing with vehicles carrying sensitive loads (fuel, ammunition etc.), where the load must be removed before the vehicle can be recovered, the responsibility for the safety, security and onward movement of vehicle loads remains with the carrier (MOD Unit).

Single Statement of User Need:

6. The Single Statement of Need (SSON) for the project is:

"The Authority requires a 24 hour per day, 365 days per year, roadside repair and recovery service available in the United Kingdom, Europe, and North Africa for MOD owned and registered vehicles."

- 7. MOD will not be liable for any costs incurred by any parties who respond to this notice. The MOD has no obligation to continue with this requirement following this Early Market Engagement, and if potential suppliers choose to act on any answers and/or information they receive from the event, it is entirely at their own cost and risk.
