## 1. Purpose

Sellafield Ltd wishes to invite potential suppliers to a Pre-Procurement Supplier Engagement Event. Sellafield Ltd seeks to provide the market with the up-to-date information and obtain market feedback in relation to the procurement of the Manufactured Products Agile Spares (MPAS) opportunity.

Sellafield would like to invite interested suppliers to a face-to-face briefing on 18th June 2024 to:

1. Provide potential suppliers with an update on the MPAS scope, contract Terms and Conditions and Procurement approach;
2. Provide potential suppliers with the opportunity to discuss the procurement approach and process with Sellafield in one-to-one sessions; and
3. Test market appetite to bid for this opportunity; and
4. Create a networking opportunity for potential tier 2 and below suppliers to meet and discuss the MPAS procurement with potential tier 1 suppliers and vice versa.

The venue for the briefing will be confirmed upon registration, but it will be in the Cumbria region.

## 2. MPAS Procurement Overview

### 2.1 Requirement background

MPAS scope is a category approach for Manufactured Products which includes Manufactured & Fabricated products (M&F), Calciner Spares and may include other known requirements such as Flask Spares, Melters, Inductors and Stillages.

Some of the products to be procured through MPAS include M&F – the current agreement expires 30 April 2025 and Calciner Spares – the current agreement expires 17th November 2024 with the provision to extend those arrangements for up to 2 years.

MPAS will meet current manufacturing customer demand and allow sufficient flexibility to encompass scope within the Manufactured Products category that is currently unforeseen, consolidating procurements in a single consistent approach in a move towards a true category approach.

The objective of the MPAS opportunity is to provide a contract which will ensure continuity of supply, streamlining the current processes by removing non-value-add activities (mini-competitions across numerous suppliers).

The MPAS opportunity will be let to one main single supplier with manufacturing capability and capacity, creating flexibility and agility for Sellafield Ltd which can call upon its supply chain to fulfil the scope in its entirety.

At the end of the MPAS contract, it is intended that the products within MPAS will be procured through the Manufactured Products Partnership (MPP) Procurement (Atamis ref: C14741 & Contract finder: CF-0091900D4L000000iAvzUAE).

## 2.2 Scope

The scope of the MPAS opportunity includes the provision of design, manufacture, supply and maintain the following products:

- Manufactured and fabricated products - products/spares are required on an ongoing basis to support stock replenishment for Sellafield Ltd operating plants, this includes minor project related demand. Products are utilised site-wide and are critical for ongoing site operations; and
- Calciner Spares - these are vital to the operation of the High-Level Waste Plant (HLWP), a continuous requirement to operations any cessation of supply can stop operations.

Further to the above the scope of the MPAS opportunity includes:

- General machining and fabrication of products including high precision and complexity manufactured from all material grades such as carbon steel, stainless steel and exotic materials from engineering drawings up to Sellafield Quality Grade 01;
- UKCA Marking / CE Marking on behalf of Sellafield Ltd;
- Undertaking manufacturing trials, prototyping and a Design for Manufacture Studies capability to allow proof of concept; and
- An Emergency Supply Agile Service should there be an emergency breakdown on plant. This will include 24/7 level of support (by exception when required) and expediting of delivery in case of urgent Sellafield Ltd demands.

### **Additional Scope**

Provision is also made within MPAS, as a category approach, for the potential to include manufacture, supply and delivery of:

- Flask Spares – these are high complexity up to Quality Grade 01;
- Melters – are high precision and high complexity manufactured products up to Quality Grade 02;
- Inductors - Furnace inductors, and associated equipment up to Quality Grade 02; and
- Stillages & Stools - required for High Integrity Stainless Steel Containers (HISSC) up to Quality Grade 02.

## 3. How to apply

To register your interest for this event, please respond via Sellafield Ltd Atamis system with the names and positions of the delegates. Due to limited space the representatives from each supplier are limited to a maximum of three (3)

Registration deadline is 12.00 pm (noon UK Time) 07 June 2024

After the registration deadline Sellafield Supply Chain team will email all registered suppliers to invite them to book a one-to-one 20 min session with representatives from Sellafield Ltd Procurement and Technical teams. The purpose of the sessions is to allow Sellafield Ltd and the supply chain to ask clarification questions regarding the MPAS opportunity. The slots for the sessions are limited and they will be allocated on first come, first served basis.
