ORDER FORM

This Order is made by the Secretary of State for Environment, Food and Rural Affairs, acting as part of the Crown, pursuant to the terms of this Framework Agreement reference **LAB 1029 AP**, The Supply of Mass Spectrometry and Chromatography Equipment.

It is agreed as follows:

1. GOODS TO BE SUPPLIED

1.1 The Supply of one Liquid Chromatograph Triple Quadrupole Mass Spectrometer (“**LCQQQ**”) and associated equipment as set out in the quotation within Annex 1 to this Order Form, referred hereafter to as the “Equipment”.

2. SCOPE OF SERVICES

2.1 The Contractor shall supply, install and provide a 12-month warranty period from the date on which the Equipment is accepted. For the purpose of this Order, the date of acceptance of the Equipment shall be the date on which the Purchaser has finished acceptance testing post installation of the Equipment by the Contractor and confirmed that the Equipment is operating as intended.

2.3 The onsite contact to arrange delivery is [REDACTED].

2.4 At least five Working Days’ notice must be provided to the onsite contact prior to delivery and installation taking place. All deliveries shall be made within the Working Hours of 10am – 4pm Monday to Friday (excluding Public Holidays). Failure by the Contractor to provide the minimum notice for delivery, or attempting delivery outside of the hours stated above, will result in rejection of delivery, and re-delivery shall be at the expense of the Contractor.

2.5 The Contractor shall provide pallet numbers and the details of the consignment to the Purchaser’s onsite contact site prior to delivery i.e., the number of items that are palletised, including their dimensions, weight and the number of boxes within each pallet.

- 2.6 After installation, the Contractor must remove all packaging and recycle or reused packaging materials where possible.
- 2.7 The Contractor must deliver the Equipment to the Purchaser prior to 31 March 2025 as time is of the essence. The Equipment must be delivered prior to March 2025 due to how the Purchaser's capital budgets are allocated.
- 1.2 The price payable to the Contractor is inclusive of all shipping and delivery costs (see Annex 1). Upon fully delivery and acceptance of the Equipment, the sum payable to the Contractor shall be £ [REDACTED] + VAT.

Installation

- 2.8 Following delivery, the Contractor shall fully install and commission the Equipment within five Working Days of the delivery date.

Training

- 2.9 The Contractor shall provide Agilent classroom training for the Purchaser's relevant staff.
- 2.10 The Purchaser must book training with the Contractor by emailing [REDACTED]@[agilent.com](mailto: [REDACTED]@agilent.com) with the purchase order number and order confirmation number. Additionally, an introduction to the instrument shall be performed by the installing engineer, however no on-site training is included.

Safety Alerts

- 2.11 The Contractor shall ensure that the Purchaser is promptly and appropriately notified of any safety alerts, or other such similar communications, applicable to the Equipment, even after the expiry of this Contract.

Warranty

- 2.12 The Contractor shall provide a 12-month warranty period from acceptance of the Equipment. The Contractor shall promptly remedy any defects or issues identified during the 12-month warranty period at the Contractor's cost.

2.13 Out of Scope Goods/Services

The following two pieces of equipment are not covered by the framework agreement: (i) InfinityLab PFC-free HPLC Conversion Kit with product code 5004-0006; and (ii) MassHunter WS SW for LC/TQ with product code M5930AA. The Contractor shall however, supply these out-of-scope goods on identical terms to the Goods supplied under the terms of the framework agreement.

2.14 Key Personnel

2.15 Deliverables, Milestones and Acceptance Criteria

The Equipment must be delivered prior to 31 March 2025. In order for the Equipment to be accepted by the Purchaser, the Equipment must be fully functional and operating as intended.

2.16 Service Levels & Service Credits

The Contractor shall provide a 12-month warranty from the date on which the Equipment is accepted by the Purchaser.




