Note 2 - The number of months in Pricing Period 2 shall be reduced by the number of months the Services were available and provided in Pricing Period 1. This reduction shall be deducted from the latter months first. The following are examples for illustrative purposes:

- a) 12 months were carried out in Pricing Period 1 therefore 12 months of Contract Year 7 are removed and Contract Year 7 does not occur in Pricing Period 2
- b) 18 months were carried out in Pricing Period 1 therefore 12 months of Contract Year 7 are removed and 6 months of Contract Year 6 are removed. Therefore, Contract Year 7 does not occur in Pricing Period 2 and the final six months of Contract Year 6 does not occur in Pricing Period 2

Note 3 – Should Option Year 1 be demanded by the Authority exercising its right to extend the Contract under Clause 19 of the Contract, then the 12 months of duration that is added to the Contract shall occur directly following the last month of Pricing Period 2.

The number of months in Option Year 1 shall be reduced by a number equal to the number of months that the last Contract Year of Pricing Period 2 are fewer than 12 months. This reduction shall be made from the initial months of Option Year 1 first. Where such a reduction must be applied following the Authority exercises its right to extend the Contract under Clause 19 of the Contract, then the remaining months of Option Year 1 shall become the final months of final Contract Year in Pricing Period 2 and Variation of Price shall be applied in accordance with that applied to the final Contract Year in Pricing Period 2. The following are examples for illustrative purposes:

- a) The final Contract Year in Pricing Period 2 had 6 months. Therefore, Option Year 1 will have 6 months.
- b) The final Contract Year in Pricing Period 2 had 10 months. Therefore, Option Year 1 will have 2 months.
