NHS Supply Chain seeks to establish a non-exclusive framework agreement for supply to NHS supply chain depots via the Stock/Blue Diamond routes and to the NHS Supply Chain customer base via the E-DirectRoute. Details of the NHS Supply Chain routes to market can be found in Appendix 4b operational suppliers requirements.

The framework agreement is for the supply of needlefree connectors and connection systems/access devices and associated products intended to provide direct infusion of fluids or administration of medication to a patient. It is anticipated that in the first 24 months of the framework agreement the value of purchases will be circa 72 000 000 GBP. For the full 48 month term (if extended) the anticipated value is circa 144 000 000 GBP.
