

Invitation for Bids

Procurement of 3 Vehicles for delivery and use in Rwanda

Contract title: Supply and delivery of three project vehicles

1. Background

Mott MacDonald/ Cambridge Education has been awarded the FCDO funded Girls in Rwanda Learn (GIRL) programme, a 6-year programme (Nov 2024 - Jun 2030). GIRL is the FCDO's new bilateral education programme in Rwanda, building on components of the previous Learning for All (LFA) programme (2015-2023). The LFA programme worked to improve learning outcomes in English and Mathematics in all government and government-aided schools in Rwanda, with a special focus on girls and including children with special educational needs. GIRL has been designed to build upon this work by continuing to focus on foundational learning outcomes in English and Mathematics, with an even stronger focus on girls' education and inclusive education. It will work to reduce school drop-out and improve transition to lower secondary or other learning pathways, particularly for girls and children with disabilities.

Delivery of these services requires mobility of programme personnel throughout Rwanda, including remote areas accessible only by traversing unmade roads and other rough terrain. This requires vehicles with robust and reliable four-wheel drive vehicles suited to off road use.

Mott MacDonald/ Cambridge Education is procuring on request of Foreign, Commonwealth and Development Office (FCDO) the vehicles for the GIRL programme.

2. Objectives

The purpose of this Invitation for Tender (IFT) is to source one passenger city car, one passenger 4x4 vehicles and one four-wheel-drive double cabin vehicle. Delivery and handover of such vehicles will take place in Kigali, Rwanda.

3. Specifications

The technical assessment should review and outline the high level attributes i.e. the fit to the minimum specifications as drawn up for each vehicle. If more than one model meets the specifications the supplier can provide prices for more than one vehicle for each category. Additional criteria for the assessment will be service, security and service continuity.

4. Delivery and Guarantee/ warranties:

Guarantee/ warranties: minimal 100,000 km or 18 months whichever occurs first

Delivery and handover of the vehicles is expected to take place at the company's offices in Kigali, Rwanda within 45 days of the placing of an order with the selected supplier.

5. Eligibility

Eligible vendors must meet the following criteria, and their submission must be documented in this order;

- Profile (maximum of 1 page)
- Evidence of Company Registration/incorporation.

- Evidence of Tax Compliance for 2022/2023 Financial Year of the Revenue Authority of the country the supplier is registered.

- Postal address and verifiable contact telephone / cell phone numbers.
- Physical address of the vendor.
- Manufacturer authorisation: evidence that you are authorised to provide the vehicles
- Bids must be valid for 60 days from date of submission of the bids.
- Delivery in full to Mott Macdonald Limited Kigali Office, 45 days after acceptance of the contract.
- References indicating the Tenderer's experience and capacity to deliver similar products to reputable organisations (private companies, INGOs, Government).
- Proposed Terms and Conditions of Business.
- Any relevant accreditations or quality certificate(s) such as ISO standards, etc.
- Any other relevant information such as ethics policy, anti-slavery policy, etc.

- Tenderers may include in their Response a small amount of related and relevant information which has not been specifically requested in the RFP.

The bids will be evaluated from a value for money perspective looking at getting the right quality at a reasonable price.
