We are looking for quotations based on the three options outlined below.

Overarching Criteria

- The quote to clearly show breakdown between all the options and products listed therein
- At least 25 year Warranty
- Bidders must be certified installers.

Mandatory Inclusion

In addition to the scope of works and the three optional specifications set out below the replacement of skylight highlighted in blue above must be included in both option quotes.

All quotations should include 10% optional contingency.

Options

Option 1 – Full Strip Out

A new 3 layer RBM waterproofing system guaranteed for 25 years is to be installed. The roof will utilise a flat board insulation scheme of 130mm.

- Strip up the existing roof coverings back to the metal deck and discard
- Supply and fix new uPVC fascia, covering the new timber hard edges complete with all joiners, corners and sealants
- Supply and mechanically fix new GRP trim covering the new fascia complete with all joiners, corners and sealants and leave ready to receive new waterproofing
- Prime all new and existing surfaces with bitumen primer, leave ready to receive new 25yr IBG warm roof system
- Supply and fix new High performance RBM warm roof system incorporating 130mm PIR insulation. All details and fire risk zones will receive the flame free, self-adhesive system in accordance with the Safe 2 torch programme and NFRC guidelines. In accordance with the supplied specification
- Supply and install new code 5 lead SVPs and cover flashings in accordance with the HERA specification
- Building Control
- Disposal certification of waste
- Asbestos R&D Survey

Option 2 – Triflex or similar

Overlaying the existing substrate with Triflex ProTect / ProDetail.

- Cleaning the substrate and using only Triflex solvent Cleaner before applying the reinforced waterproofing system (Triflex ProTect / ProDetail)
- Overlaying the cleaned substrate with Triflex ProTect / ProDetail following manufacturer instructions.

<u>Option 3 -</u> any other suitable solution which would be environmentally friendly offering a 25-year warranty

- ✓ Proposed methodology and timeline for completing the project.
- ✓ Breakdown of costs, including materials, labour, and any additional expenses.
