Background

The parties entered into the Agreement for the supply of the following telecommunication services:

Services: 2 x MIA UPGRADE& RESIGN

The parties agree as follows:

1. Definitions

- 1.1. All defined terms in this amendment to the Agreement (the “Amendment”) shall have the same meanings as defined in the Agreement unless the context requires otherwise or otherwise expressly provided in this Amendment.
- 1.2. “Services” means the services supplied by Virgin Media Business to the Customer under the Agreement.

2. Applicability of terms and conditions of the Agreement

- 2.1. For the avoidance of doubt, all terms and conditions in the Agreement shall apply to this Amendment as if all of those terms and conditions were set out in this Amendment in full, in particular the subject to survey, feasibility, force majeure and payment provisions.
- 2.2. If there are any inconsistencies between the provisions of this Amendment and the provisions of the Agreement, the provisions of this Amendment shall take precedence to the extent of the inconsistency.

3. Additional terms and conditions

- 3.1. All Charges quoted exclude Value Added Tax or any similar tax.
- 3.2. Virgin Media Business shall in each case be entitled to charge a minimum of twelve (12) months of Rental in respect of any new or amended Service.
- 3.3. All new or amended Services will unless otherwise provided be co-terminous with the Services as detailed in the Agreement.
- 3.4. If the remainder of the Minimum Period as detailed in the Agreement is less than twelve (12) months from the relevant Service Commencement Date of the new or amended Service, the Customer agrees to pay not less than twelve (12) months Rental in respect of the new or amended Service.
- 3.5. Cancellation Charges may apply in accordance with the Agreement in respect of any Services which the Customer cancels or terminates during the Minimum Period.



