# **Task Assumptions and Dependencies**

This proposal is made on the following assumptions and dependencies. Acceptance of our proposal confirms that the Authority believes the below assumptions and dependencies to be fair and reasonable and that our proposal is constrained in the following ways;

- 1. This Task is dependent upon a number of key MOD personnel being available and providing input to the Task, the details of which will necessarily emerge and evolve throughout the period of performance of the Task.
- A range of MOD information and documentation (GFI) requirements have been identified as relevant to the Task. These GFI requirements as currently understood are detailed in the Authority's statement of requirement and as outlined at section 8 of the Task Lead Technical Proposal (reference CDSN02). Additional GFI requirements may be identified by the Task Lead during the performance of the Task, in which instance a formal written request will be submitted by CORDA to the Authority for consideration. It is acknowledged that the release of any additional GFI under the task will only be approved if:
  - 1. the Authority deem it releasable and relevant to the performance of the task;
  - 2. subject to (1) it can be provided within a mutually agreeable timescale; and
  - 3. the additional Authority approved GFI is added to the task by way of a formal contract amendment.
- 3. A range of assumptions and dependencies have been identified as relevant to this task by the Task Lead. These assumptions as currently understood are outlined within section 9 of the Technical Proposal (reference CDSN02).
- 4. This task will be subject to DEFCON 703
- 5. This task will be subject to DEFCONs 524 and 525. Acceptance for the purposes of DEFCONs 524 and 525 is deemed to have taken place 30 days after delivery to the Authority, in the event that no notification of an issue has been received from the Authority.
- 6. Dstl agrees that industry participation within this Task shall not preclude entry into any resultant competition.
- 7. The project is planned to start on 30/08/21. Delay in the contract award will cause an equivalent delay in delivery.
- 8. It is assumed that no export controlled technical data is required to be used within the Task.
- 9. It is assumed for the purposes of DEFCON 632 that the Authority has the necessary rights to pass on any third party intellectual property, as GFI, to the contractor and that the Authority will indemnify the contractor (and its subcontractors) in accordance with DEFCON 632.

- 10. It is MoD's responsibility to conduct the appropriate V&V on both the CTD Model and it's outputs; and to verify the results independently prior to making any decision informed by the outputs or the model. Any losses, as far as permitted by law, arising from using the model, without completing this appropriate V&V, shall be excluded.
- 11. The authority accepts that any resultant outputs of the task and the 'CTD Model' will only be as comprehensive and reliable as the assumptions and underlying data (provided by the MoD as GFX) that the Task Lead has access to and that the outputs are constrained by this fact.
- 12. It is MoD's responsibility to validate and verify any recommendations or mitigations suggested within the task, before changes to the supply chain strategy, policy or contracts are made. BAE Systems holds no liability, as far as permissible by law, for the accuracy of the outputs and deliverables of this task.
- 13. With reference to enclosure 5, it is agreed that the Authority shall limit the contractor's liability, with regards to this risks outlined within enclosure 5. Nothing in this contract excludes or limits the liability of the supplier for death or personal injury, caused by negligence; or of the supplier for fraud.

# **Task Management Services Assumptions & Dependencies**

- 1. BAE Systems CORDA reserves the right to revalidate our proposal and price in the event that more than 1 set of clarification questions are requested or our proposal is required to be amended more than 1 time prior to contract award.
- 2. It is assumed that the task will last no longer than 3 months, with 3 milestones and 3 monthly reports, with the task ending on 30<sup>th</sup> November 2021 should it be contracted by 30<sup>th</sup> August 2021.
- 3. It is assumed that there is no requirement for a deliverable quality plan, for this task.
