



## **PART E: ADJUSTMENTS**

### **1. Changes to the Charges**

The Charges will not be impacted by any change to the Framework Prices.

### **2. Indexation**


- a. Any amounts or sums in this Call-Off Contract which are expressed to be “subject to Indexation” shall be adjusted in accordance with the provisions of this paragraph 2 to reflect the effects of inflation.
- b. Where Indexation applies, the relevant adjustment shall be:
  - i. applied on the first day of the second April following the Call-Off Start Date and on the first day of April in each subsequent year (each such date an “adjustment date”); and
  - ii. determined by multiplying the relevant amount or sum by the percentage increase or changes in the Consumer Price Index published for the 12 months ended on the 31 January immediately preceding the relevant adjustment date.
- c. Except as set out in this paragraph 2, neither the Charges nor any other costs, expenses, fees or charges shall be adjusted to take account of any inflation, change to exchange rate, change to interest rate or any other factor or element which might otherwise increase the cost to the Supplier or Sub-contractors of the performance of their obligations.
